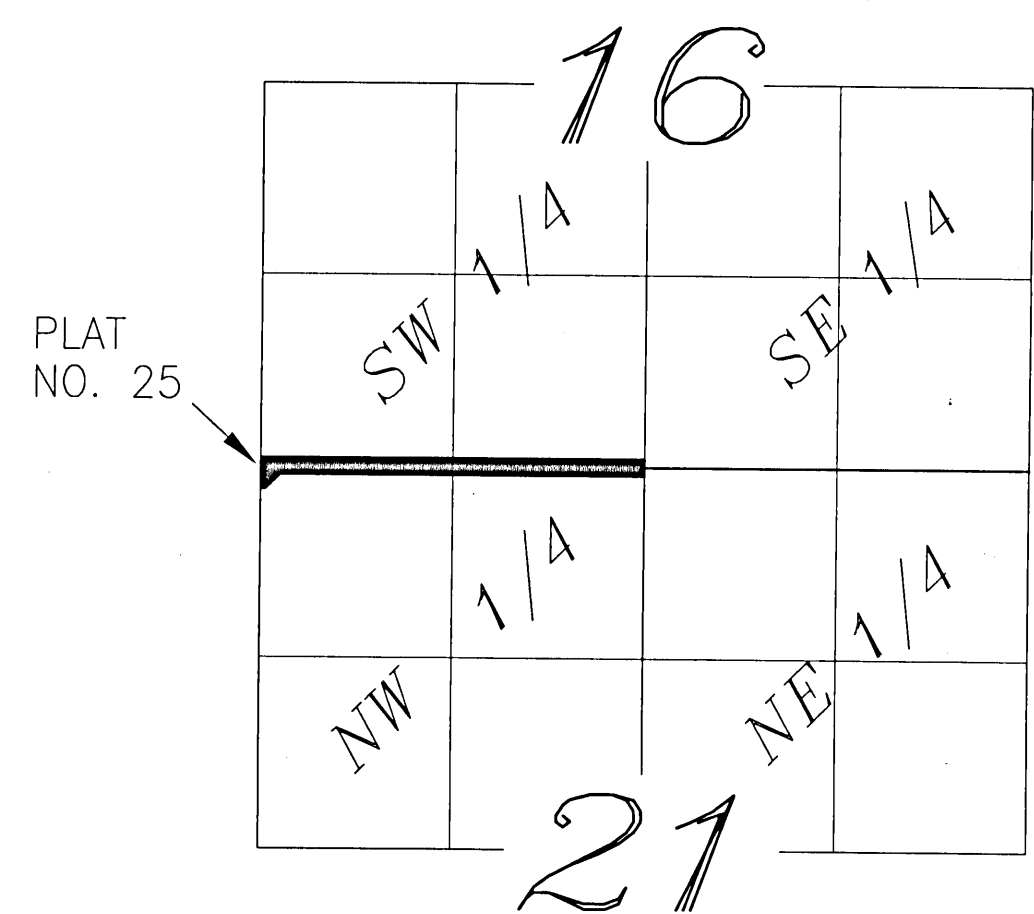

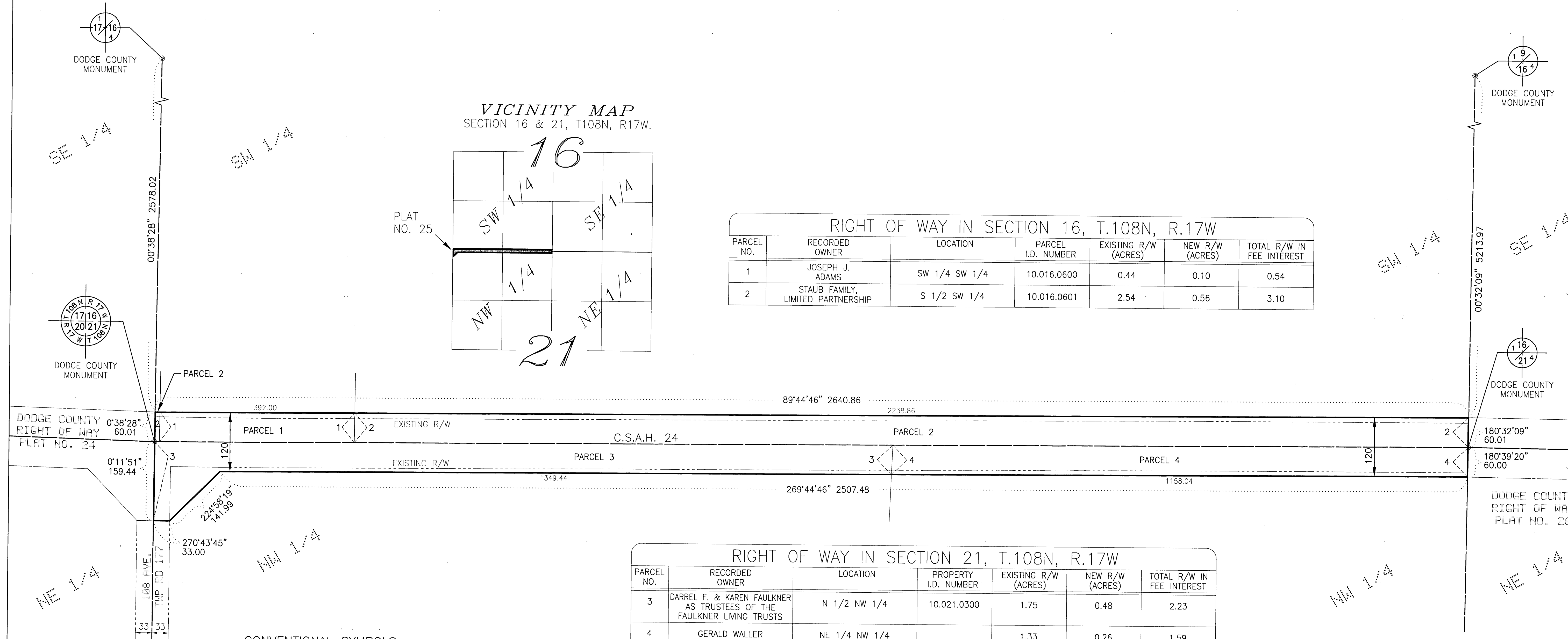
DODGE COUNTY STATE AID HIGHWAY NO. 24

SECTION 16 & 21, T.108N, R.17W.

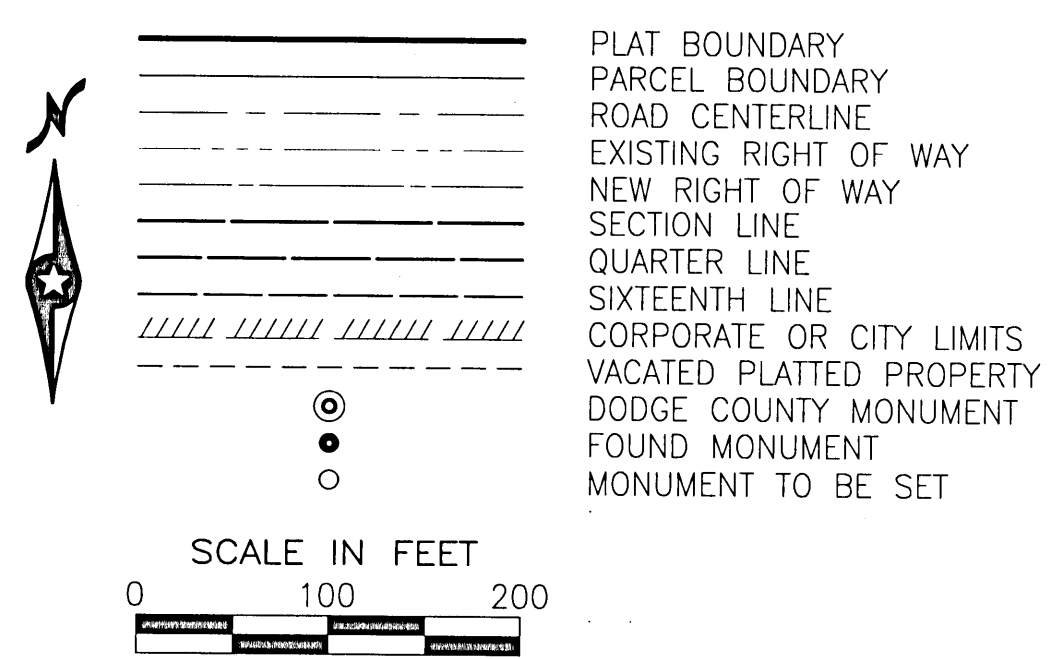
