thence South 89°42'15" East a distance of 1659.69 feet, on the south line of said NE14, to the southeast corner thereof;

thence South 89°54'25" East a distance of 506 feet more or less, on the south line of the SW1/4 NW1/4 of said Section 33, to a point on the centerline of the Cedar River;

thence Northwesterly, Westerly and Northeasterly a distance of 1820 feet more or less, on the centerline of said Cedar River, to the point of intersection with a southeasterly extension of the southerly line of said Lot 6, Block 1, Whitetail Estates, said line having a bearing of South 50°57'51" East;
