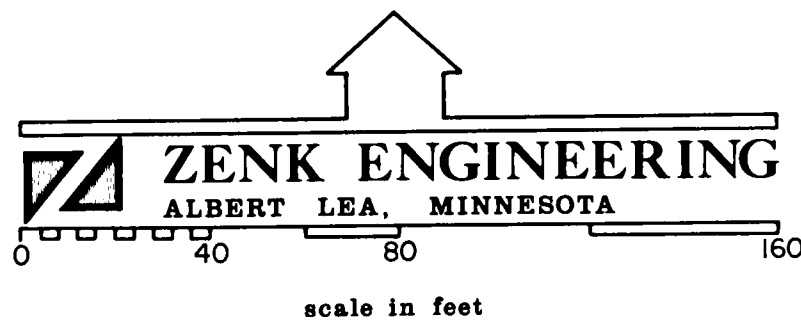
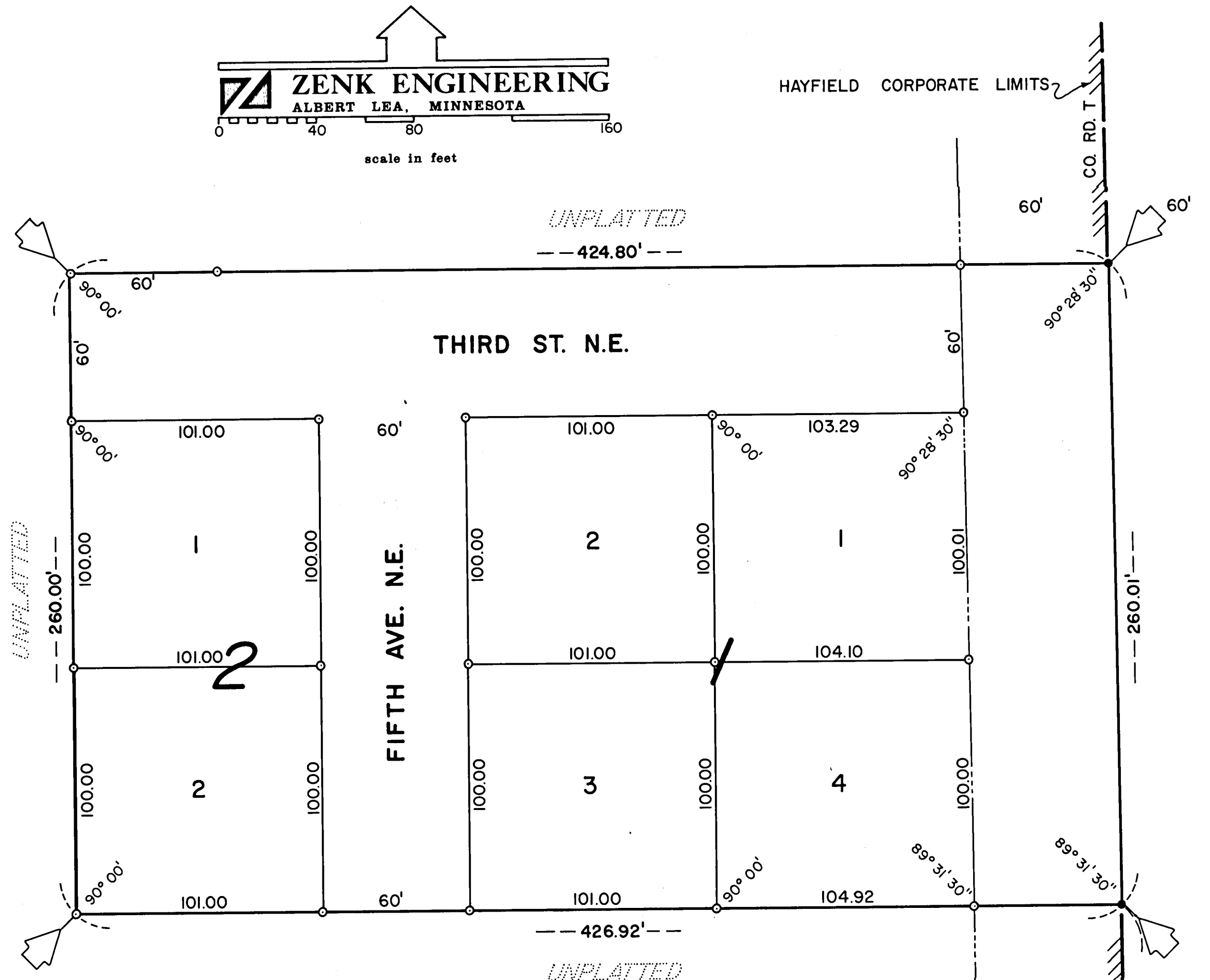

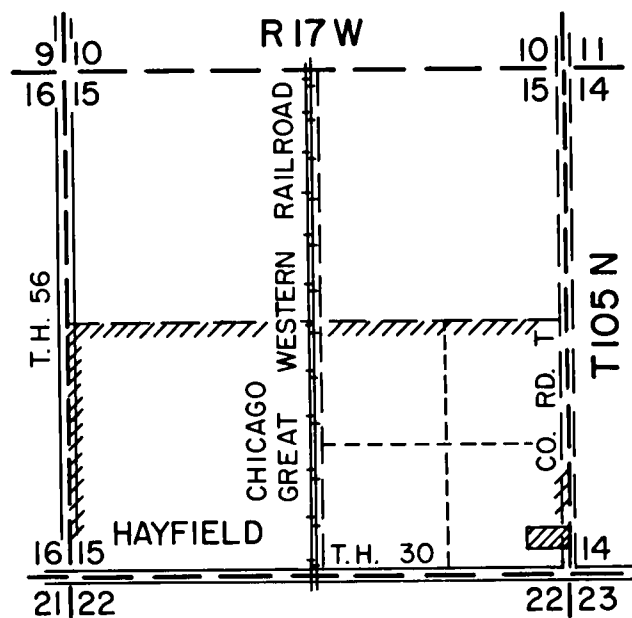
HAYFIELD CORPORATE LIMITS



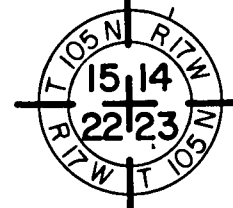
