

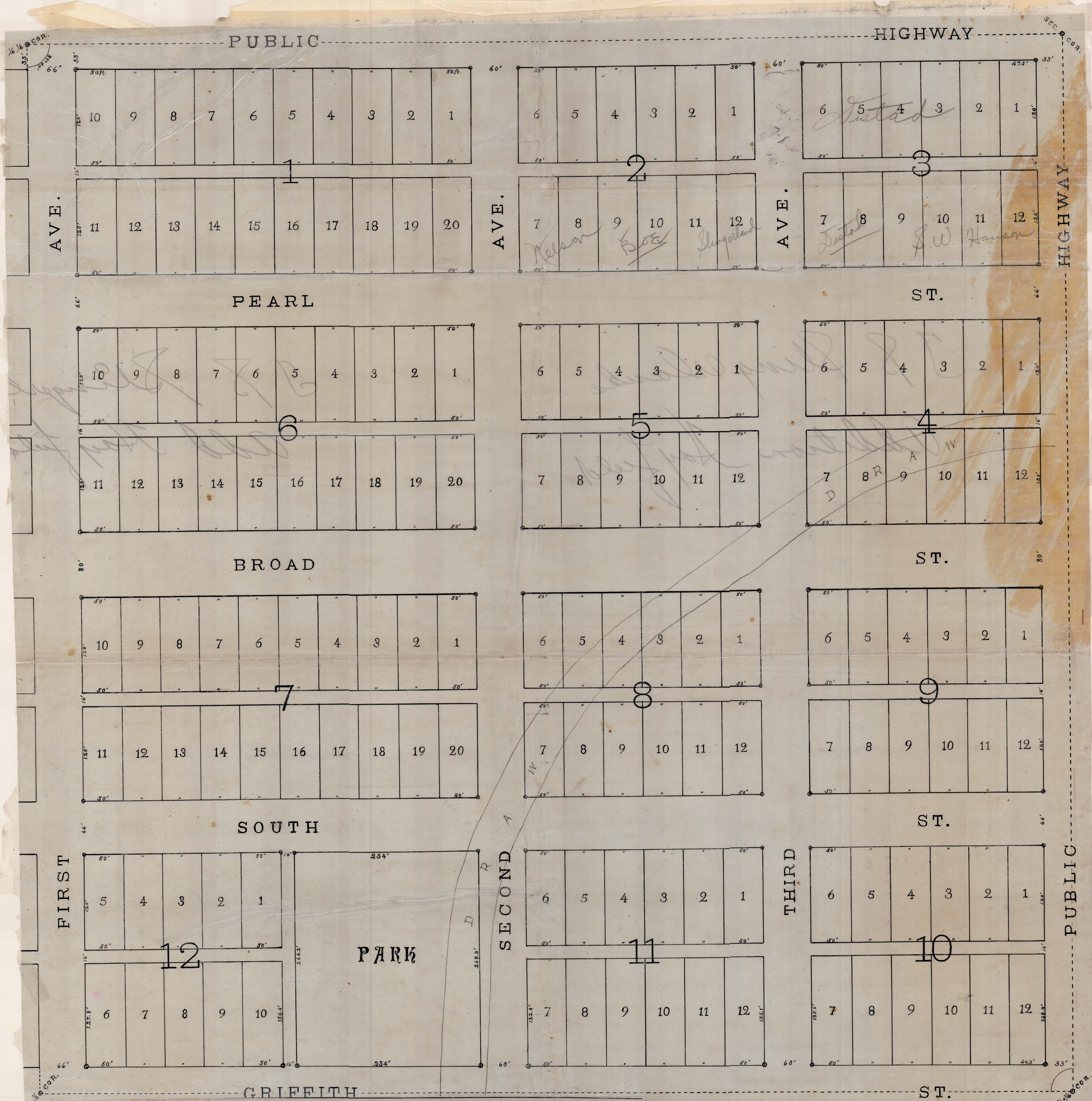
T. S. SLINGERLAND'S Addition To HAYFIELD.

I, M.N. Clausen, surveyor and civil engineer residing in the City of Austin in said County, do hereby certify that, at the request of George A. Norton and Elbert L. Slingsland executors of the last will and testament of Reuben S. Slingsland, deceased, I made the survey and prepared the plat of the land in the North-east Quarter of Section Twenty-two, in Town-ship One Hundred Five North, of Range Seventeen West in Dodge County, which land is now known as "R.S. Slingsland's Addition to Hayfield, and which plat is hereto attached.

I further certify that said plat is a correct representation of the said survey; that all distances are correctly shown on said plat and that the monuments for guidance for future surveys have been correctly placed in the ground as shown thereon; that the outside boundary lines are correctly designated, and that the topography of the said land is correctly shown on said plat; that there are no wet lands and no public highways within or across said land existing before the making of said plat, which are not correctly located and plainly shown and designated thereon.

I further certify that all of the blocks in said plat are numbered progressively; that all lots are numbered progressively in the block in which they are situated; that all dimensions of all lots and blocks are correctly shown, and designated upon said plat in feet and decimal parts thereof and that said survey was made and the said plat drawn and prepared in full compliance with the provisions of the Statutes and the laws of the State of Minnesota in such cases made and provided.
