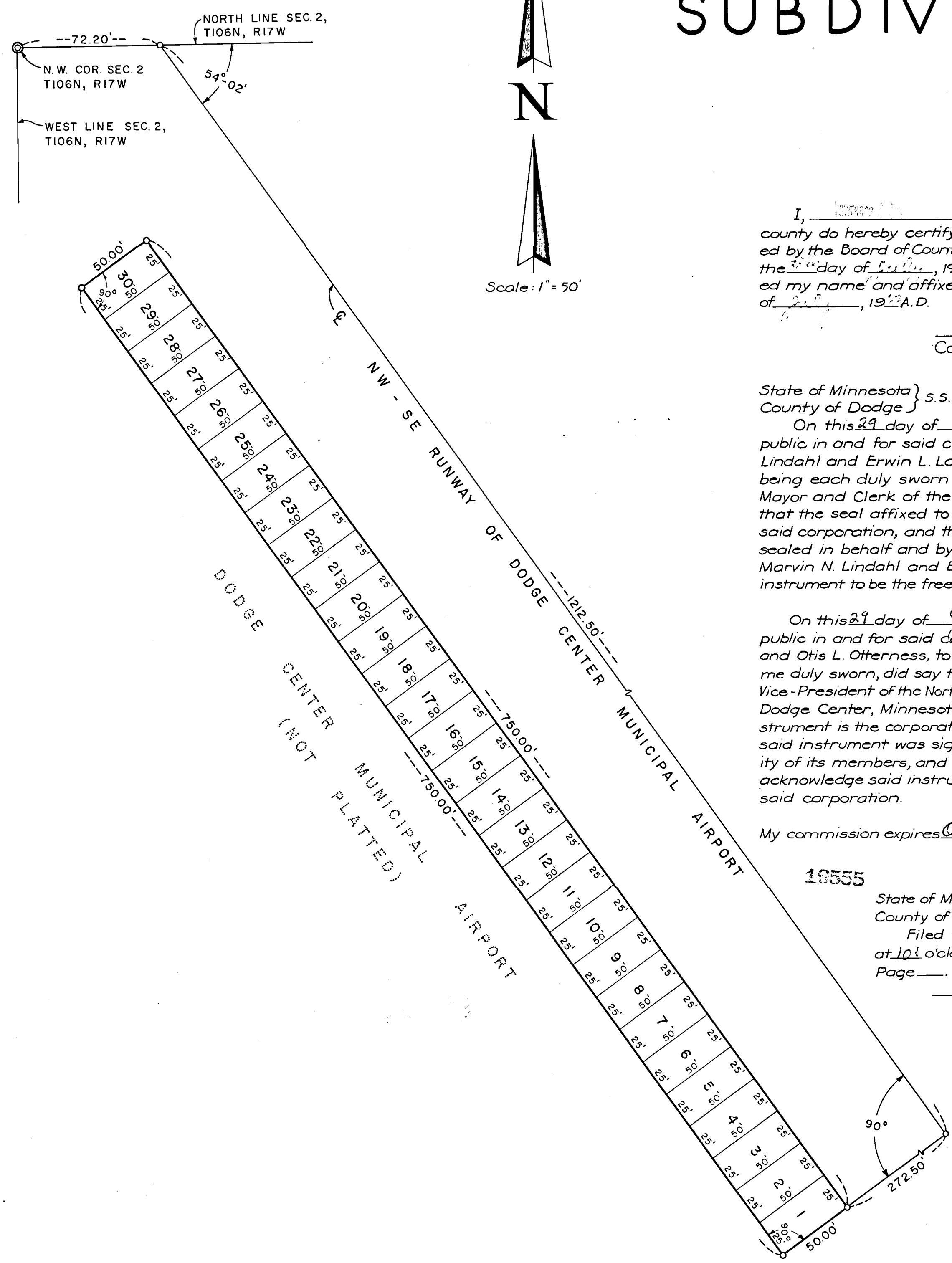


DODGE CENTER MUNICIPAL AIRPORT

SURVEYOR'S CERTIFICATE

 I, Leonard M. Sankstone, Registered Civil Engineer and Land Surveyor, State of Minnesota, do hereby certify that at the request of the Village of Dodge Center, a municipal corporation, Dodge County, Minnesota, owners and proprietors, and the Northwestern State Bank of Dodge Center, a Minnesota corporation, mortgagors, of the real estate in the County of Dodge, State of Minnesota, I have surveyed, staked and platted said real estate into lots as shown by the plat on which this certificate is written, and which shall be known and dedicated as **DODGE CENTER MUNICIPAL AIRPORT, SUBDIVISION NO. 1**, as herein after described to wit:

Commencing at the northwest corner of Section 2, Township 106 North, Range 17 West, thence easterly along the north line of said Section 2 a distance of 72.20 feet to a point on the centerline produced of the Northwest-Southeast Runway of the Dodge Center Municipal Airport, thence southeasterly along said centerline a distance of 1212.50 feet, thence 90° right a distance of 272.50 feet to the point of beginning of the land to be described, thence 90° right a distance of 750.00 feet, thence 90° left a distance of 50.00 feet, thence 90° left a distance of 750.00 feet, thence 90° left a distance of 50.00 feet to the point of beginning.

I further certify that the plat is a correct representation of such survey as made, that all distances are correctly shown on the plan as designated in feet and decimals of a foot, that the outside boundaries are designated on the plat and that there are no wet lands thereon, and that said land has not heretofore been platted, and that monuments for the guidance of future surveys have been placed in the ground at the places designated thus (o).
