

INSTRUMENT OF DEDICATION

That part of the Southwest Quarter of the Southwest Quarter of Section 28, Township 107 North, Range 16 West, Dodge County, Minnesota, described as follows:

Beginning at the southwest corner of said Southwest Quarter; thence northerly on a Minnesota State Plane Grid azimuth from north of 359 degrees 11 minutes 20 seconds along the west line of said Southwest Quarter-Quarter 330.00 feet; thence easterly 89 degrees 19 minutes 29 seconds azimuth 850.48 feet; thence southerly 179 degrees 19 minutes 29 seconds azimuth 165.00 feet; thence easterly 89 degrees 19 minutes 29 seconds azimuth 468.63 feet to the east line of said Southwest Quarter-Quarter; thence southerly 179 degrees 10 minutes 53 seconds azimuth along said east line 165.00 feet to the south line of said Southwest Quarter-Quarter; thence westerly 269 degrees 19 minutes 29 seconds azimuth along said south line 1168.74 feet; thence northerly 359 degrees 11 minutes 20 seconds azimuth 108.00 feet; thence westerly 269 degrees 19 minutes 29 seconds azimuth 108.00 feet to the south line of said Southwest Quarter-Quarter; thence westerly 269 degrees 19 minutes 20 seconds azimuth 108.00 feet to the south line of said Southwest Quarter-Quarter; thence westerly 269 degrees 19 minutes 29 seconds azimuth along said south line 50.00 feet to the point of beginning.

Said tract contains 7.97 acres more or less.

Have caused the same to be surveyed and platted as MARTI'S FIRST SUBDIVISION and do hereby donate and dedicate to the public for public use forever the thoroughfares and grant the easements as shown on this plat.
