

INSTRUMENT OF DEDICATION

KNOW ALL MEN BY THESE PRESENTS THAT: Franklin D. Mathias, a single person, owner and proprietor of the following described property situated in the City of West Concord, County of Dodge, State of Minnesota, to wit:

That part of the West Half of the Northeast Quarter of Section 19, Township 108 North, Range 17 West, Dodge County, Minnesota, described as follows:

Commencing at the northwest corner of said Northeast Quarter; thence southerly on an assumed azimuth from north of 180 degrees 24 minutes 55 seconds along the west line of said Northeast Quarter 1249.52 feet to the southwest corner of H. Wescott's Addition to the Village of West Concord, Dodge County, Minnesota, H. Wescott's Addition to the Village of West Concord, Dodge County, Minnesota, as monumented and occupied; thence easterly 90 degrees 39 minutes 52 seconds azimuth along the southerly line of said H. Wescotts Addition 571.18 feet to the southwest corner of Flicek's First Addition, Dodge County, Minnesota, as monumented and occupied, and the point of beginning; thence easterly 90 degrees 39 minutes 52 seconds azimuth along the south line of Flicek's First Addition and H. Wescott's Addition and projection thereof 633.06 feet to a point on said line which lies 120.00 feet westerly of the east line of said West Half; thence southerly 180 degrees 29 minutes 16 seconds azimuth parallel with said east line 34.94 feet; thence westerly 270 degrees 21 minutes 43 seconds azimuth 33.00 feet; thence southerly 180 degrees 29 minutes 16 seconds azimuth parallel with said east line 131.95 feet; thence westerly 271 degrees 17 minutes 36 seconds azimuth 89.51 feet; thence southerly 180 degrees 29 minutes 16 seconds azimuth parallel with said east line 166.32 feet; thence westerly 270 degrees 14 minutes 52 seconds azimuth 574.40 feet; thence northerly 00 degrees 24 minutes 55 seconds seconds azimuth 574.40 feet; thence northerly 00 degrees 24 minutes 55 seconds azimuth 160.00 feet; thence northeasterly 20 degrees 26 minutes 31 seconds azimuth 187.64 feet to the point of beginning.

Said tract contains 4.65 acres more or less.
