

CONDOMINIUM NUMBER 14 ARMORY CENTER CONDOMINIUMS

The undersigned, being first duly sworn under oath, certifies and deposes that these Floor Plans of CONDOMINIUM NO. 14, ARMORY CENTER CONDOMINIUMS, being located upon:

All that part of Lots One (1) and Two (2) and of the Alley in Block Thirty Nine (39) of the City of Red Wing, according to the recorded plats thereof, bounded and described as follows, to-wit:

Beginning at a point on the Easterly line of Plum Street Two (2) feet Northerly from the North Westerly corner of Lot One (1) of Block Thirty Nine (39) in the City of Red Wing; running thence Southerly and along said line of said Street Sixty Seven and two-thirds (67 & 2/3) feet; thence Easterly and parallel with the Northerly lines of Lots One (1) and Two (2) in said Block to the Easterly line of said Lot Two (2); thence Northerly and along said easterly line of said Lot Two (2) Sixty Seven and two-thirds (67 & 2/3) feet to a point Two (2) feet Northerly from the North Easterly corner of said Lots Two (2); thence Westerly parallel with and two (2) feet Northerly of the Northerly lines of said Lots One (1) and Two (2) to the point of beginning.

Also, the Southerly seventy-six Feet Four Inches (76'4") of Lot One (1) and the Southerly Seventy-six Feet Four Inches (76'4") of the Westerly Two-Thirds (2/3) of Lot Two (2), Block Thirty-nine (39), City of Red Wing, according to the plat thereof on file and of record in the Office of the Register of Deeds for the County of Goodhue, State of Minnesota.







Denotes existing wall as the unit vertical plane boundary --- Denotes unit vertical plane boundary




SECOND LEVEL FLOOR PLAN
