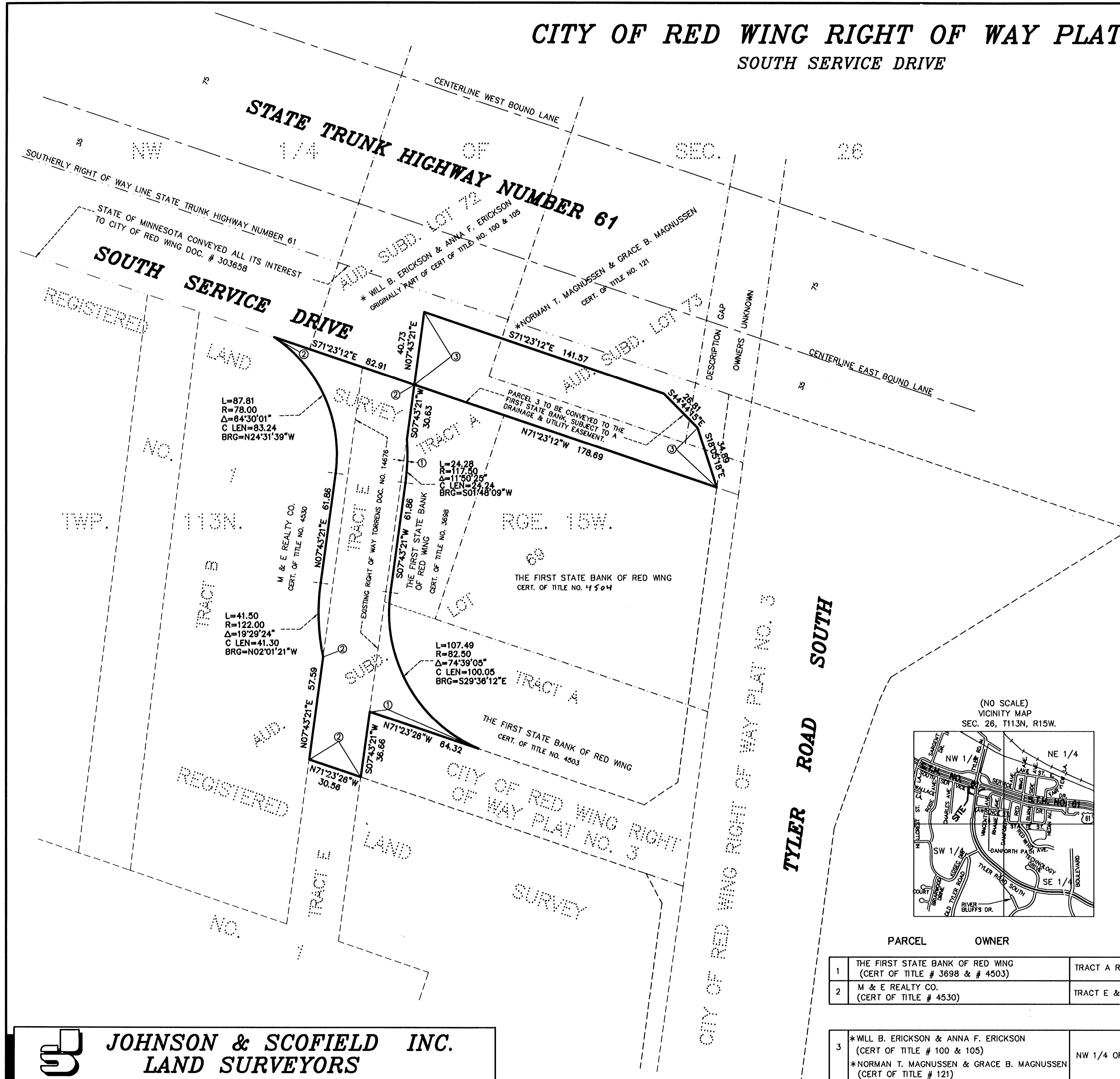


CITY OF RED WING RIGHT OF WAY PLAT NO. 5

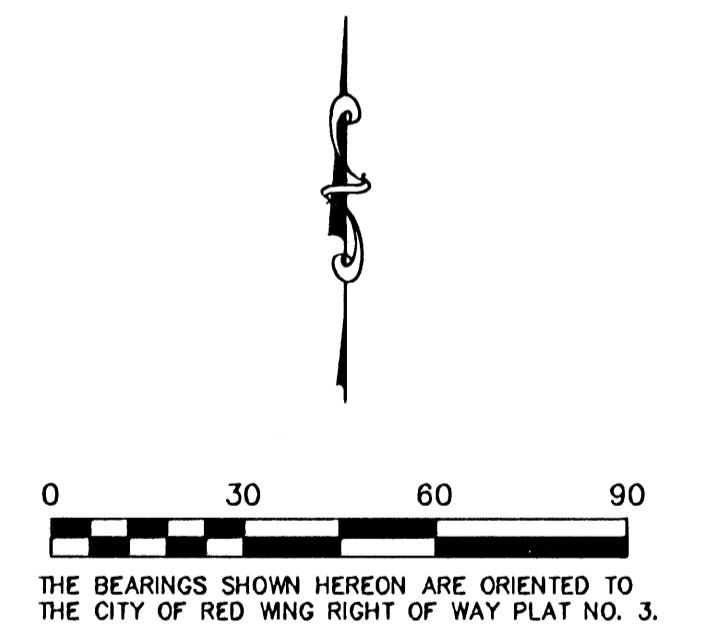
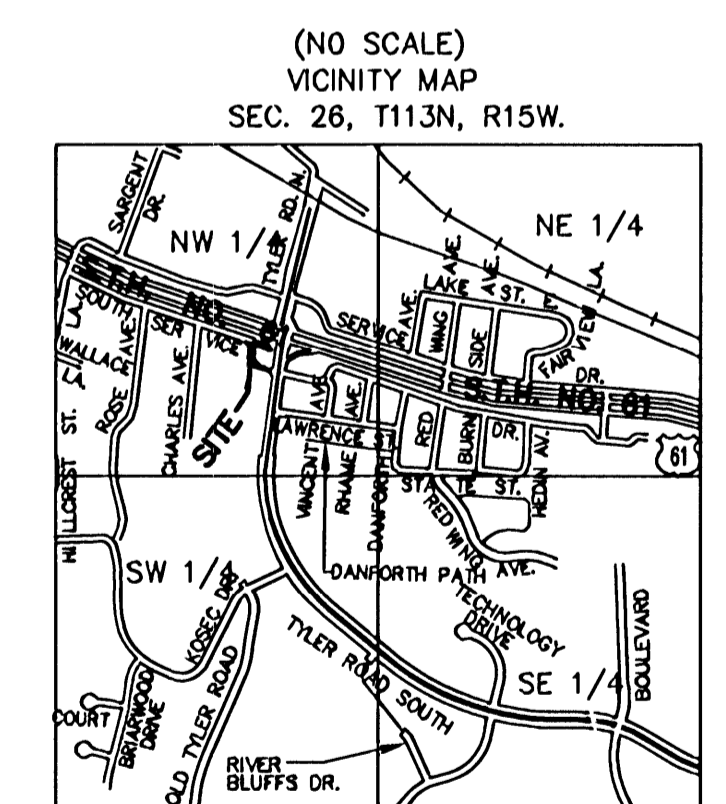
