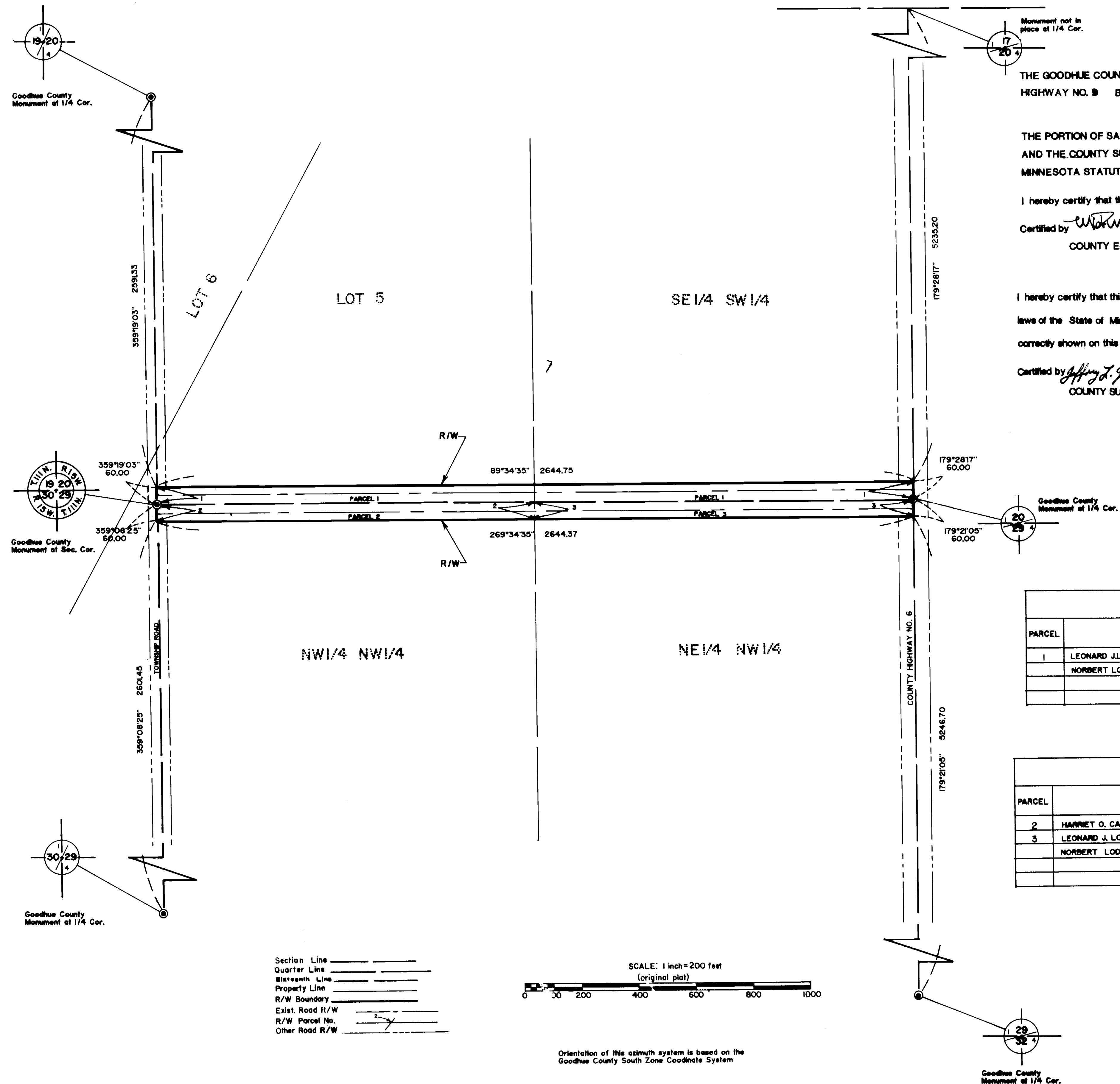


GOODHUE COUNTY HIGHWAY RIGHT OF WAY PLAT NO. 15

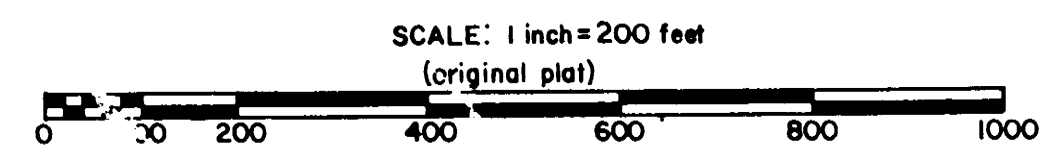
