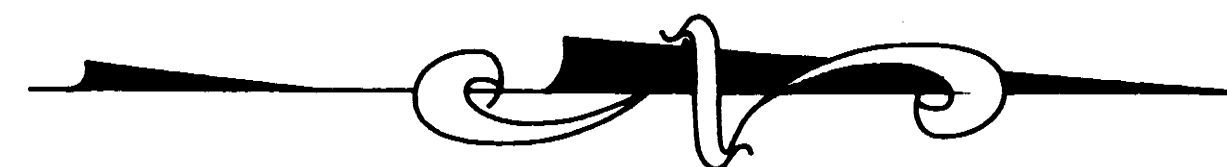
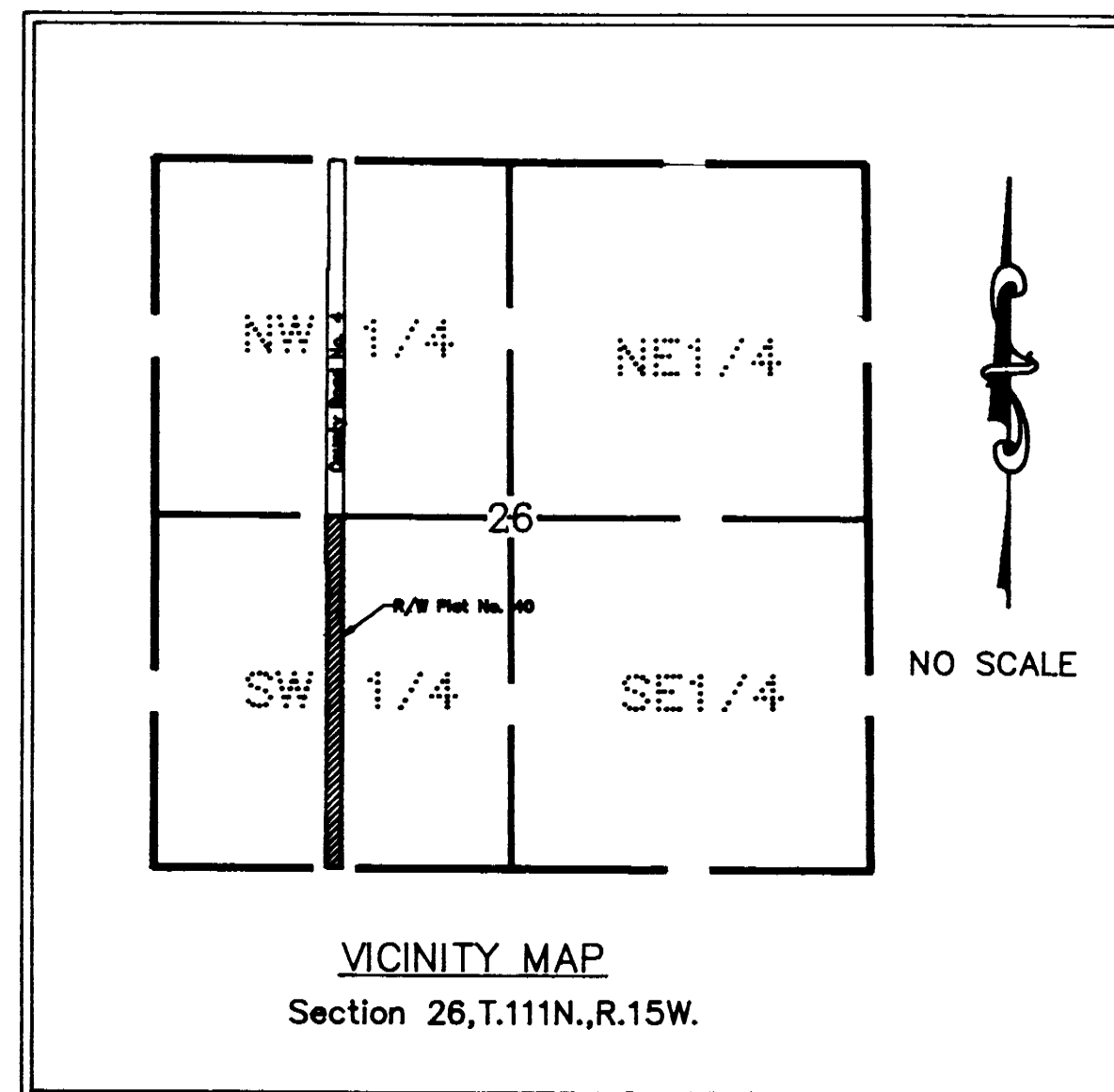
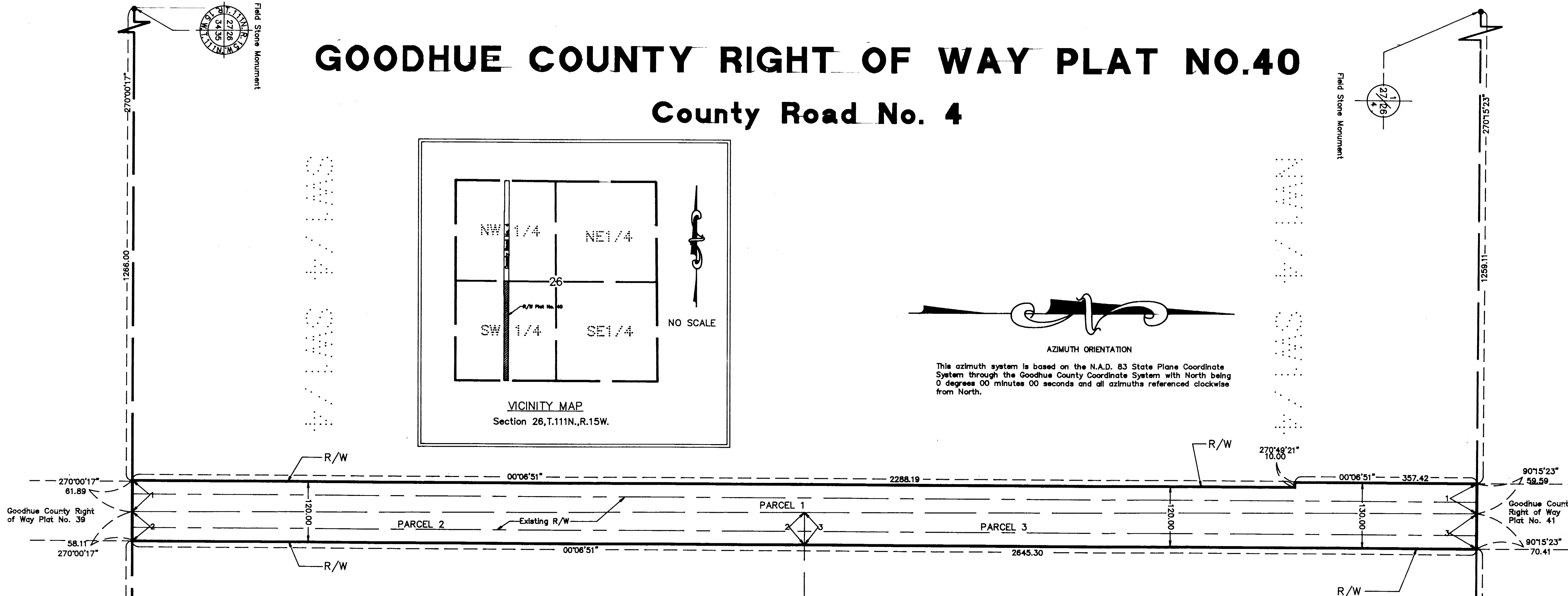


GOODHUE COUNTY RIGHT OF WAY PLAT NO.40

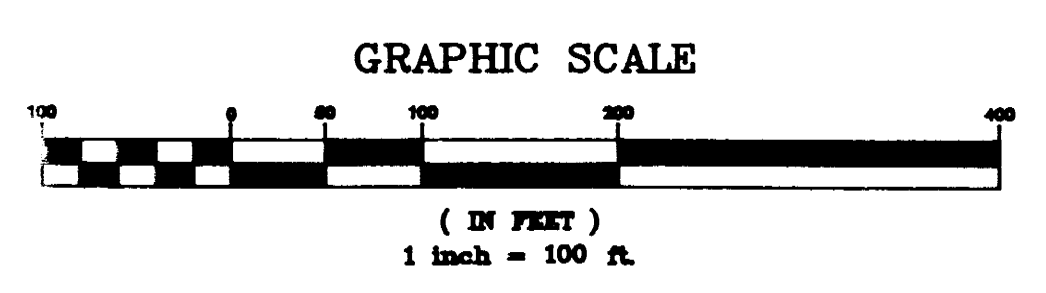
