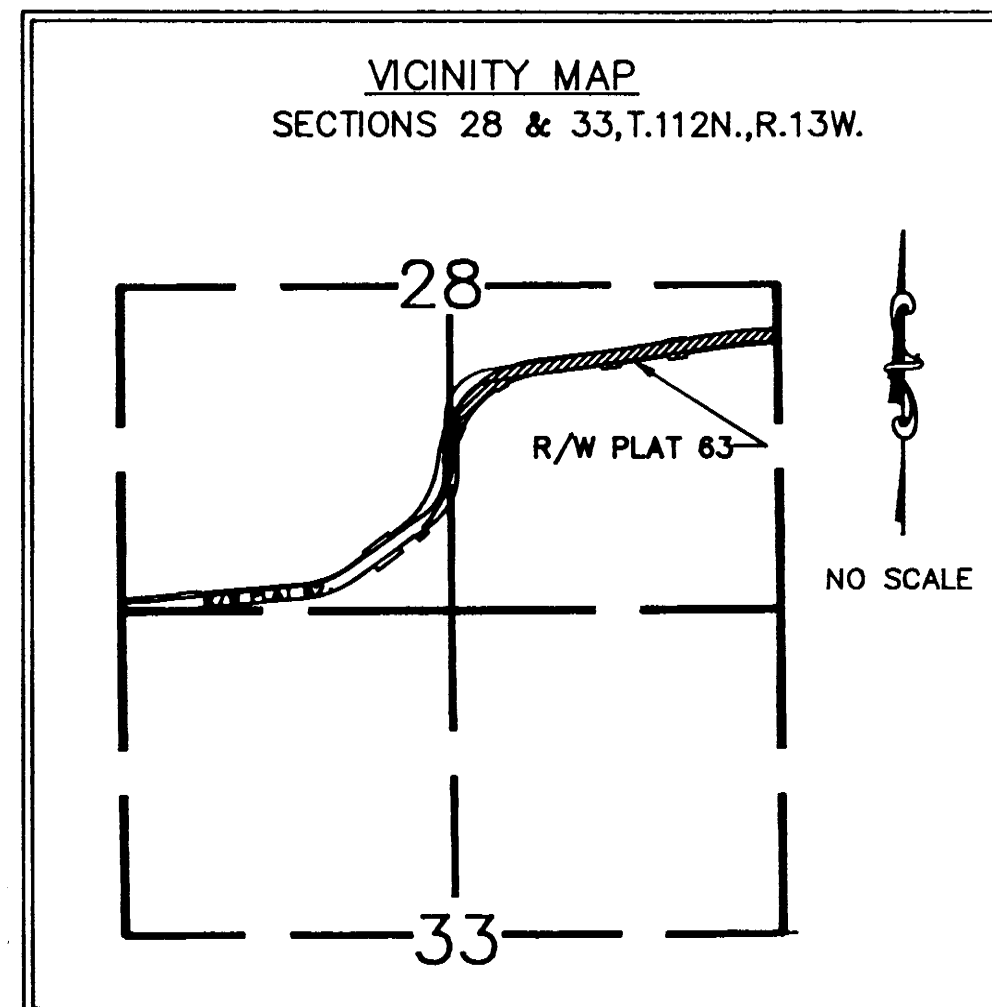
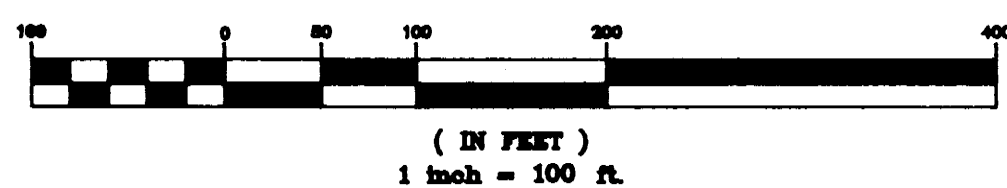

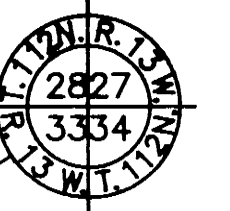
GRAPHIC SCALE
