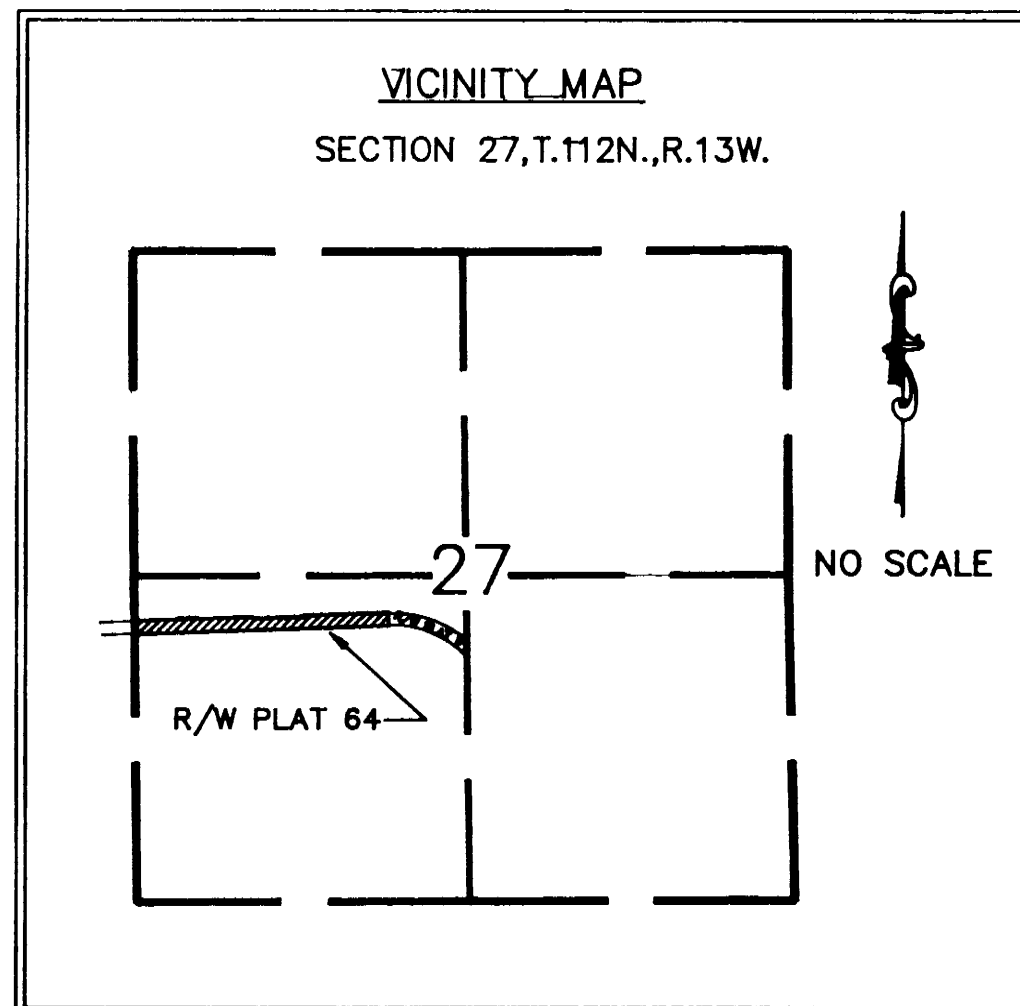


GOODHUE COUNTY RIGHT OF WAY PLAT NO. 64

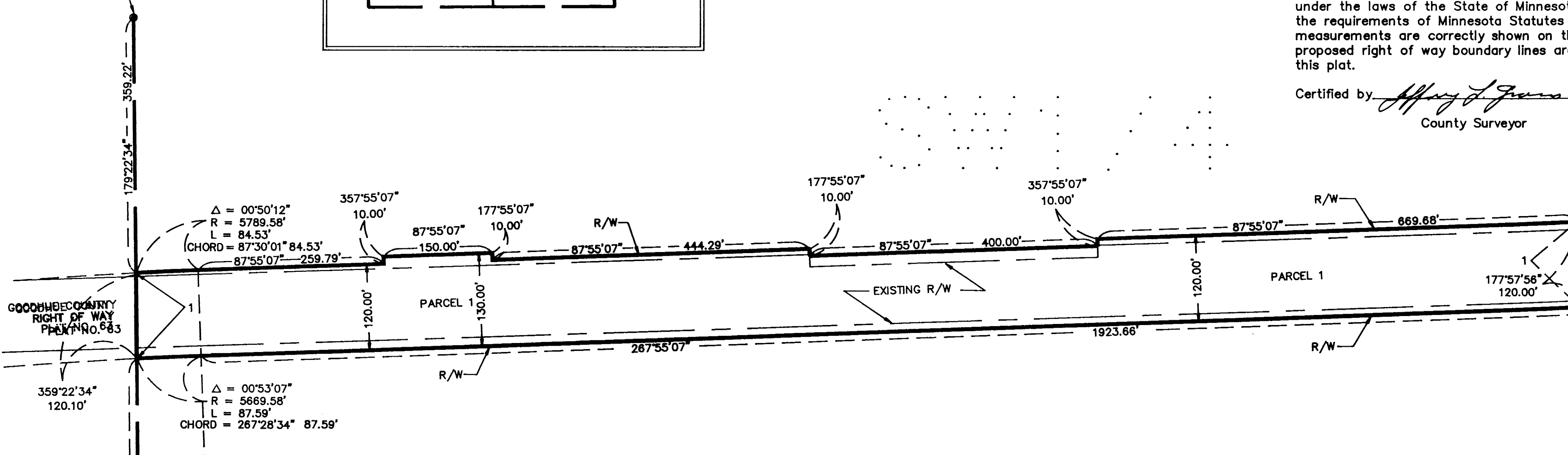
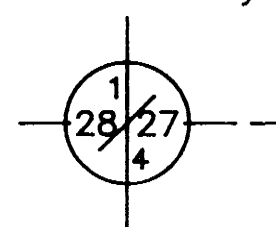

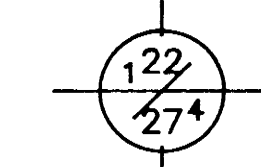
AZIMUTH ORIENTATION

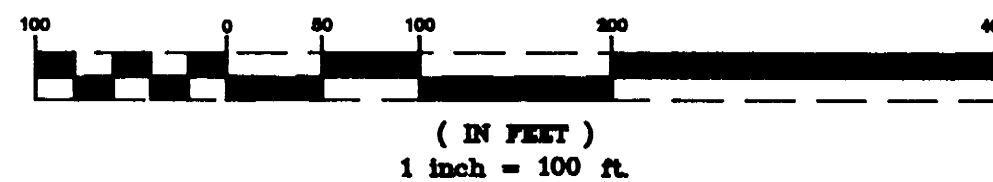

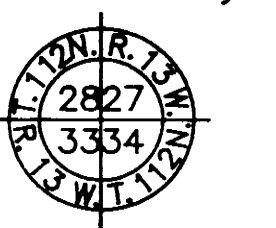
