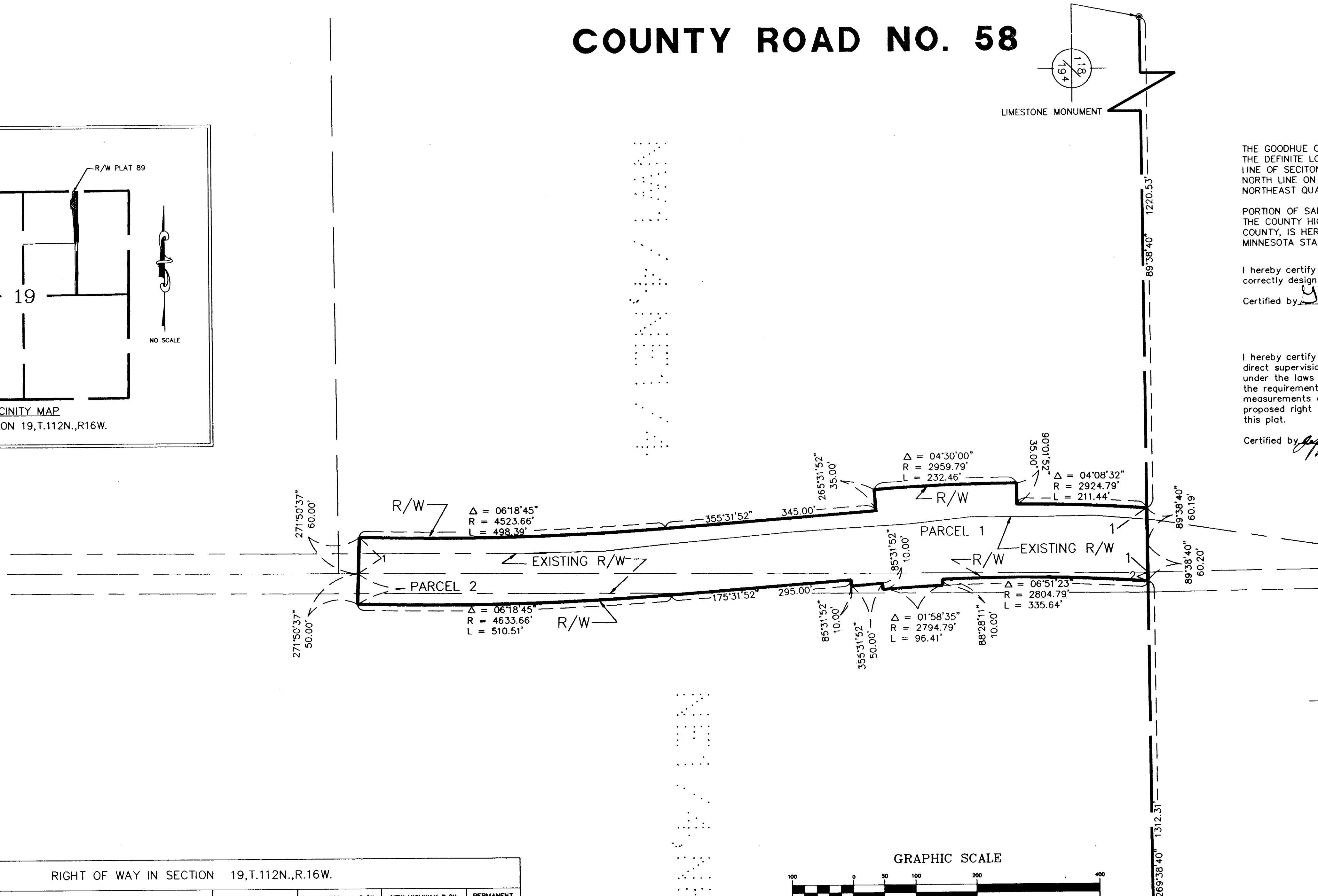
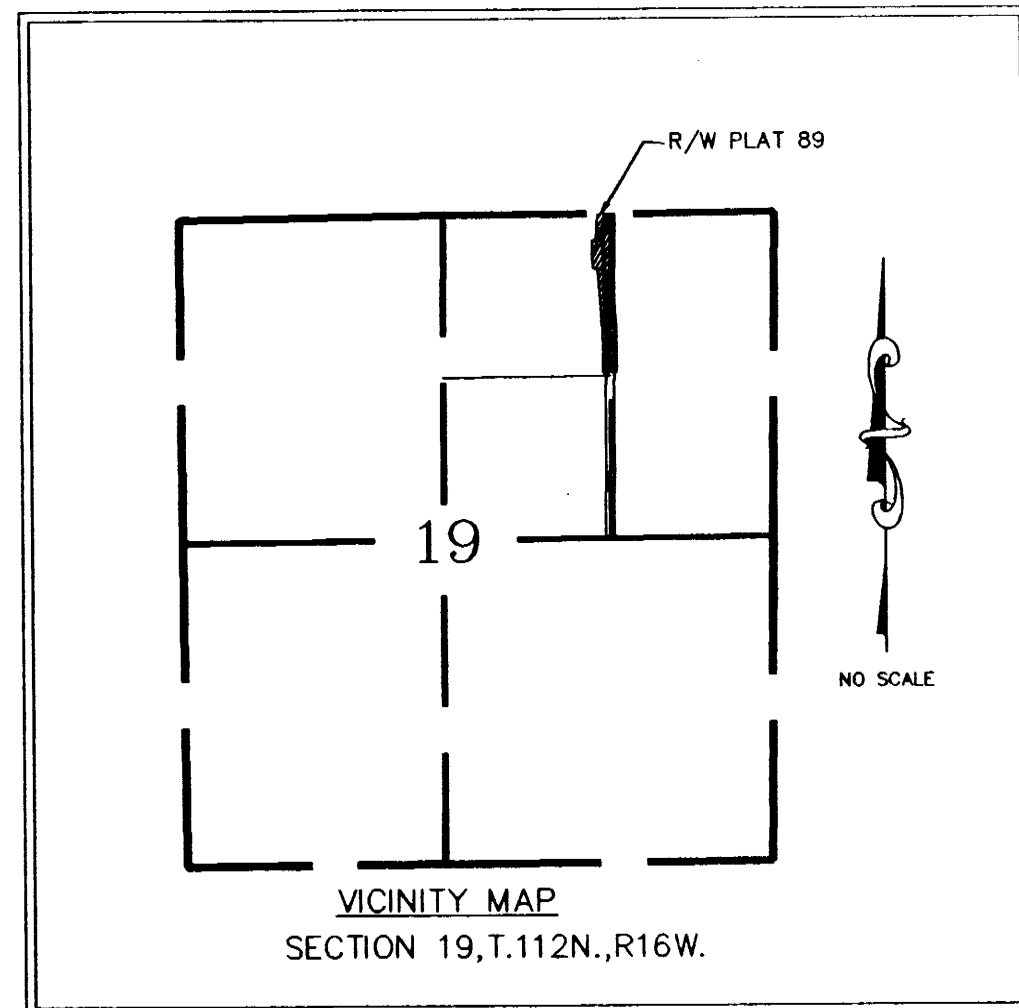


GOODHUE COUNTY RIGHT OF WAY PLAT NO. 89

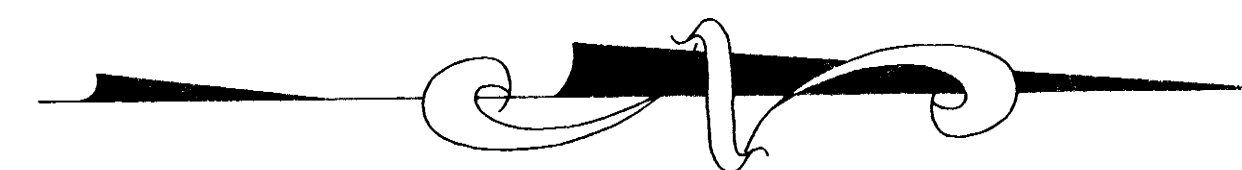

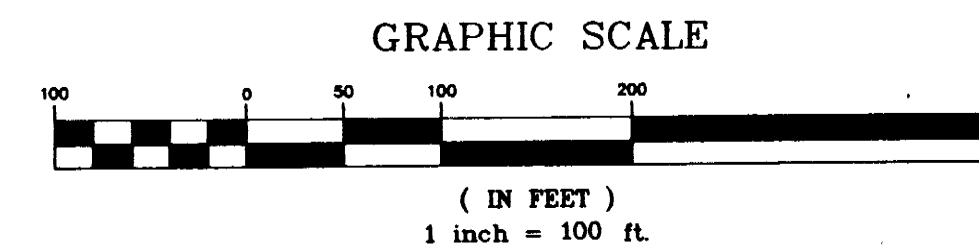

AZIMUTH ORIENTATION

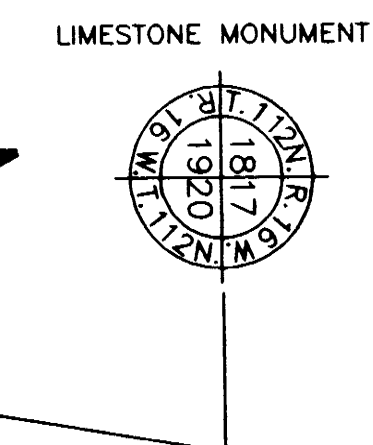
