I hereby certify that the highway location and right of way is correctly designated on this plat.

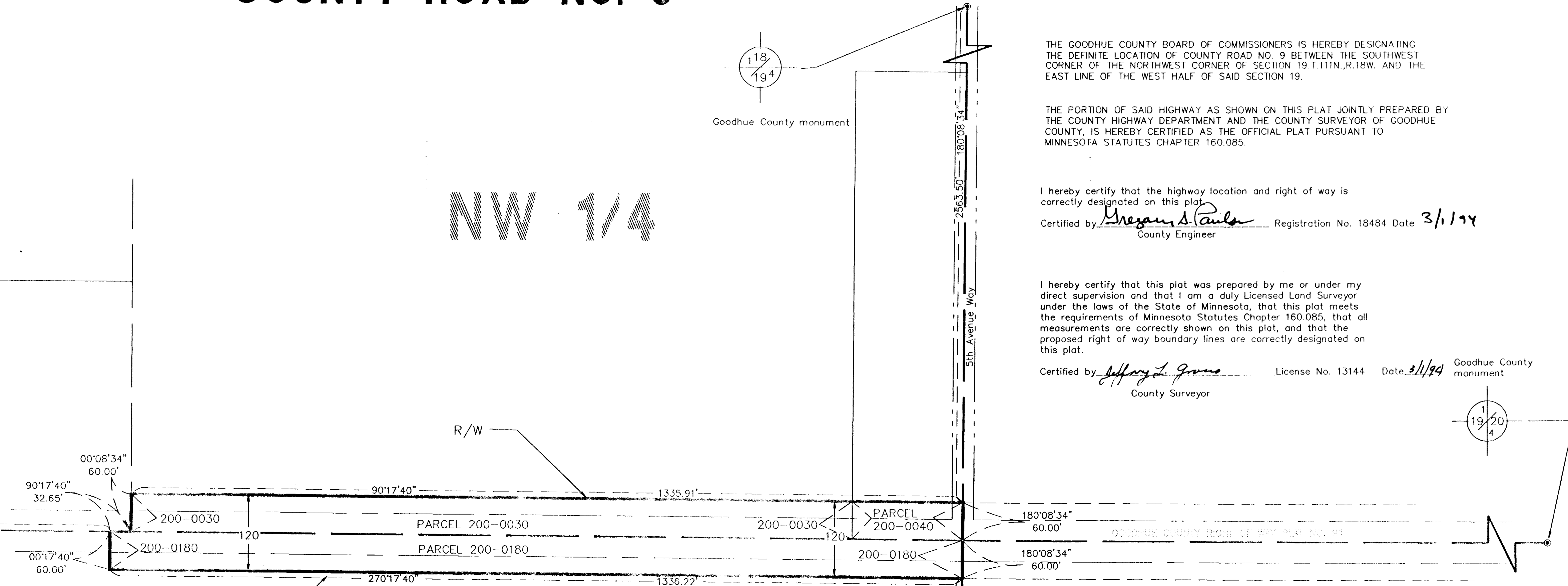
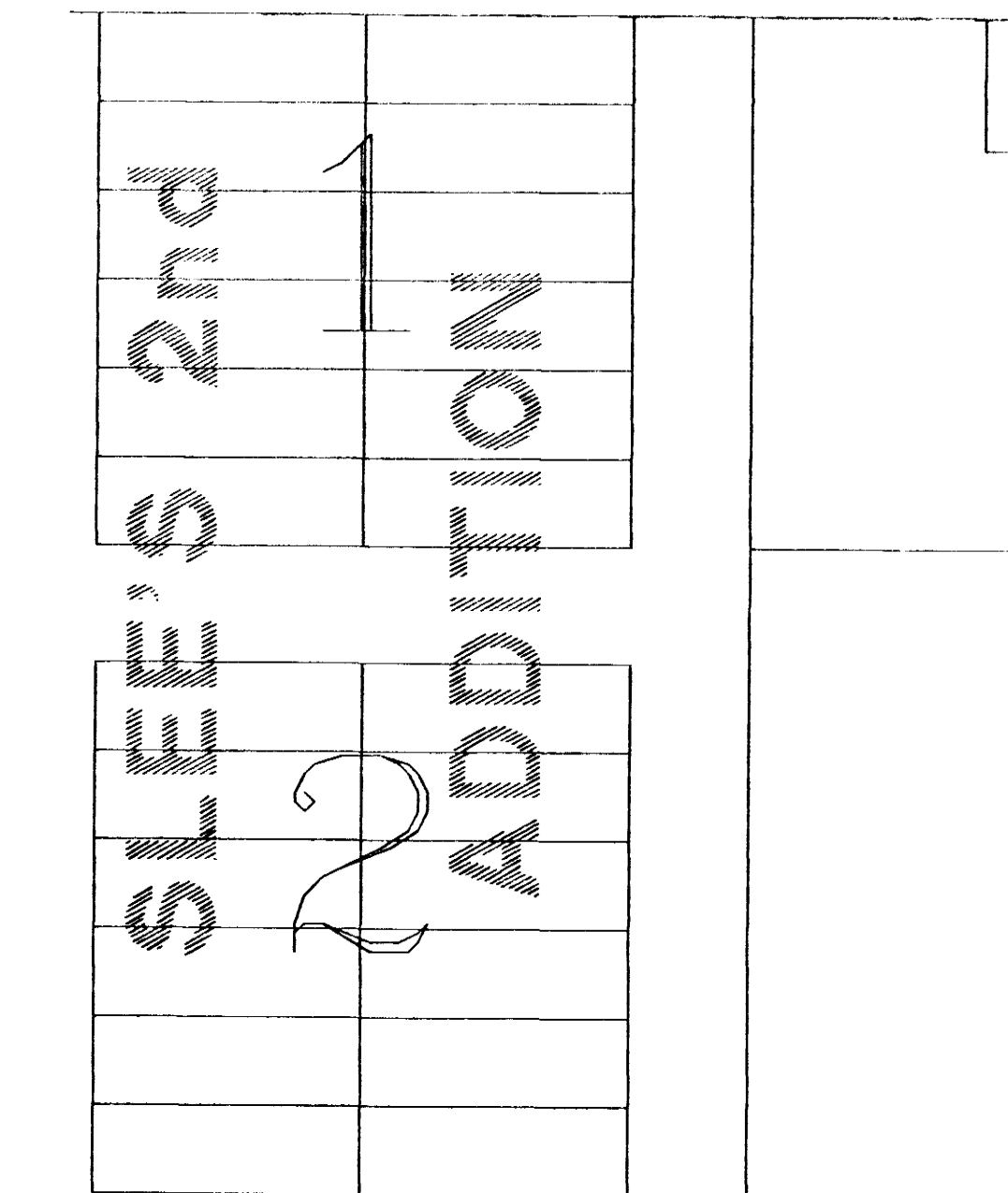
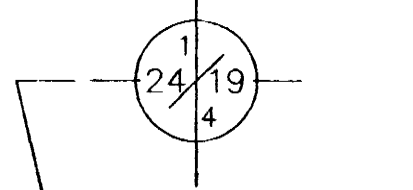
