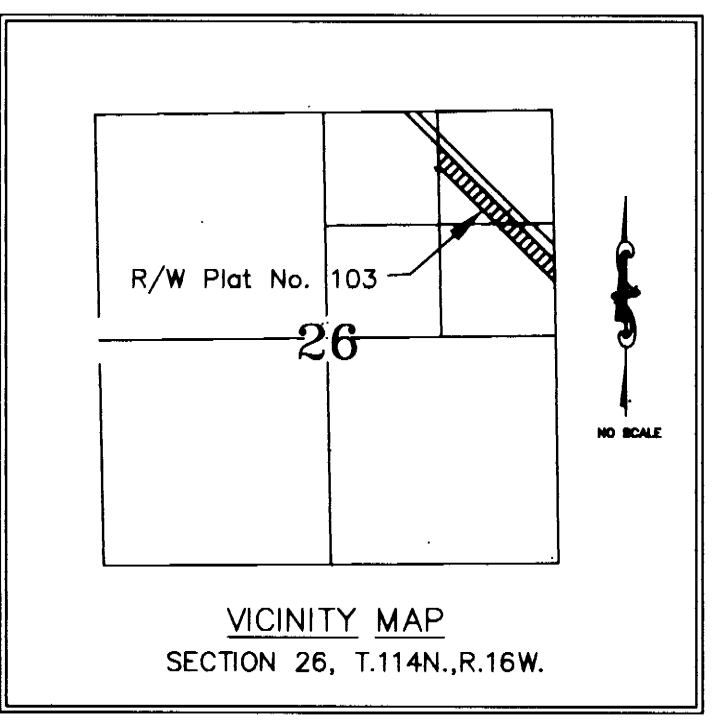
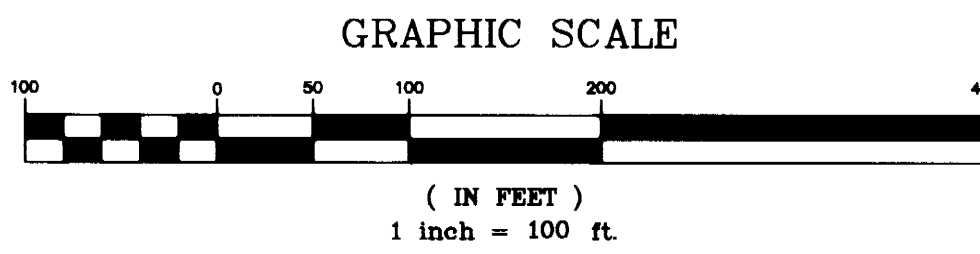
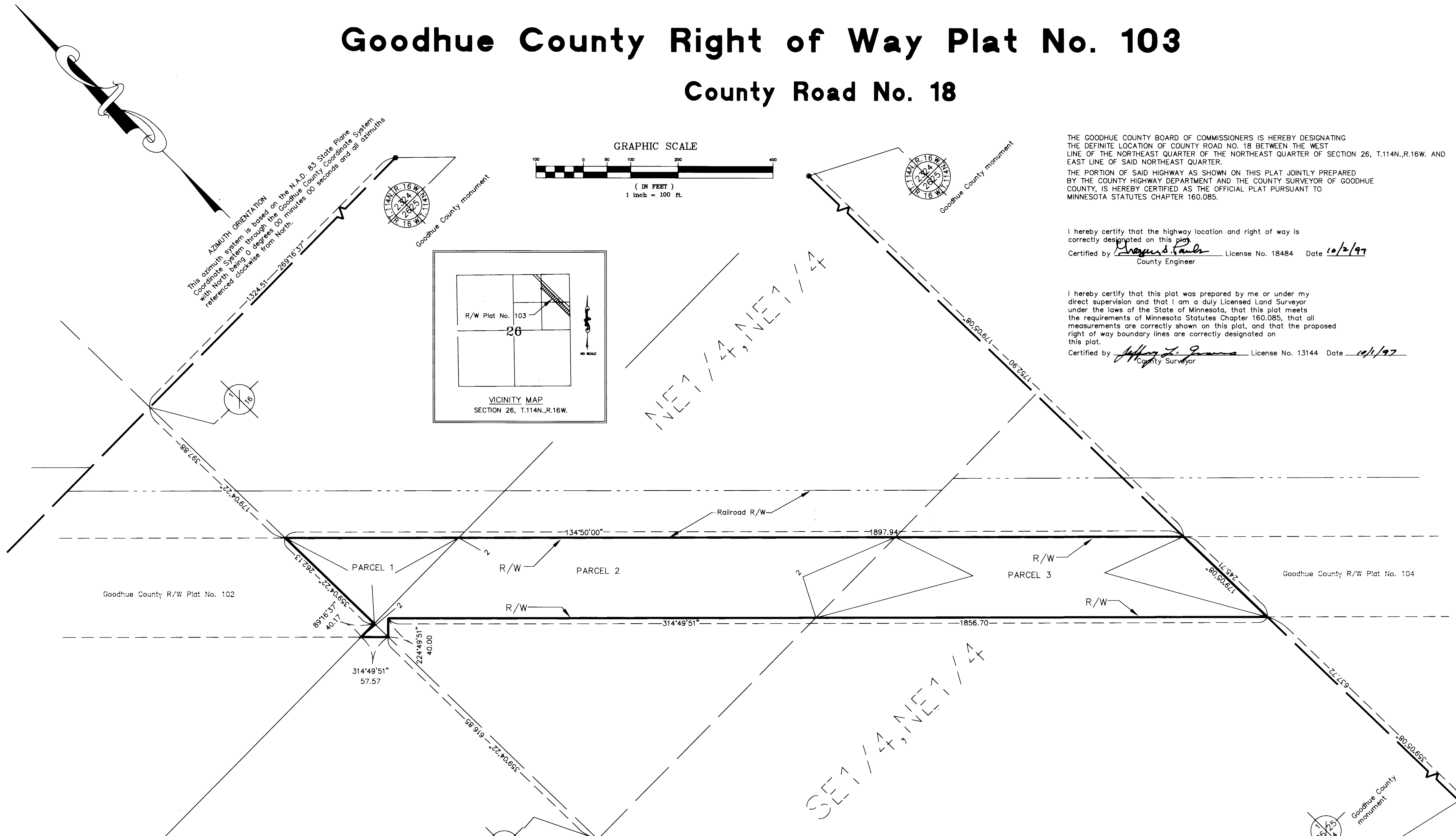


Goodhue County Right of Way Plat No. 103
