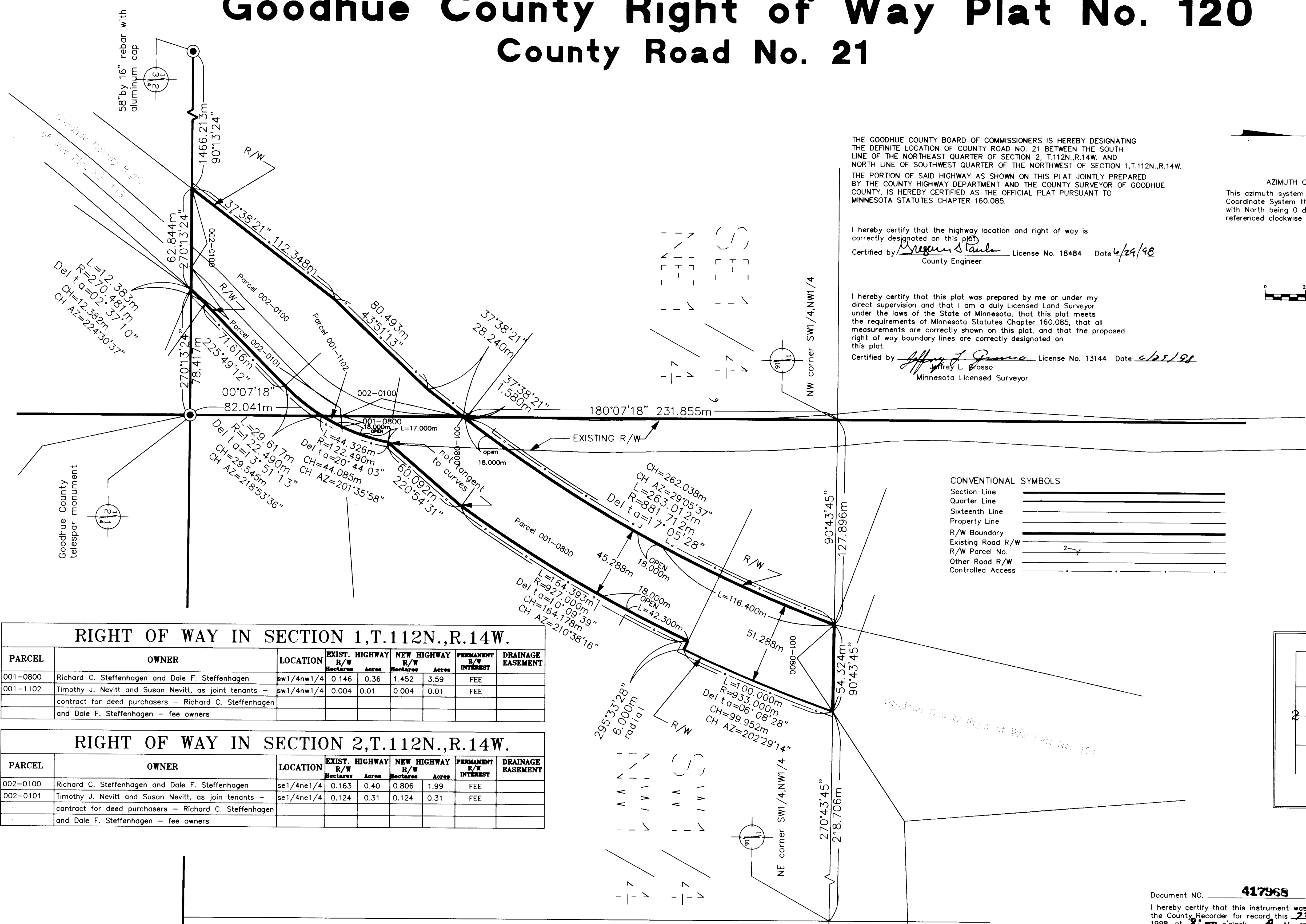


Goodhue County Right of Way Plat No. 120

County Road No. 21



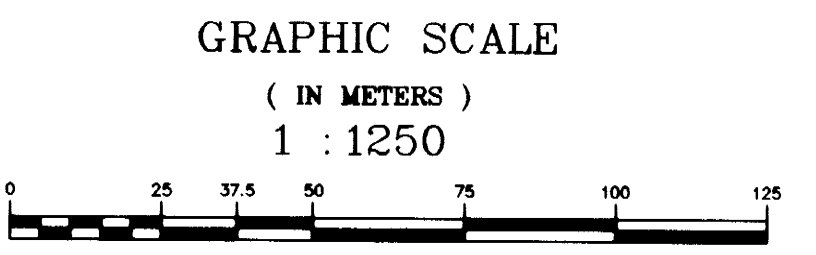

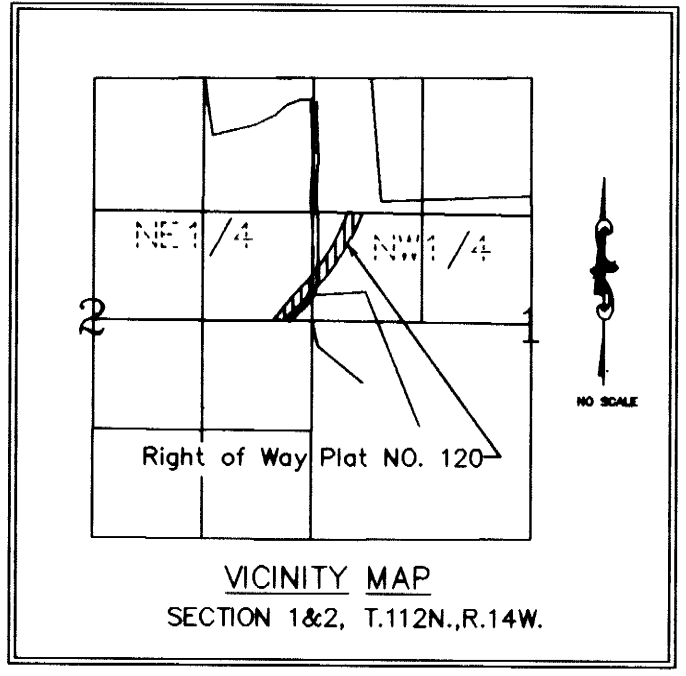
