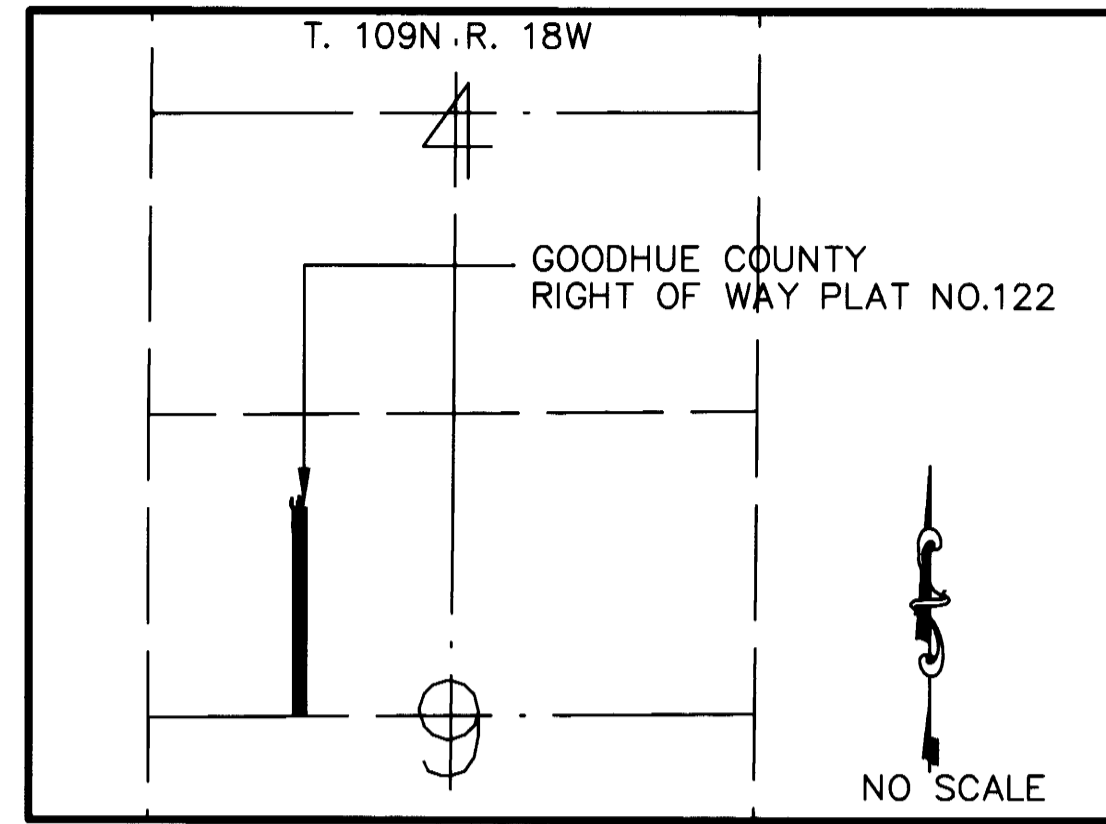
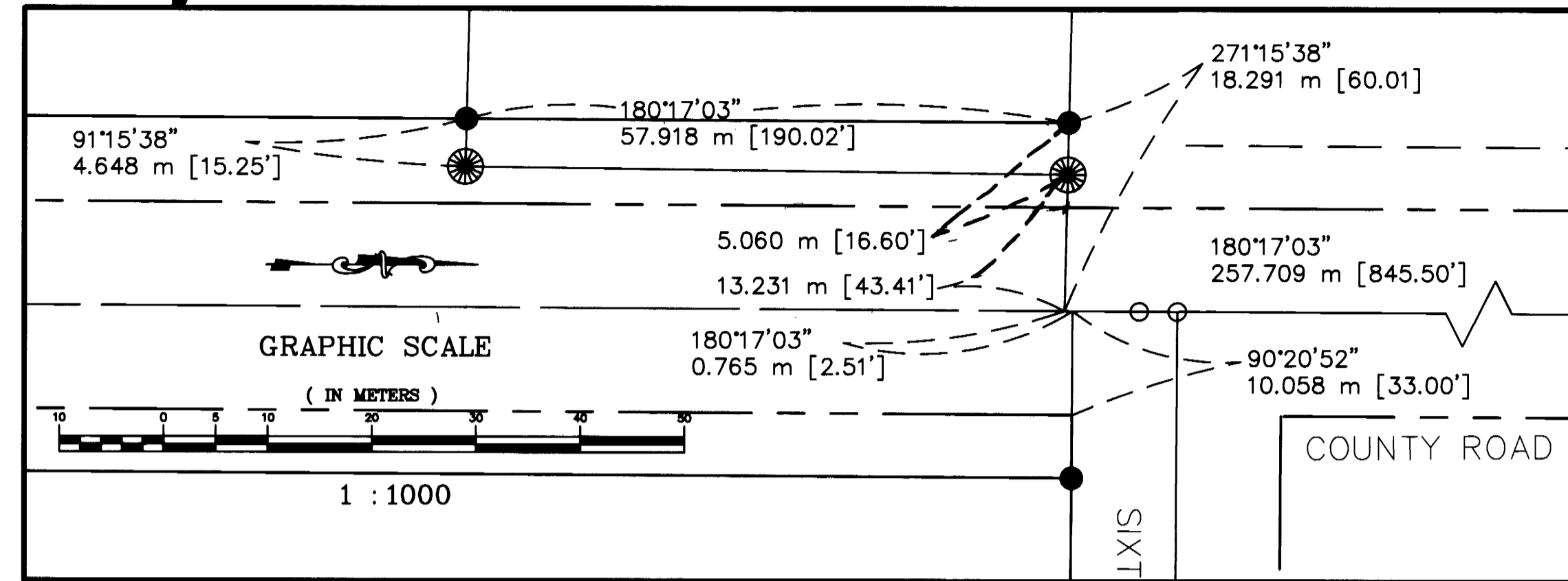


Goodhue County Right of Way Plat No. 122

LOCATION MAP T.109N. R.18W.

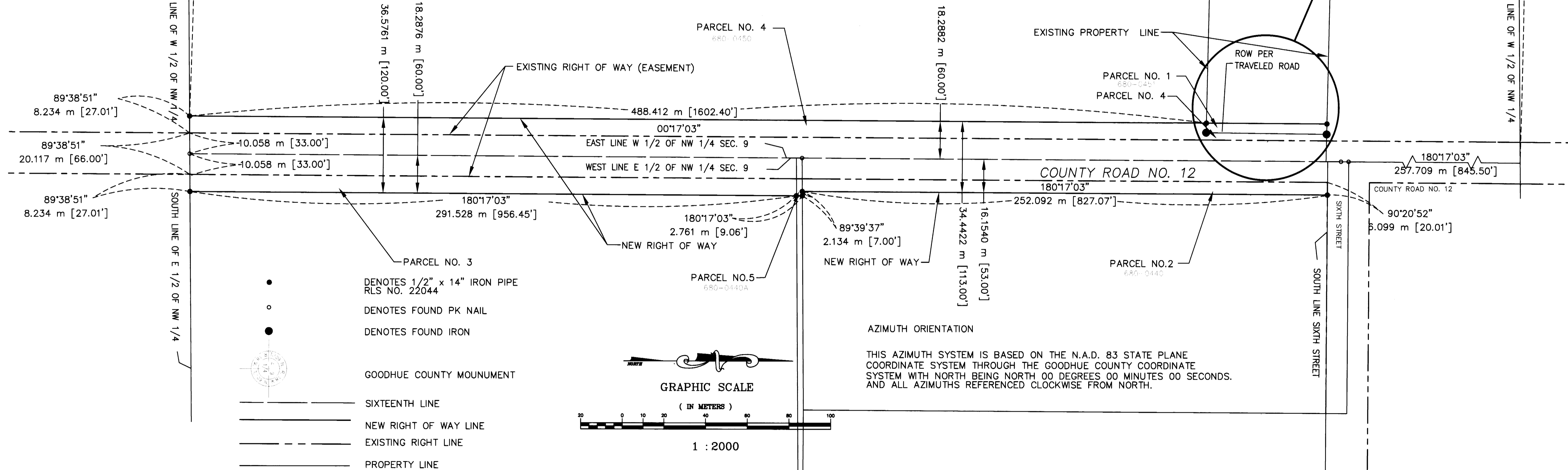
