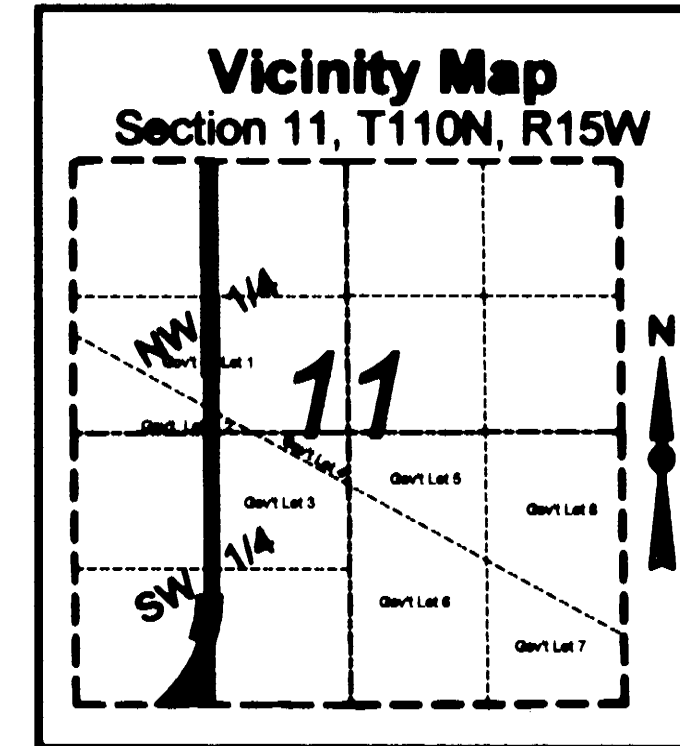
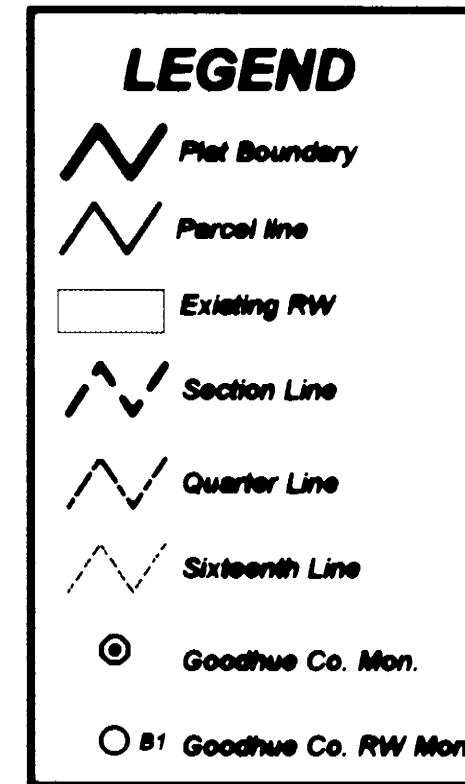

Goodhue County ROW monuments are 5/8" by 24" rebar with a 2" aluminum cap marked "Goodhue County RW LS 23048" and will be placed in the ground after construction is complete.
