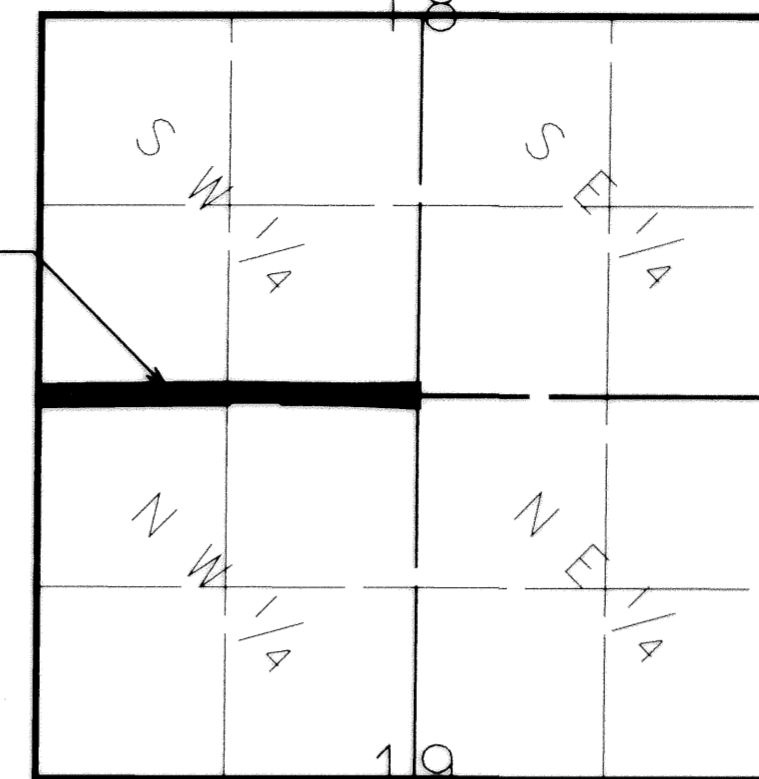

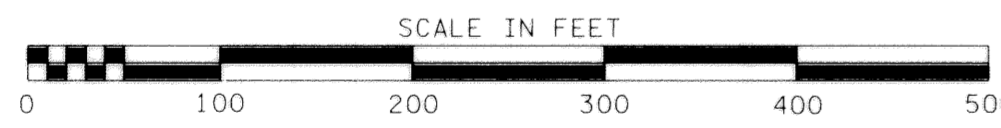
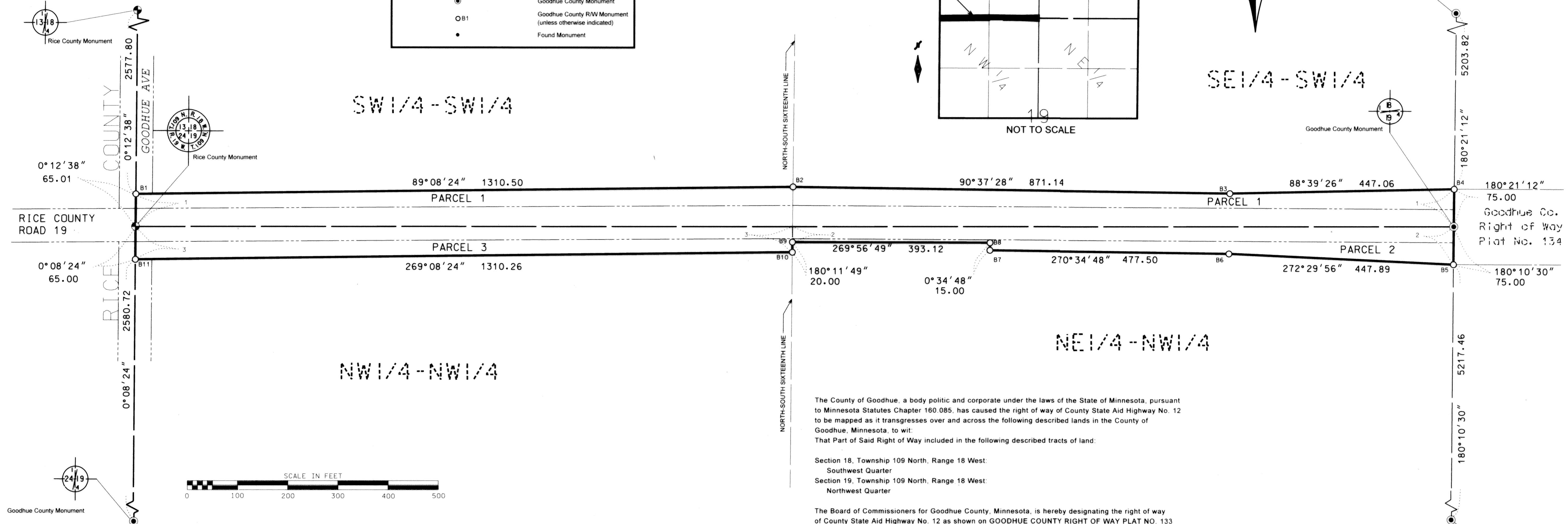
## VICINITY MAP
