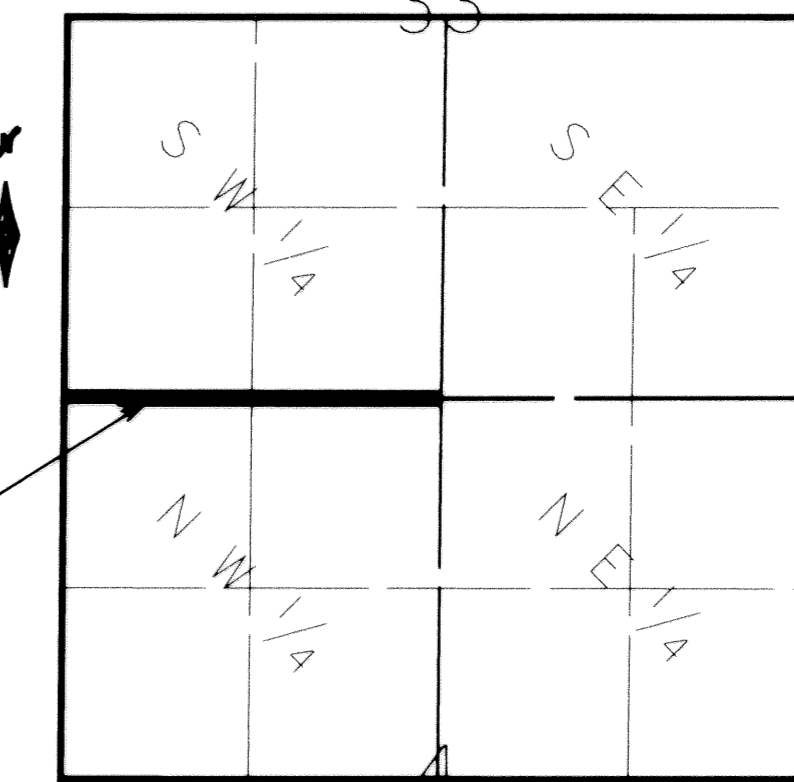

This plat is subject to easements of record.

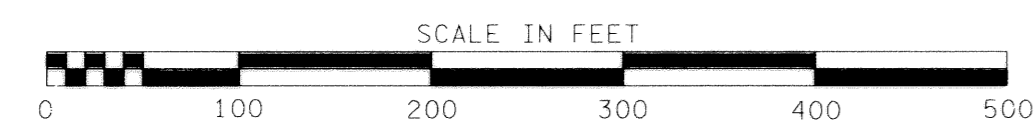
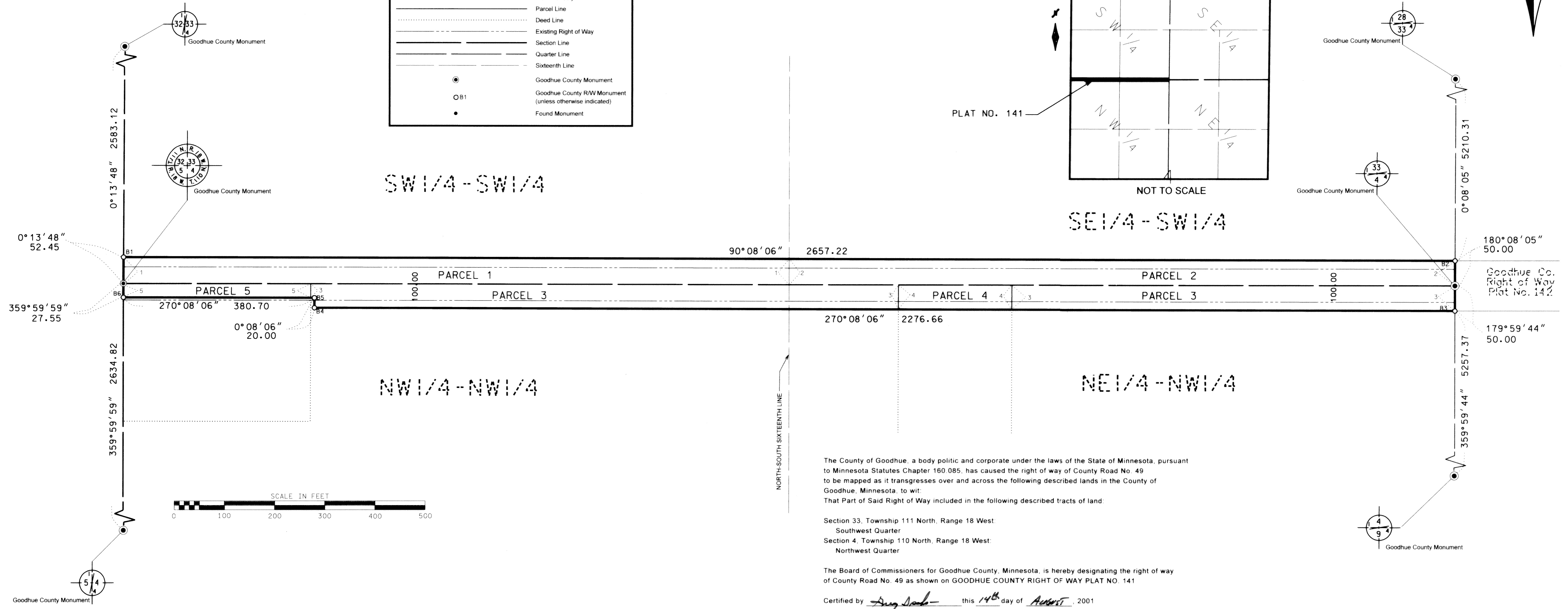
