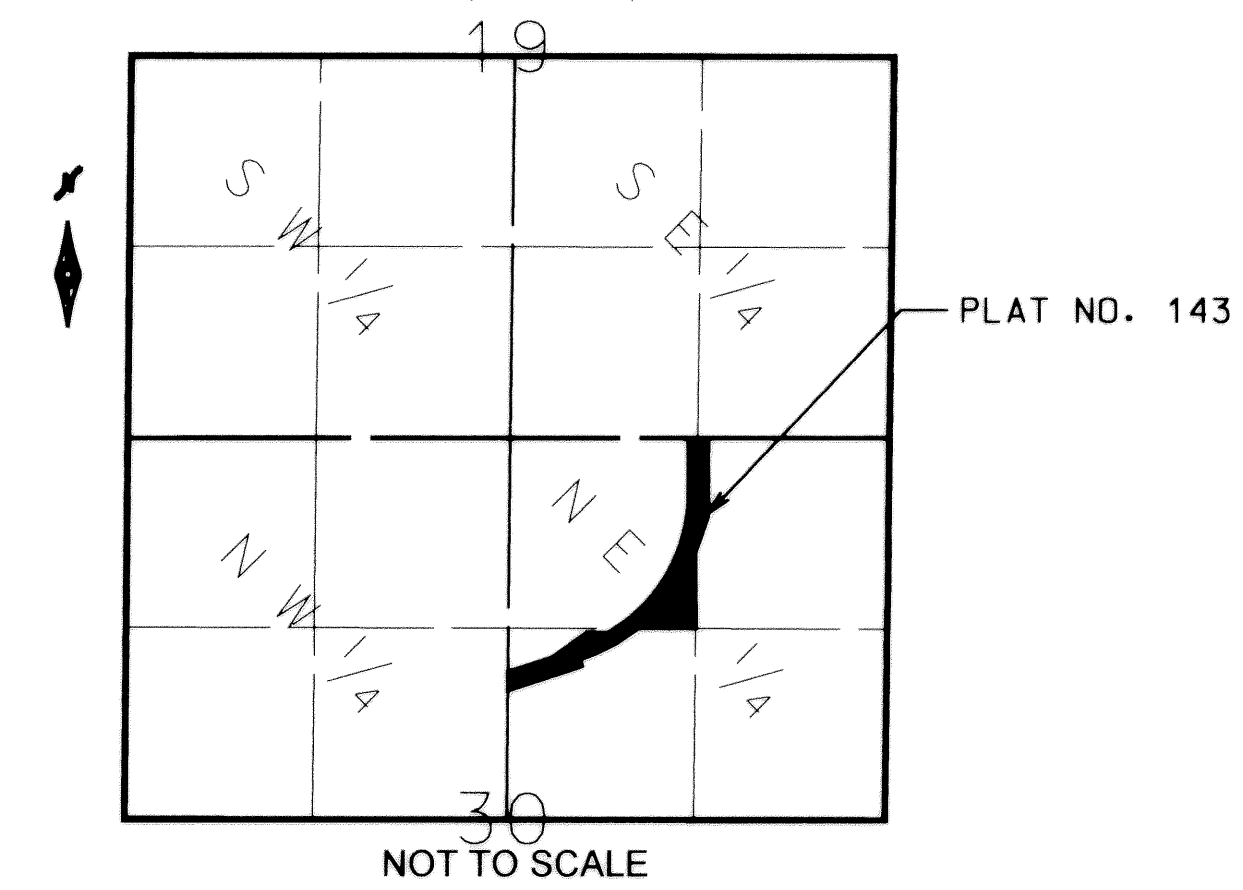


# GOODHUE COUNTY RIGHT OF WAY PLAT NO. 143

Section 30, T.112 N., R16 W



Goodhue County Right of Way Monuments are 5/8" by 24" rebar with a 2" aluminum cap marked "Goodhue County RW LS 23048" and will be placed in the ground after construction is complete.

This azimuth system is based on the HARN Adjustment of NAD 1983 Goodhue County coordinate system with the North being 00 degrees 00 minutes 00 seconds, and all azimuth are referenced clockwise from north.

This plat is subject to easements of record.

The County of Goodhue, a body politic and corporate under the laws of the State of Minnesota, pursuant to Minnesota Statutes Chapter 160.085, has caused the right of way of County Road No. 58 to be mapped as it transgresses over and across the following described lands in the County of Goodhue, Minnesota, to wit:

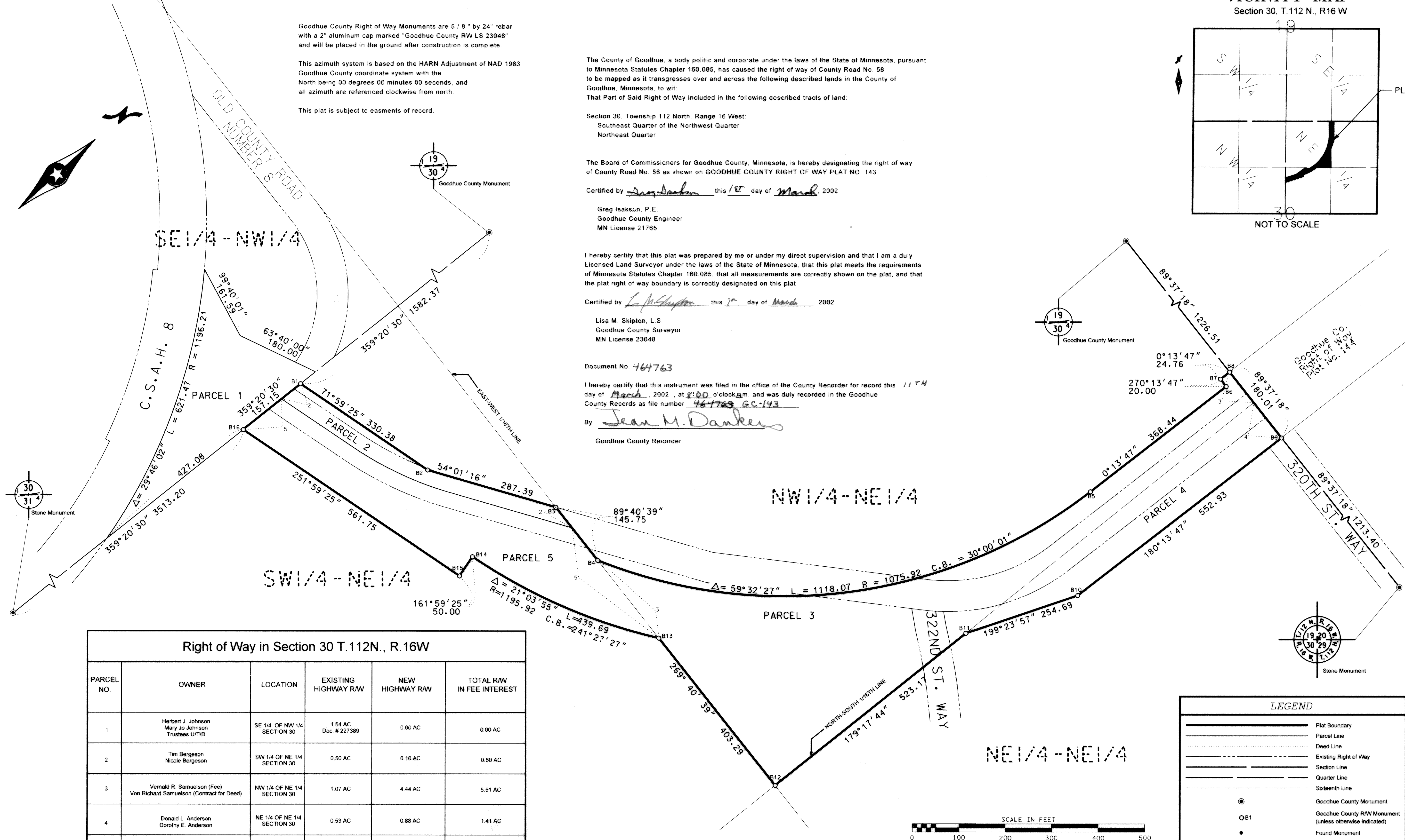
