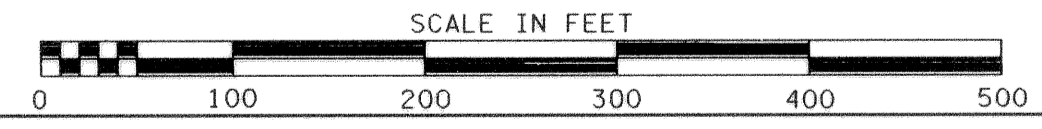


### VICINITY MAP

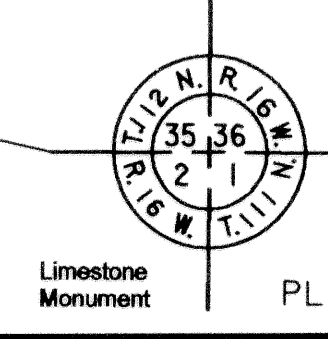
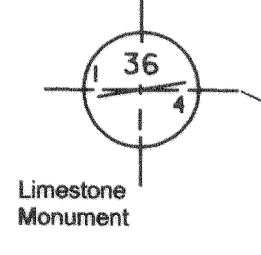
