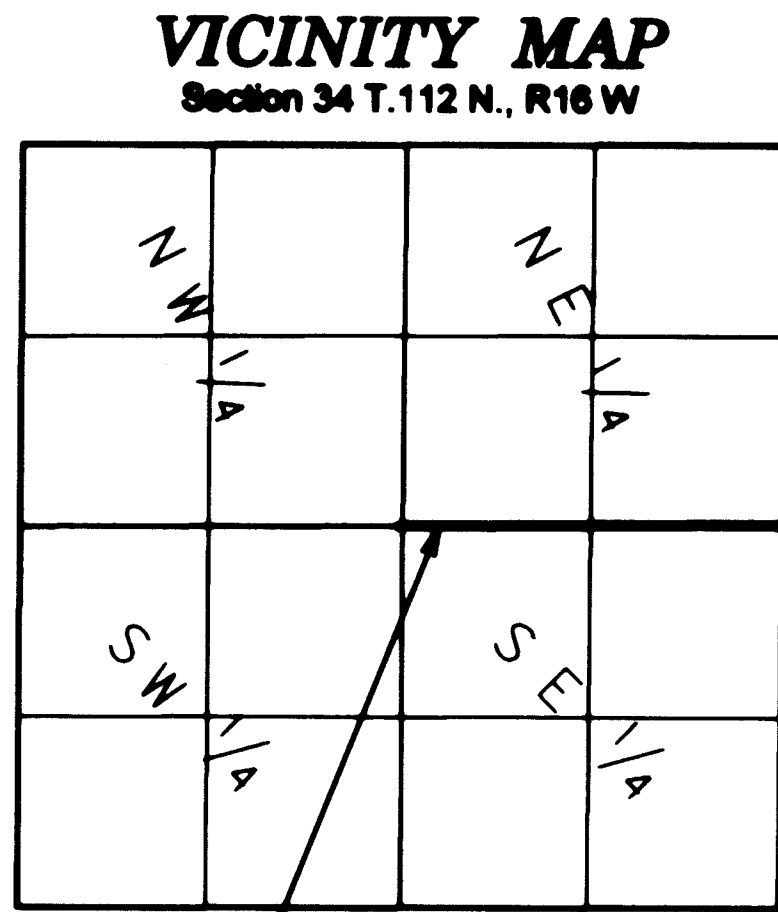
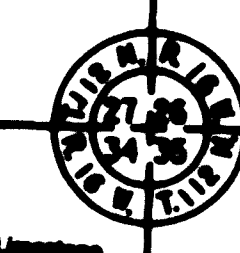
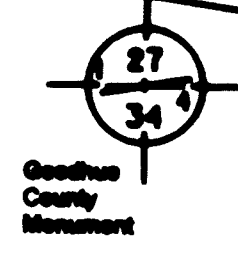


GOODHUE COUNTY RIGHT OF WAY PLAT NO. 171

This plat is subject to easements of record.

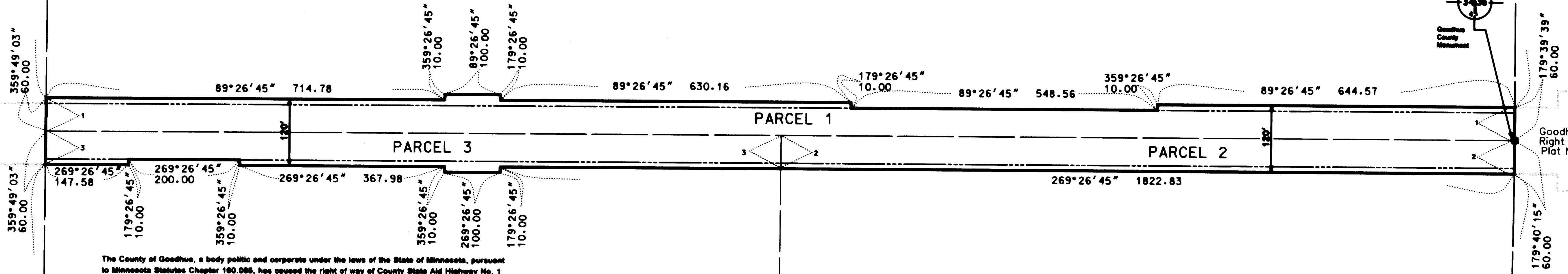
