

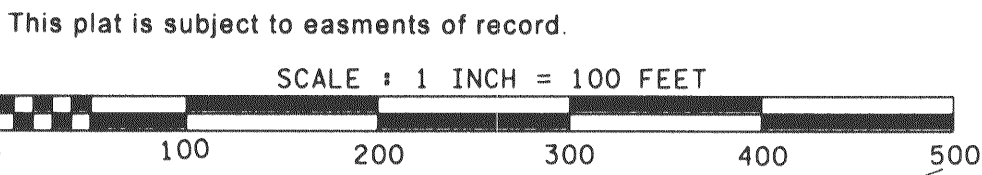

AMENDMENT TO GOODHUE COUNTY RIGHT OF WAY PLAT NO. 189 (PARCELS 1,2,3,4,&5)

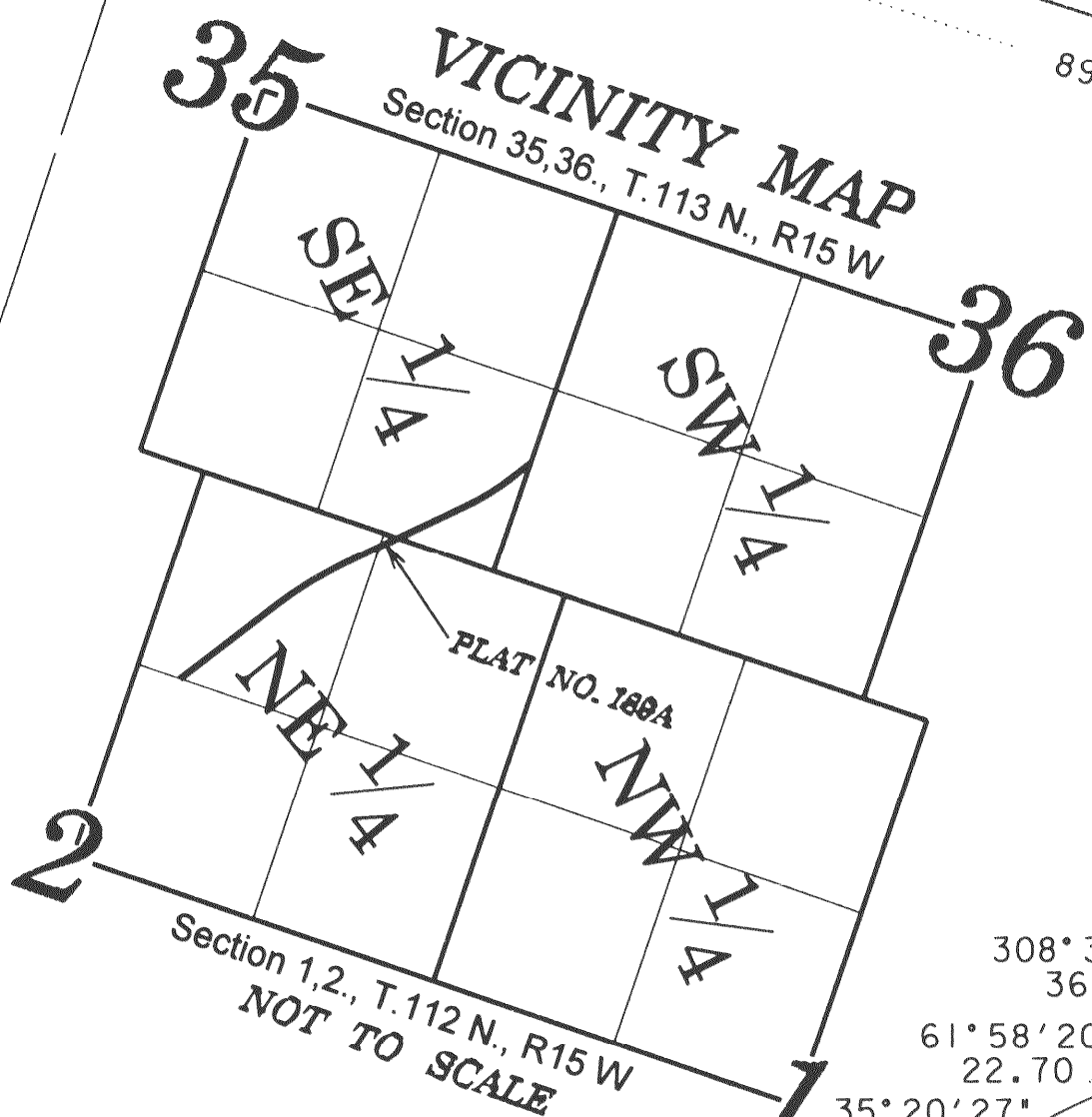
