

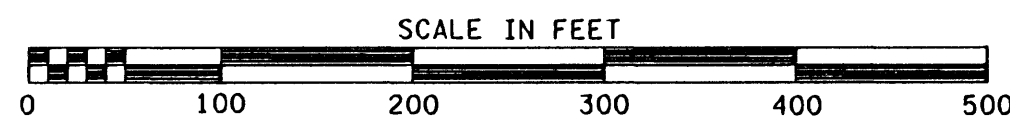
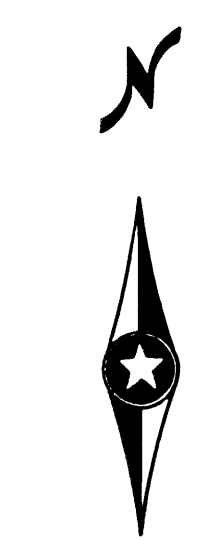
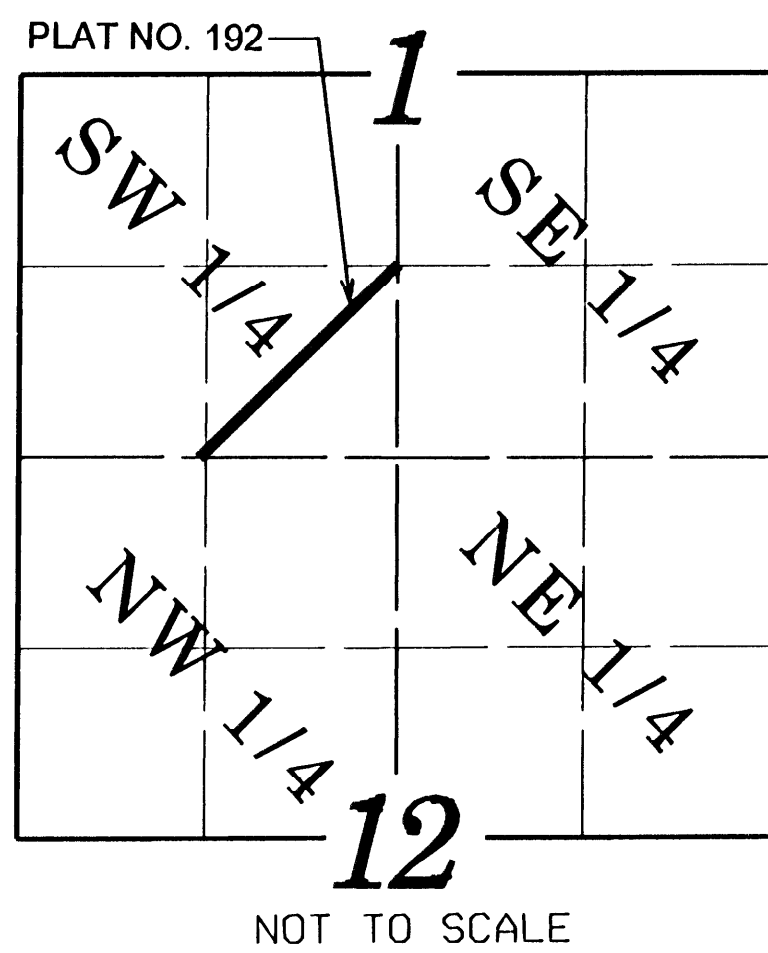

Section 1, & 12, T.111 N., R.17 W

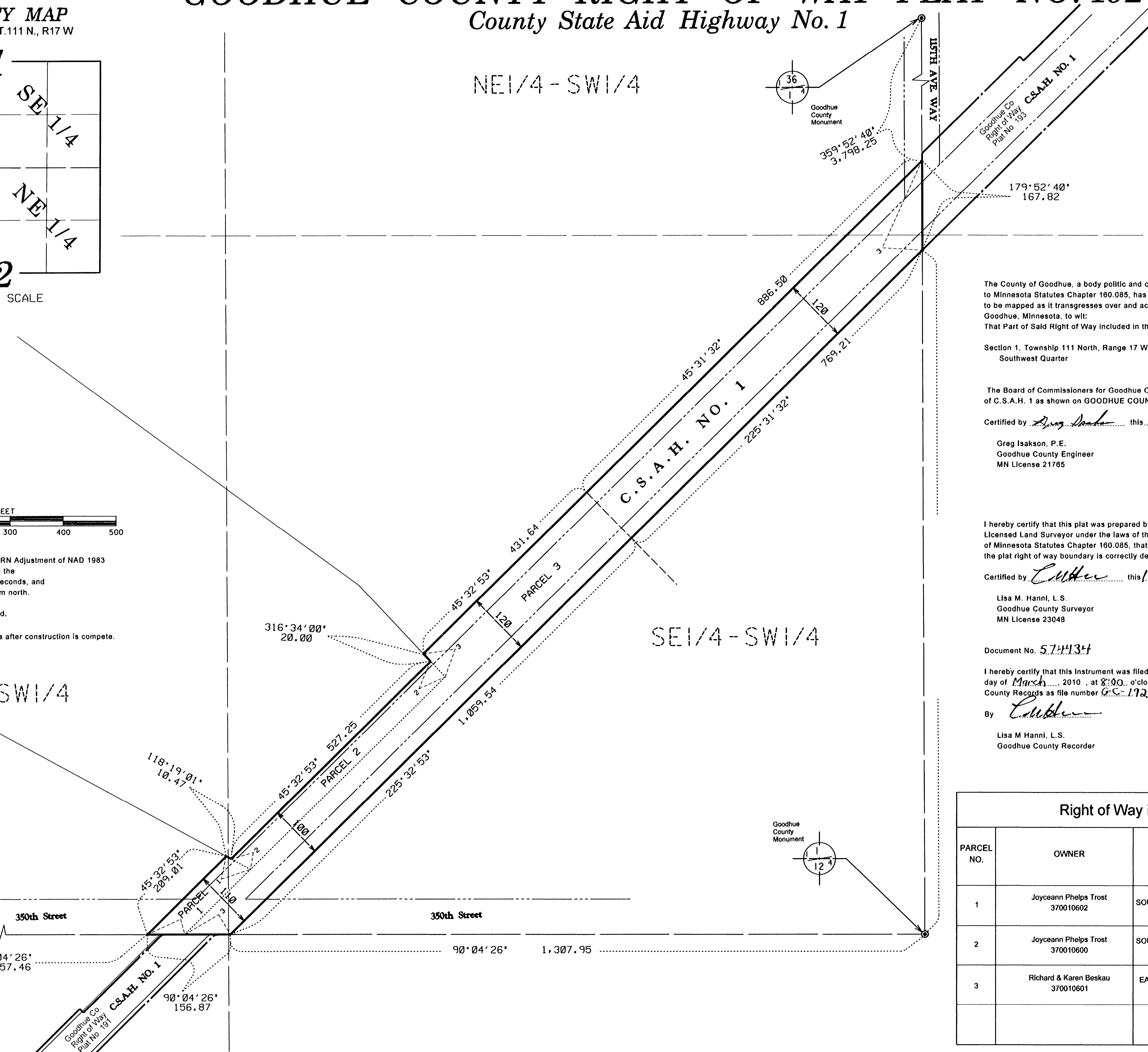
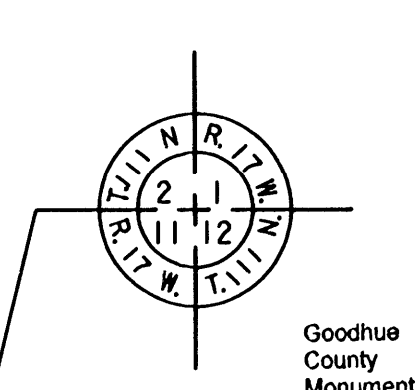
