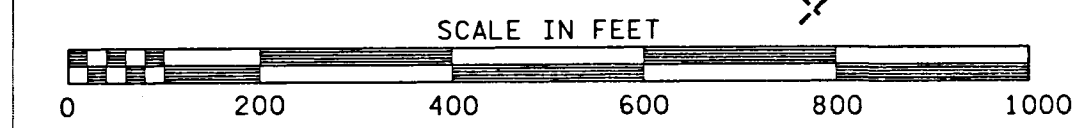
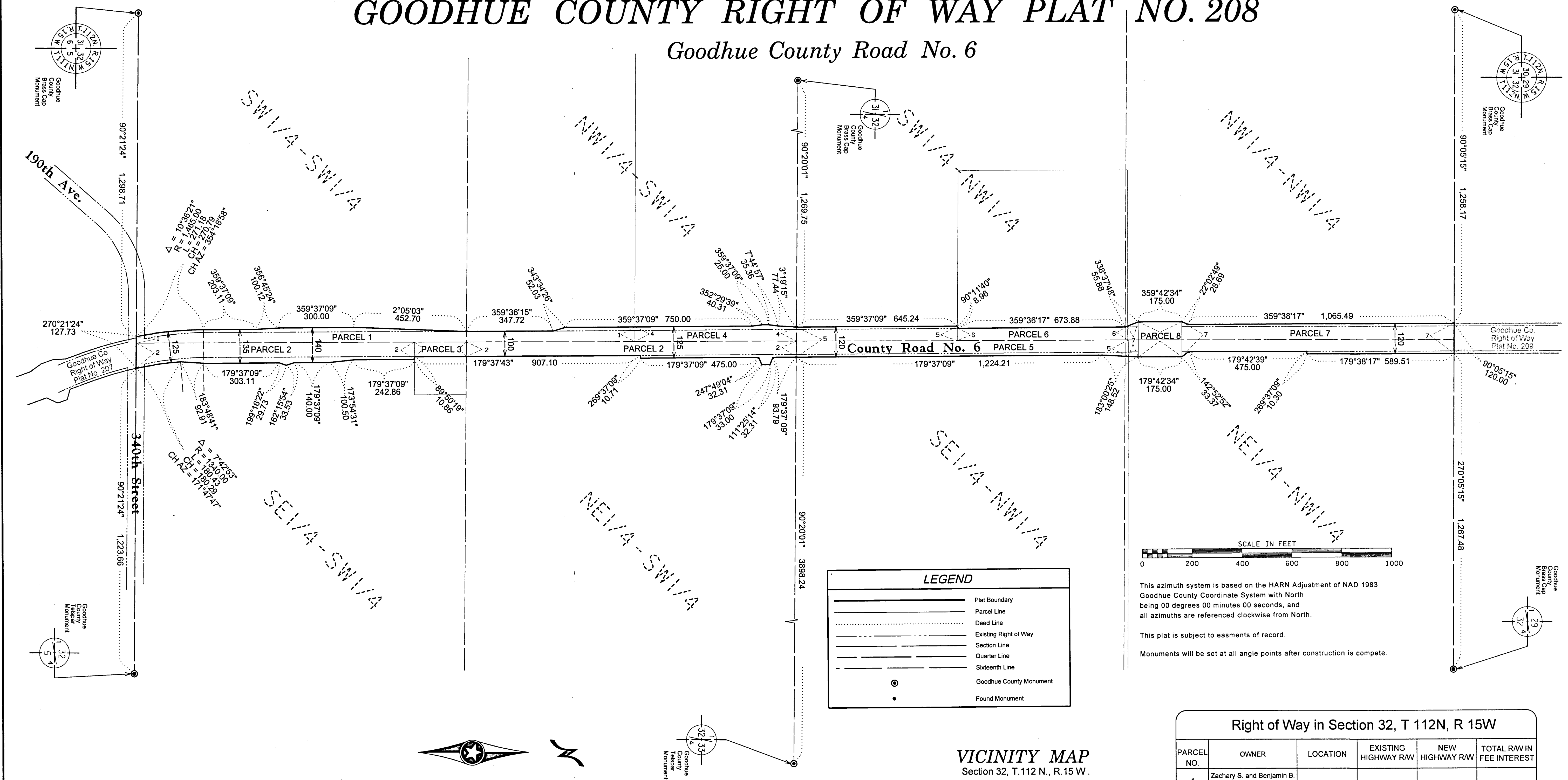


GOODHUE COUNTY RIGHT OF WAY PLAT NO. 208

Goodhue County Road No. 6

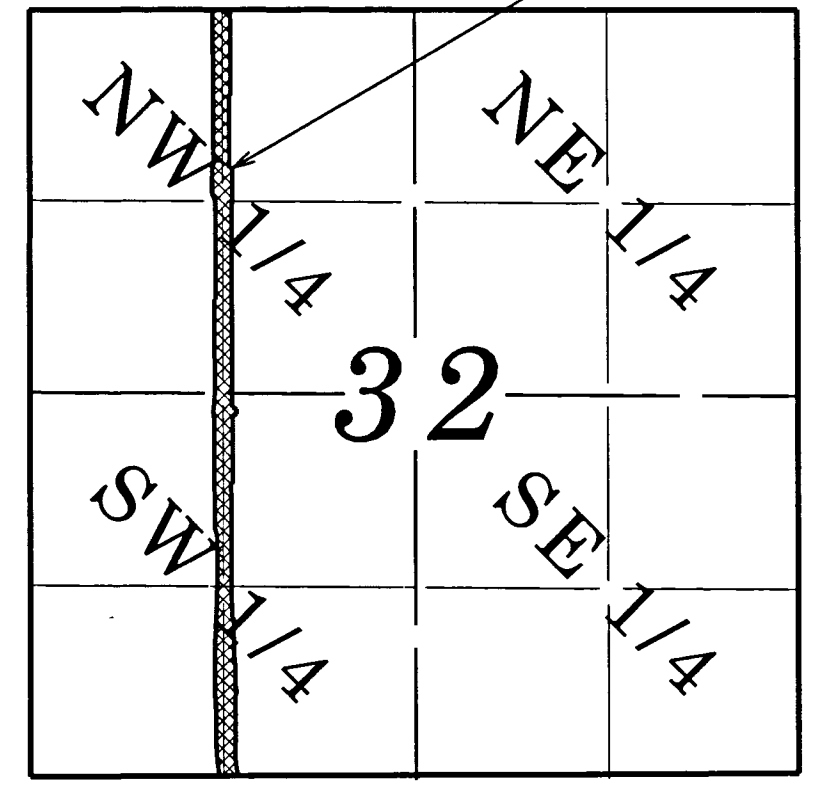
