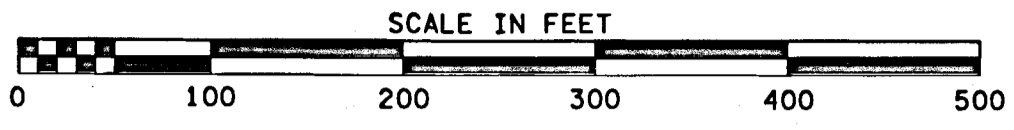
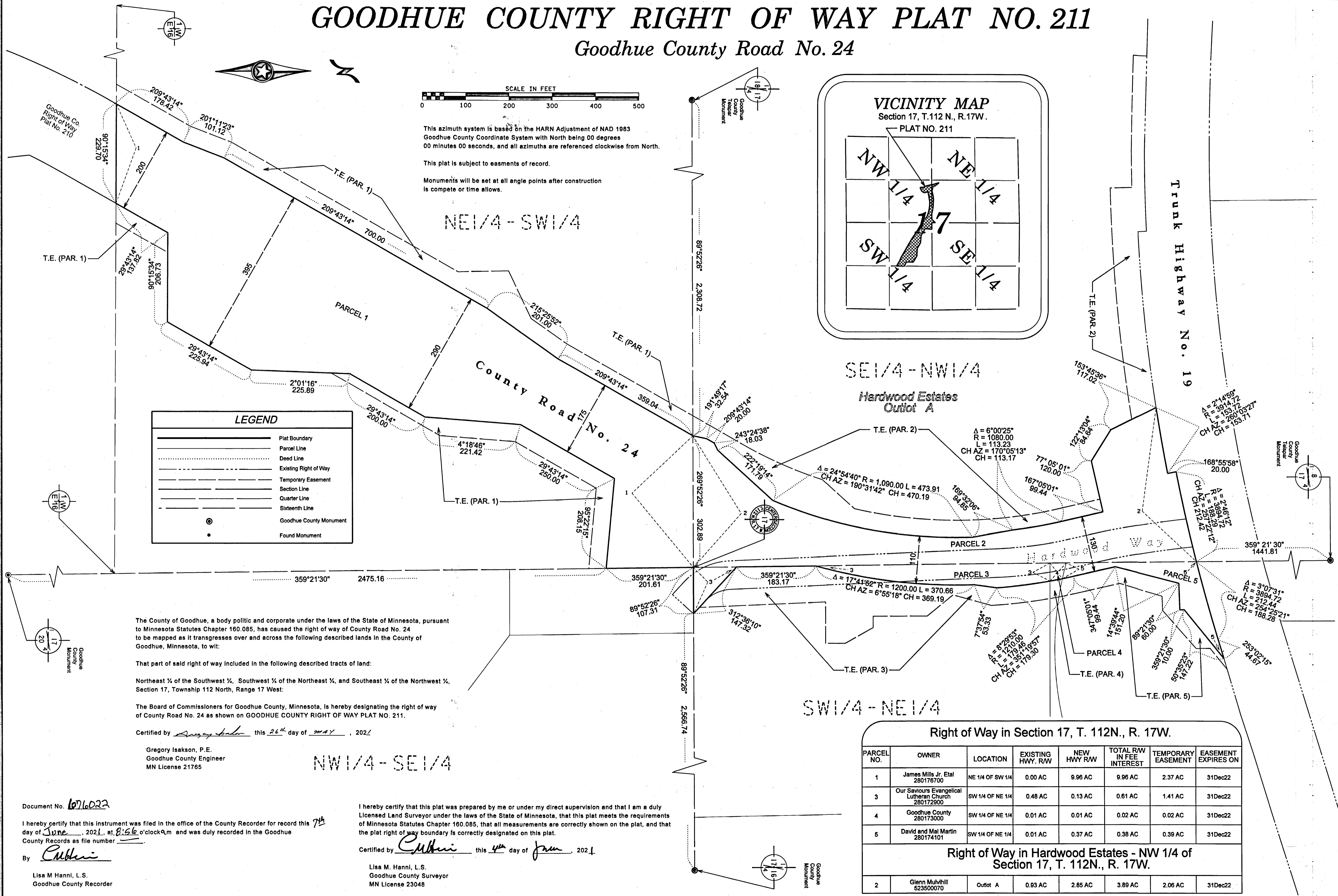

# GOODHUE COUNTY RIGHT OF WAY PLAT NO. 211

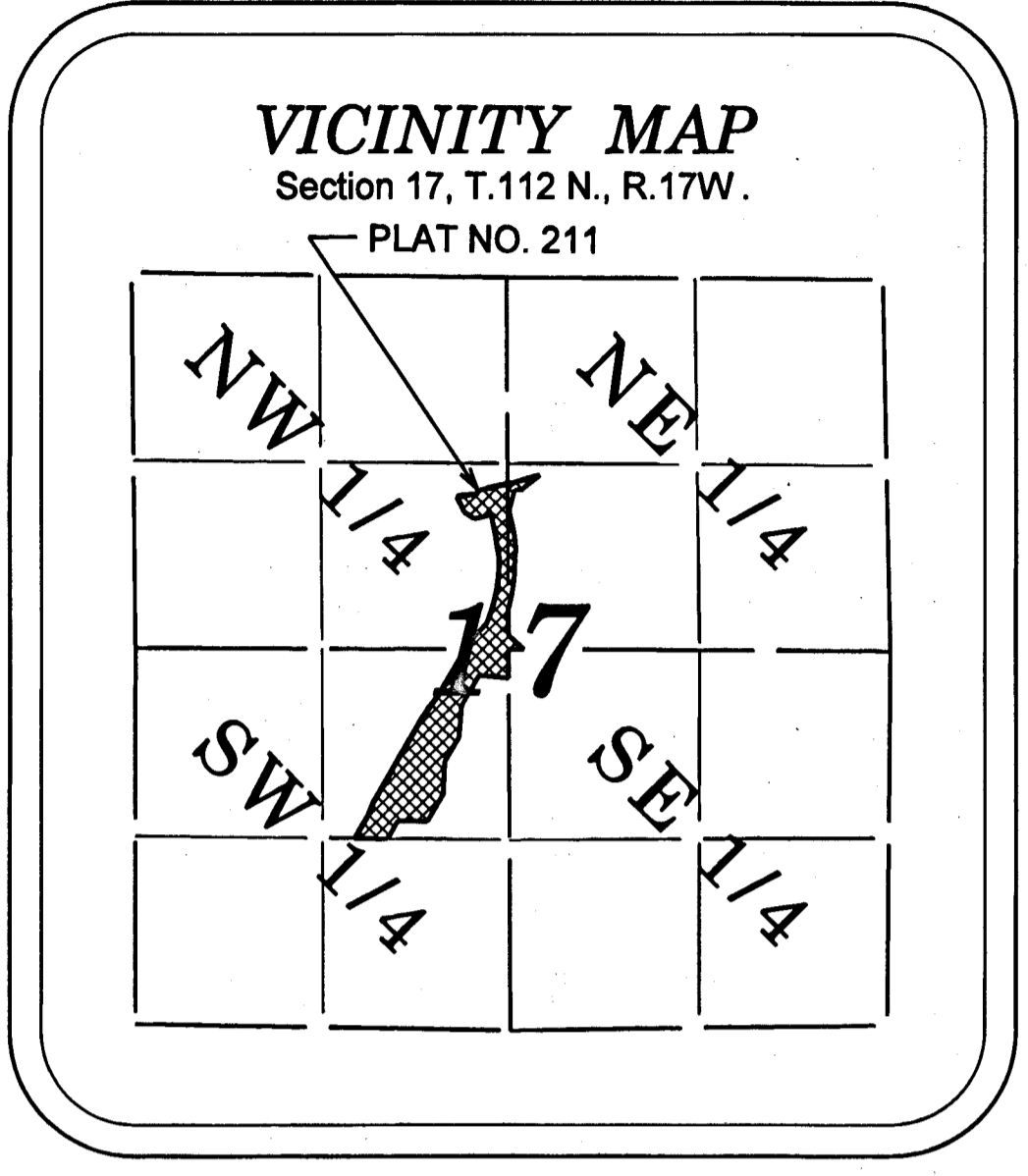
## Goodhue County Road No. 24



This azimuth system is based on the HARN Adjustment of NAD 1983 Goodhue County Coordinate System with North being 00 degrees 00 minutes 00 seconds, and all azimuths are referenced clockwise from North.

This plat is subject to easements of record.

Monuments will be set at all angle points after construction is complete or time allows.
