Instrument of Dedication

Know all men by these presents, that I, Edward Ivergedal, single, of the Village of Wanamingo, County of Goodhue, State of Minnesota, the owner in fee simple of the following described real estate, situated in the County of Goodhue and State of Minnesota, to wit: -
Beginning at the South West corner of the North East Quarter of the South East Quarter of Section Twenty-Five, Township One Hundred Ten North, Range Seventeen West (Sec. 25, T. 110 N., R. 17 W.), thence run North along quarter-quarter line Six Hundred Fifty Four and one-tenth (654.1) Feet, more or less, to one-sixteenth section line; Thence run East along said sixteenth section line, Five Hundred Eighty Seven and two-tenths (587.2) Feet, more or less, to its intersection with the East Line of High Avenue; Thence South along said East Line of High Avenue, Six Hundred Fifty Two and nine-tenths (652.9) Feet, more or less, to its intersection with quarter-quarter section line; Thence run West along said quarter-quarter line, Five Hundred Eighty Six and eight-tenths (586.8) Feet, to Place of Beginning.

I do hereby declare that I have caused said premises to be surveyed and platted and monuments fixed as designated on plat by Albert E. Rhame, County Surveyor, in the manner shown on the within plat, and I do hereby designate and name the same as "Edward Ivergedal's Second Addition" to the Village of Wanamingo, and do further declare that I am the owner in fee simple of said real estate and that the said premises are free from all incumbrances, and I hereby dedicate to the Public Use forever, the Streets and Alleys hereon designated to be used, occupied and enjoyed as such Streets and Alleys.
