**Dedication**

Know all men by these presents: That Paul Lawrence and Delores Lawrence, his wife and the E. H. Lidberg Company Inc. of the following described real estate in the City of Red Wing, County of Goodhue and State of Minnesota, to wit: All that part of the Southwest quarter of Section 31, Township 113 North, Range 14 West and of the Southeast quarter of the Northwest quarter of said Section 31, described as follows: Beginning at an iron pipe at the intersection of the north line of the Southwest quarter of the Northeast quarter of said Section 31 with the West line of West Avenue; Thence run South along the West line of West Avenue 579.3 feet to an iron pipe; Thence run West and parallel to the north line of said Southwest quarter of Northeast quarter for 1220.6 feet more or less to West line of said Southwest quarter of Northeast quarter; Thence continue West for 30 feet to an iron pipe; Thence North parallel and 30 feet West of the East line of said Southeast quarter of the Northwest quarter 579.3 feet to the North line of said Southeast quarter of Northwest quarter; Thence run east 1250.6 feet to the place of Beginning. Have caused same to be surveyed by Albert E. Rhame, County Surveyor of Goodhue County, and the Lots, Blocks, Streets and Alleys in same are arranged and platted in the manner shown and named and designated as **RE-ARRANGEMENT OF LAWRENCE ADDITION**.

The owners above named hereby dedicate to the Public Use the streets and Alleys as shown hereon and an easement on the west 5 feet of lots 9, 26 and 43. In witness whereof the said owners have executed this instrument this 5<sup>th</sup> day of May 1953.
