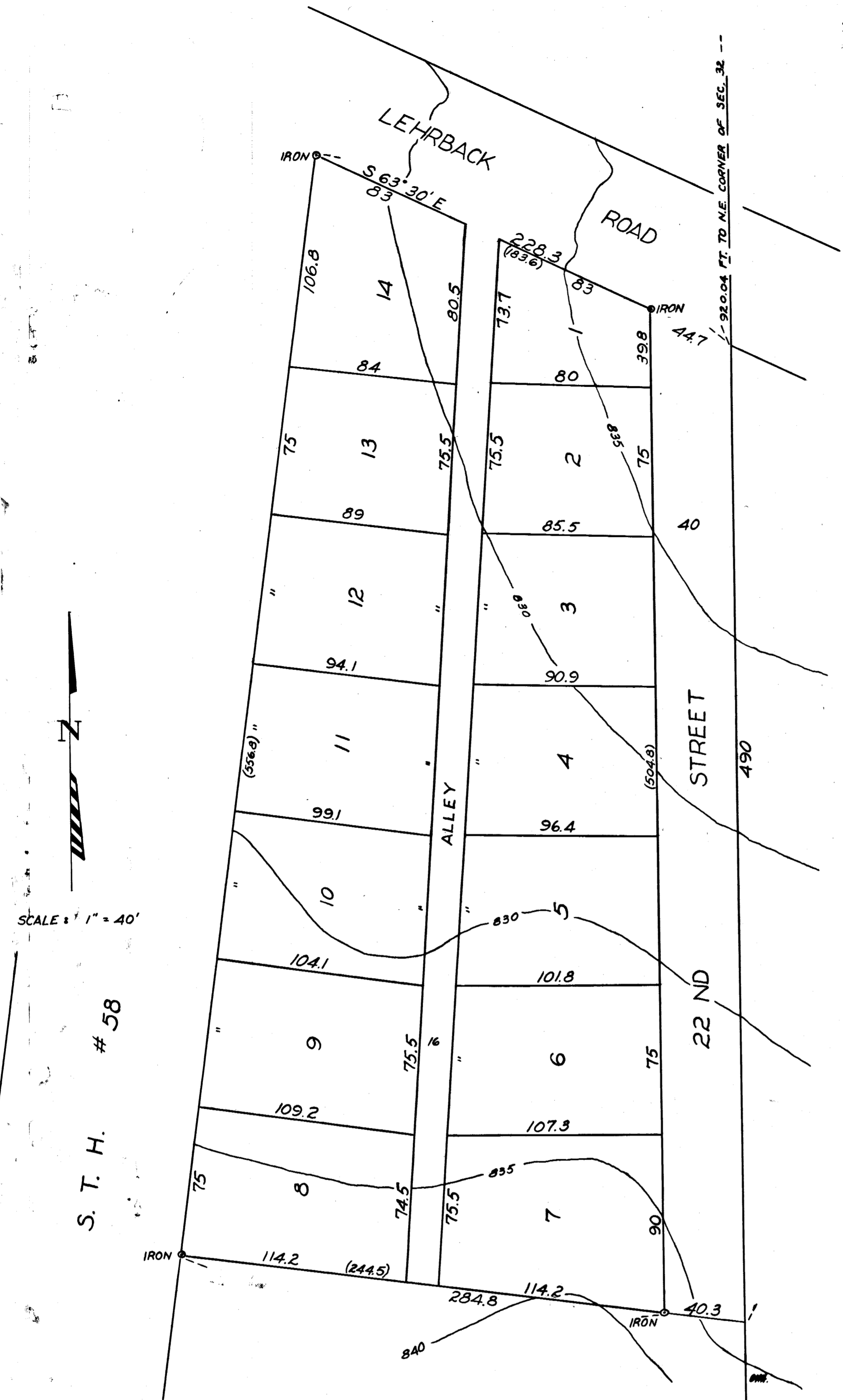

KNOW ALL MEN BY THESE PRESENTS, THAT THE CITY OF RED WING AS THE OWNER OF THE FOLLOWING DESCRIBED REAL ESTATE IN THE CITY OF RED WING, COUNTY OF GOODHUE, STATE OF MINNESOTA, TO WIT; THAT PART OF THE EASTERLY ONE HALF (1/2) OF THE NORTHEASTERLY ONE QUARTER (1/4) OF SECTION 32, DESCRIBED AS FOLLOWS; COMMENCING 920.04 FEET SOUTH OF THE NORTHEAST CORNER OF SECTION 32 FOR A POINT OF BEGINNING, THENCE SOUTH 490 FEET, THENCE WESTERLY 284.8 FEET TO THE EAST LINE OF STATE TRUNK HIGHWAY NUMBER 58, THENCE NORTHERLY ON THE EAST LINE OF STATE TRUNK HIGHWAY NUMBER 58, TO THE SOUTH LINE OF THE LEHRBACK ROAD 556.8 FEET, THENCE SOUTH 63° 30' EAST 228.3 FEET ON THE SOUTH LINE OF THE LEHRBACK ROAD TO THE POINT OF BEGINNING, SHOWN IN DETAIL ON THE ANNEXED PLAT, HAS CAUSED THE SAME TO BE SURVEYED AND PLATTED INTO LOTS, BY JAMES F.
