

Dedication

Know all men by these presents:
That we Herman L. Olson and Esther I. Olson, his wife and Monroe Warn and Laura Warn, his wife
as owners of the following described real estate in the City of Red Wing, County of Goodhue
and State of Minnesota, to wit:
All that part of Lots 13, 14, 15 and 29 and Vacated 16th Street in Smith's Addition to the City
of Red Wing as follows: From the Southwesterly Corner of said Lot 13 run South 48 1/2° East
along the Northeastly Line of East Avenue 130 feet to the Place of Beginning;
Thence South 48 1/2° East 40 feet; Thence North 41 1/2° East 100 Feet; Thence South 48 1/2° East
65 feet; Thence North 41 1/2° East 200 feet; Thence South 48 1/2° East 422 feet to the easterly
line of said Lot 29; Thence North 13° East 273 feet to a point 550 feet northeasterly
of the northeasterly line of East Avenue measured at right thereto; Thence North 48 1/2°
West 84 feet; Thence North 41 1/2° East 145 feet to the easterly line of said Lot 29;
Thence North 13° East 23 feet more or less to the Southwesterly Line of Central Park Street;
Thence Northwesterly along the southwesterly Line of Central Park Street 320 feet more or less
to a point 275.2 feet Southeastly of the Southeastly Line of 15th Street, measured at
right angles to 15th Street; Thence South 41 1/2° West 130 feet more or less to a point 500
feet northeasterly of the Place of Beginning; Thence North 48 1/2° West 130 feet;
Thence South 41 1/2° West 350 feet; Thence South 48 1/2° East 130 feet; Thence South 41 1/2° West
150 feet to the Place of Beginning.
