That Alvin B. Steffenhagen and Helen A. Steffenhagen his wife, owners of the following described real estate in the City of Red Wing, County of Goodhue and State of Minnesota, to wit: All that part of Government Lots 1 and 5 in Section 31, Township 113 North, Range 14 West in the City of Red Wing, Goodhue County and State of Minnesota, described as follows: Beginning at the intersection of the center line of the Twin Bluff Road with the north line of said Government Lot 5; Thence South 9°00' West along center line of said Road 900 feet; Thence South 25°16' West 100 feet; Thence South 42°34' West 100 feet; Thence South 50°34' West along center of said Road for 50 feet; Now leaving said Road run North 39°26' West 183 feet; Thence South 50°34' West parallel with said Road 400 feet to the West Line of said Government Lot 5; Thence South 69°5 feet to the Southwest corner of said Government Lot 5; Thence East along the South Lines of said Government Lot 5 and 1 for 1229 feet to a point distant 378.4 feet east of the Southwest corner of said Government Lot 1; Thence North to the North Line of said Government Lot 5 at a point 353.3 feet distant West of the northeast corner thereof; Thence West 543 feet to the Place of Beginning; Said tract containing 30 acres more or less.

Have caused same to be surveyed by Albert E. Phame, County Surveyor of Goodhue County, and the Lots and Streets in same are arranged and platted in the manner shown and named and designated as GLEN VIEW ADDITION.

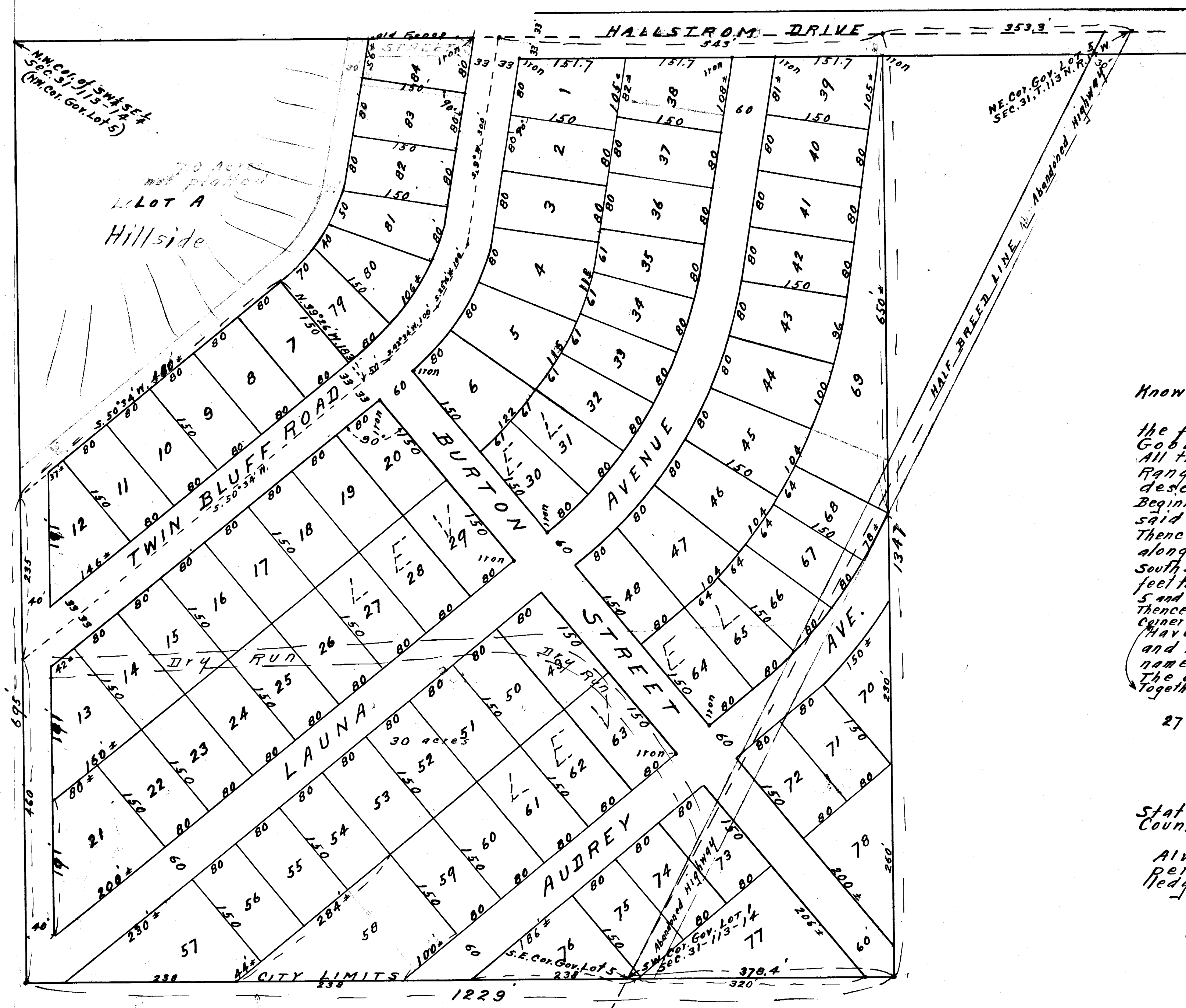
