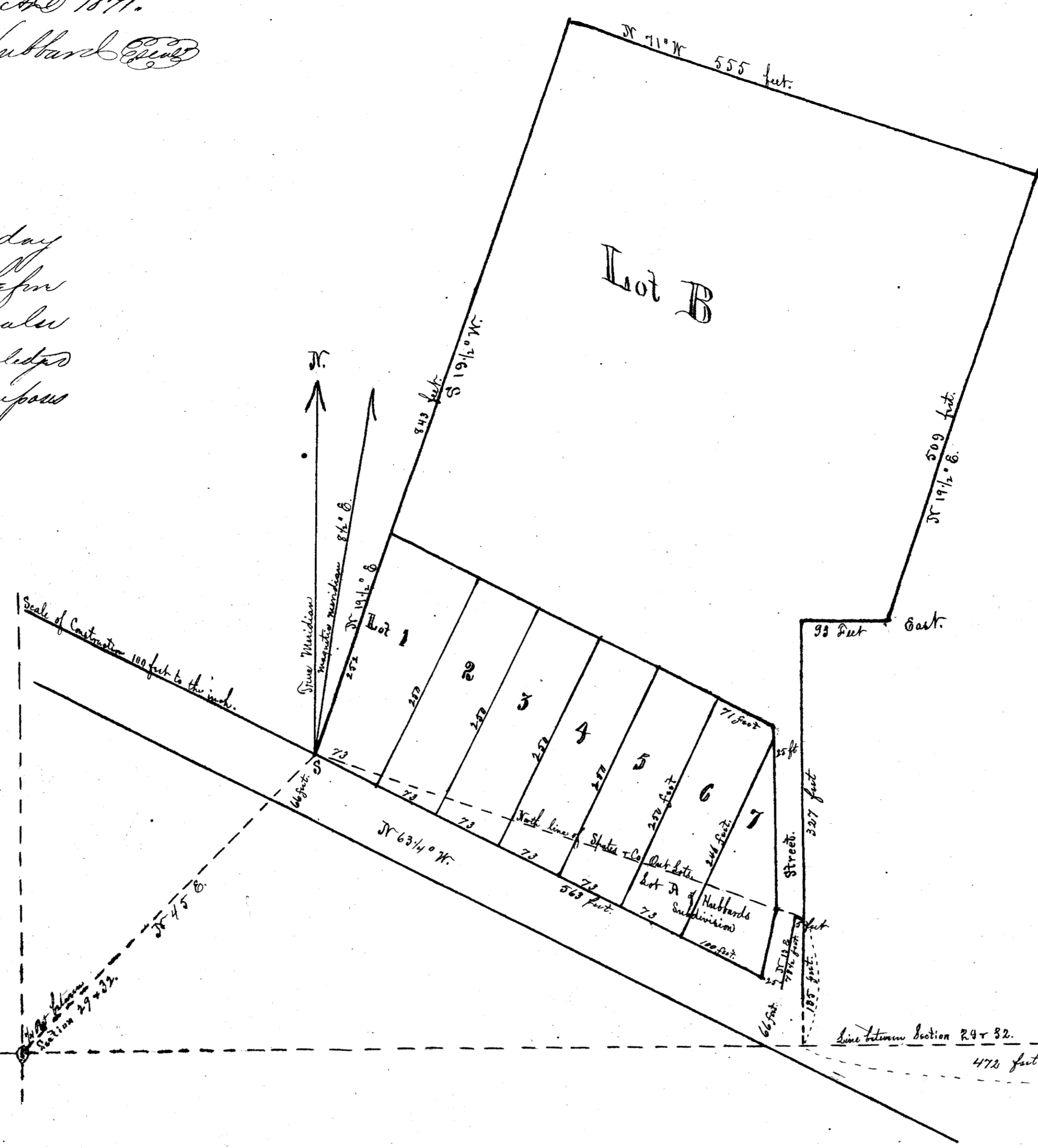


# Hubbards Addition to Red Wing.
