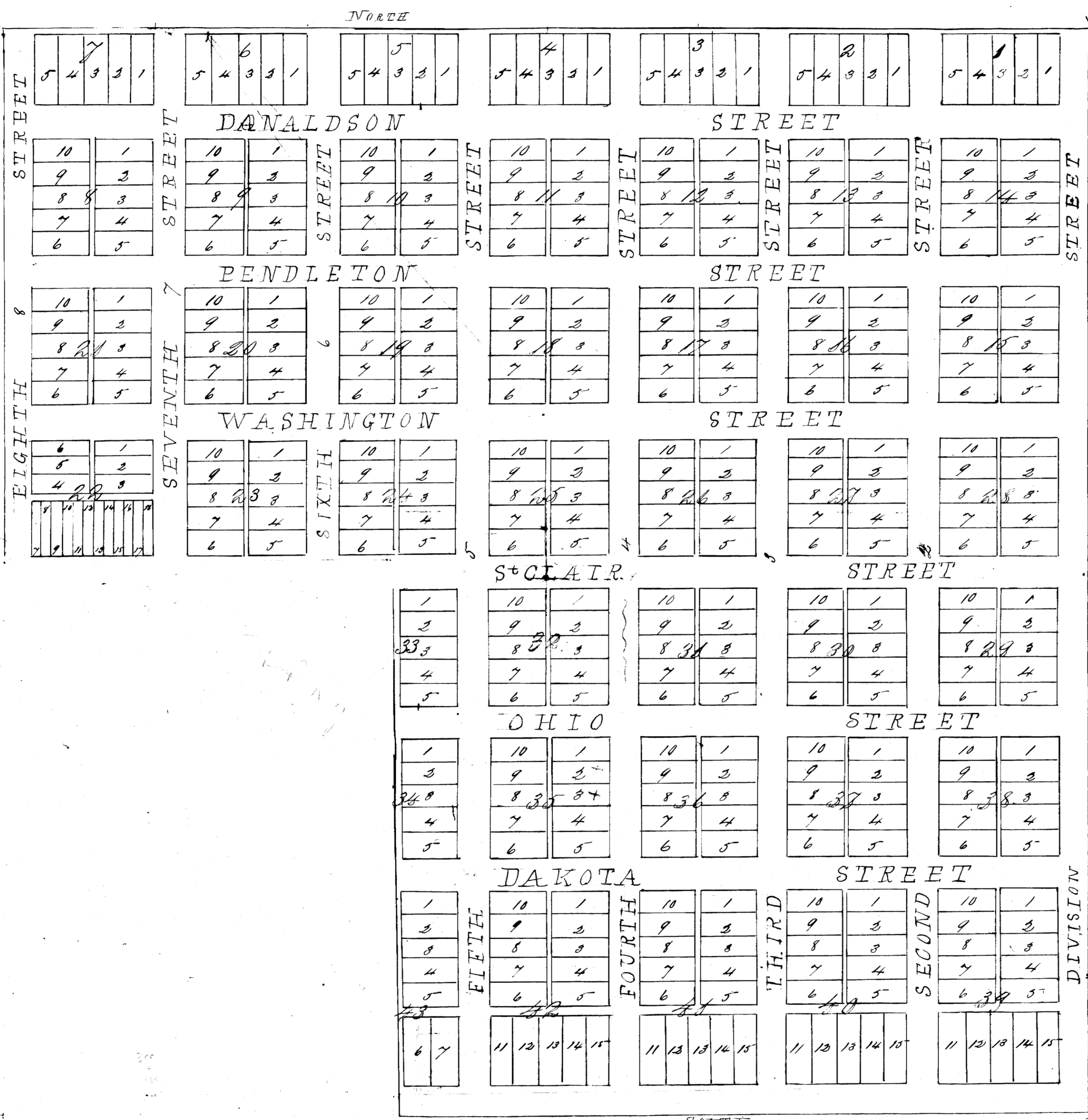


PLAT OF ST. CLAIR'S "TERRE HAUTE" ADDITION TO CANNON FALLS

Magnetic Variation 8 deg 30 min



St. Clair's "Terre Haute" Addition to Cannon Falls is situated on Lots 7, 8, 11 & 12 of Section No 7 D No 112 of R. 17 West. All lots are sixty (60) by one hundred & forty two (142) feet except in Blocks 1, 2, 3, 4, 5, 6 & 7 the lots are 60 ft by 160. Lots No 11, 12, 13, 14 & 15 in Blocks 39, 40, 41 & 42 are 60 feet by 160 lots No 6 & 7 in Block No 43 are 71 by 160. Lots 1, 2, 3, 4, 5, 6 in Block No 22 are 47 by 142. Lots 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17 & 18 in same block are 20 feet by 142. All streets are 80 feet wide. All Alleys are 16 feet wide. Surveyed and drawn in the summer of 1873 by

Chapter 175, Page 245
CHAPTER CLXXV.
AN ACT TO VACATE A PART OF ST. CLAIR'S TERRE HAUTE ADDITION TO CANNON FALLS, IN THE COUNTY OF GOODHUE.
Be it enacted by the Legislature of the State of Minnesota:
SECTION 1. That all that part of the plat of "St. Clair's Terre Haute Addition," to the village of Cannon Falls, in the county of Goodhue, according to the plat thereof in the office of the register of deeds of said county, lying east of Fourth street, be and the same hereby is vacated, and the lands covered by that part of said plat shall hereafter be assessed for taxation as lands, and not as village lots. Provided, That all taxes heretofore levied or assessed upon any lots lying within that part of said plat hereby vacated, shall be collected in the same manner as though this act had not been passed.
SEC. 2. This act shall take effect and be in force from and after its passage.
