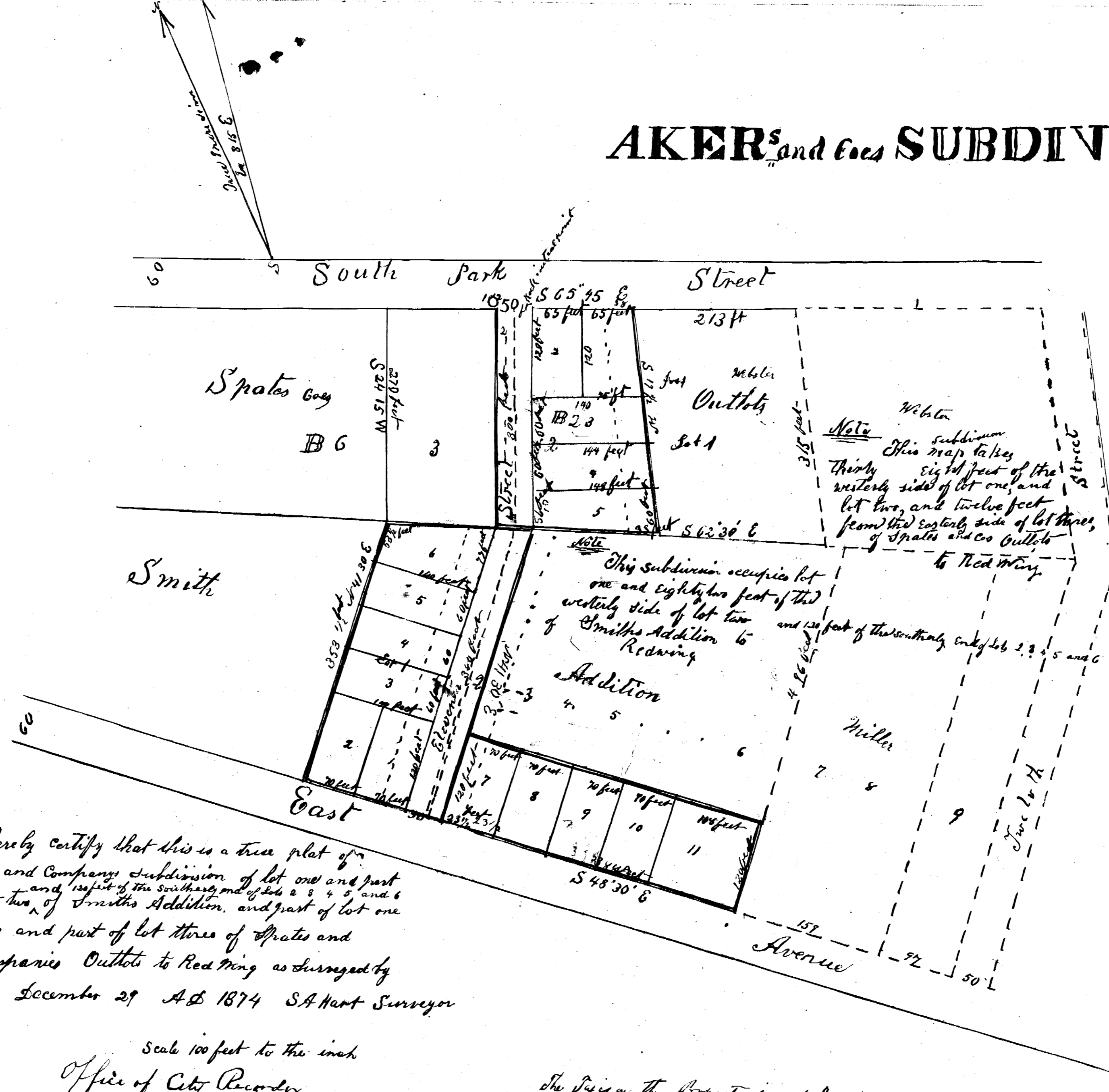

AKER & Co's SUBDIVISION



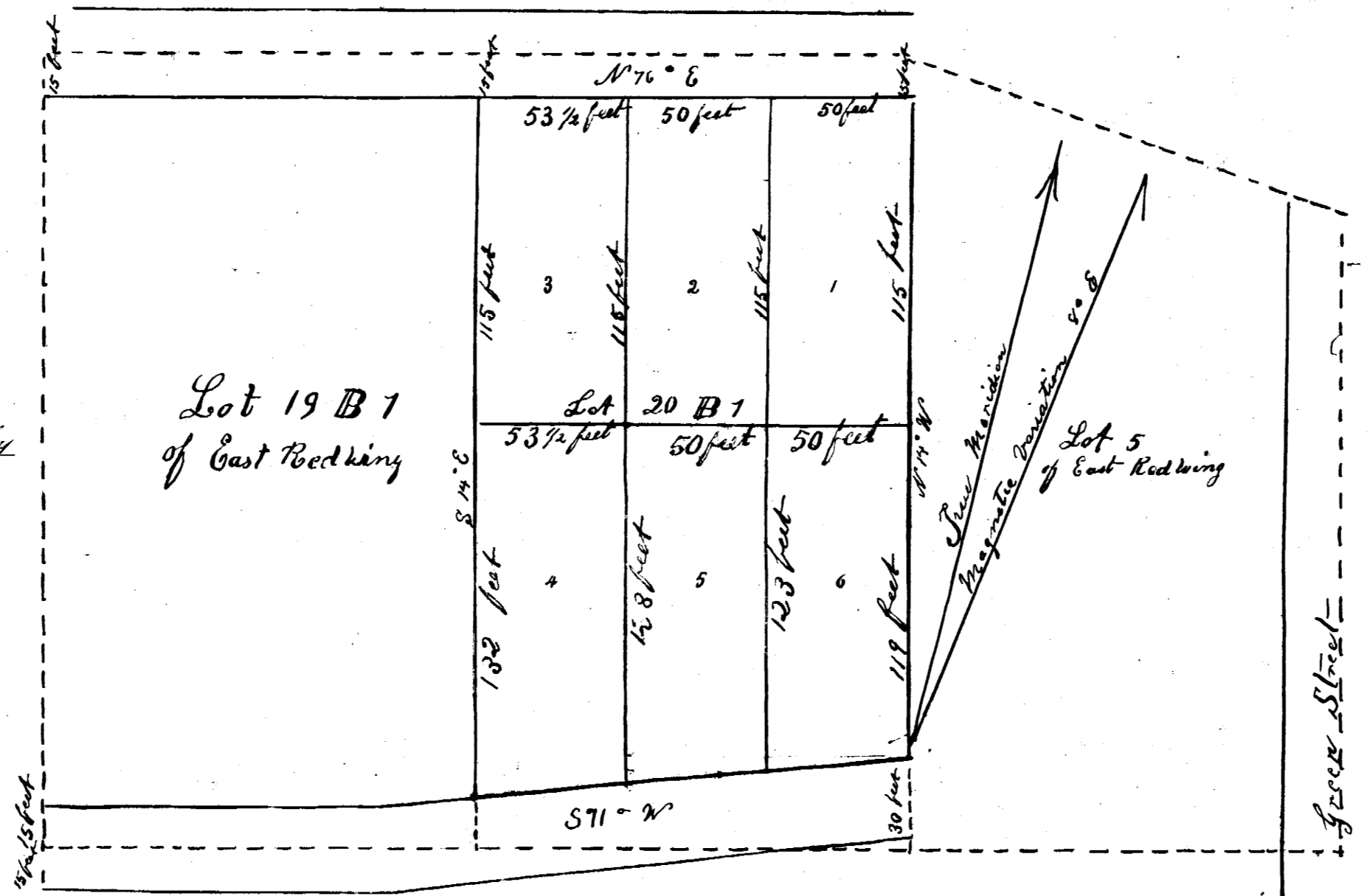
