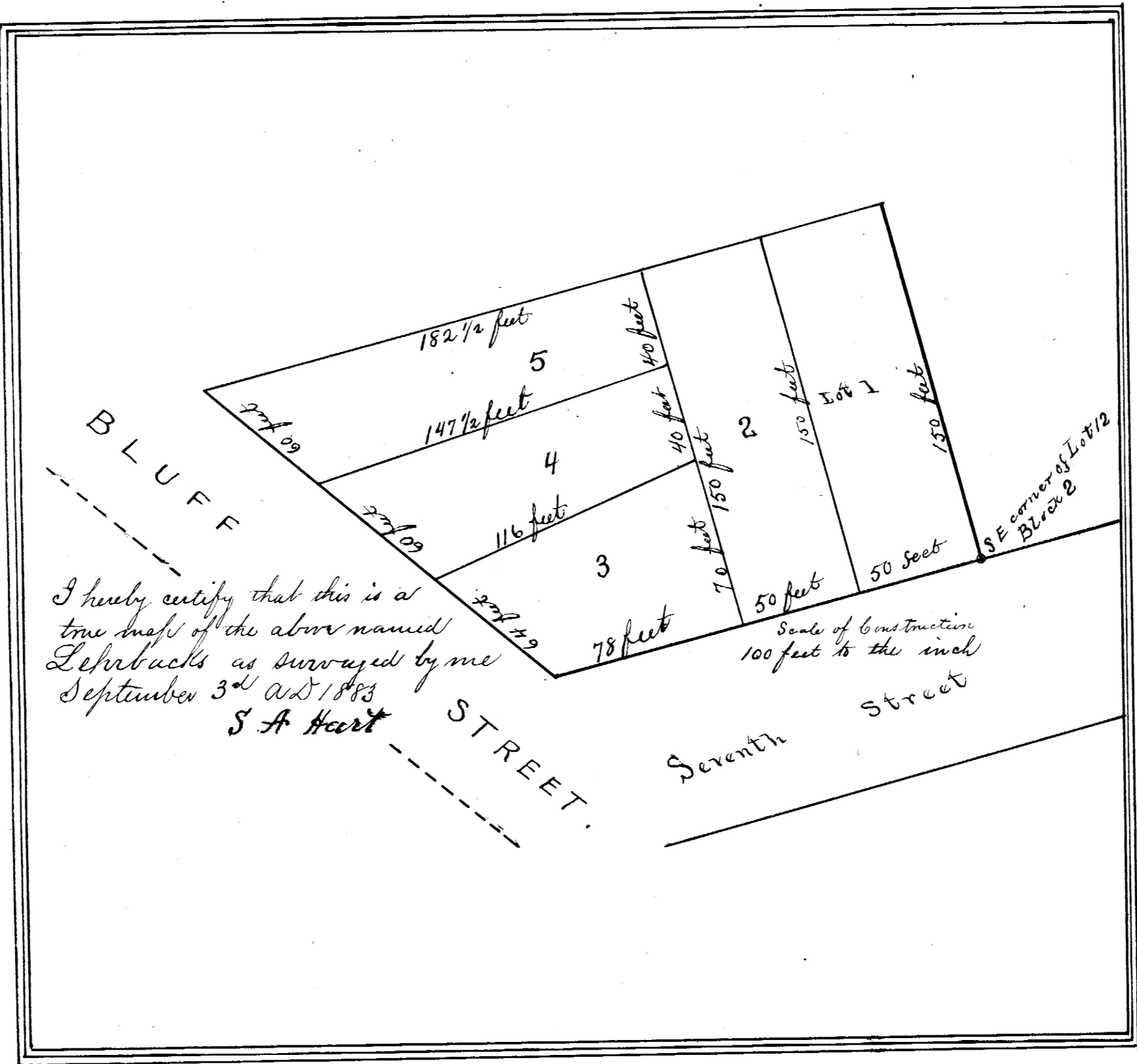


LEHRBACH'S SUBDIVISION

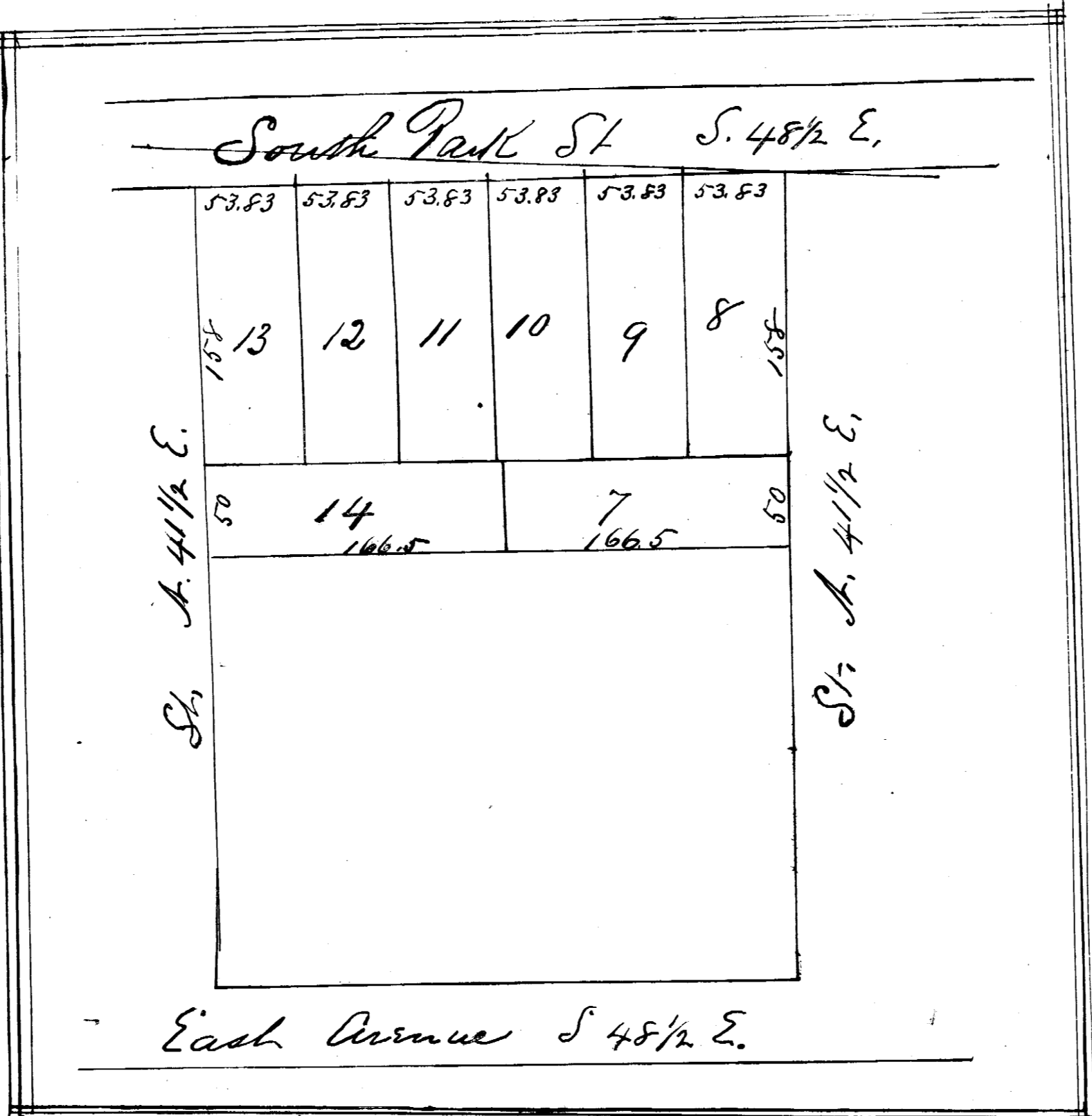
