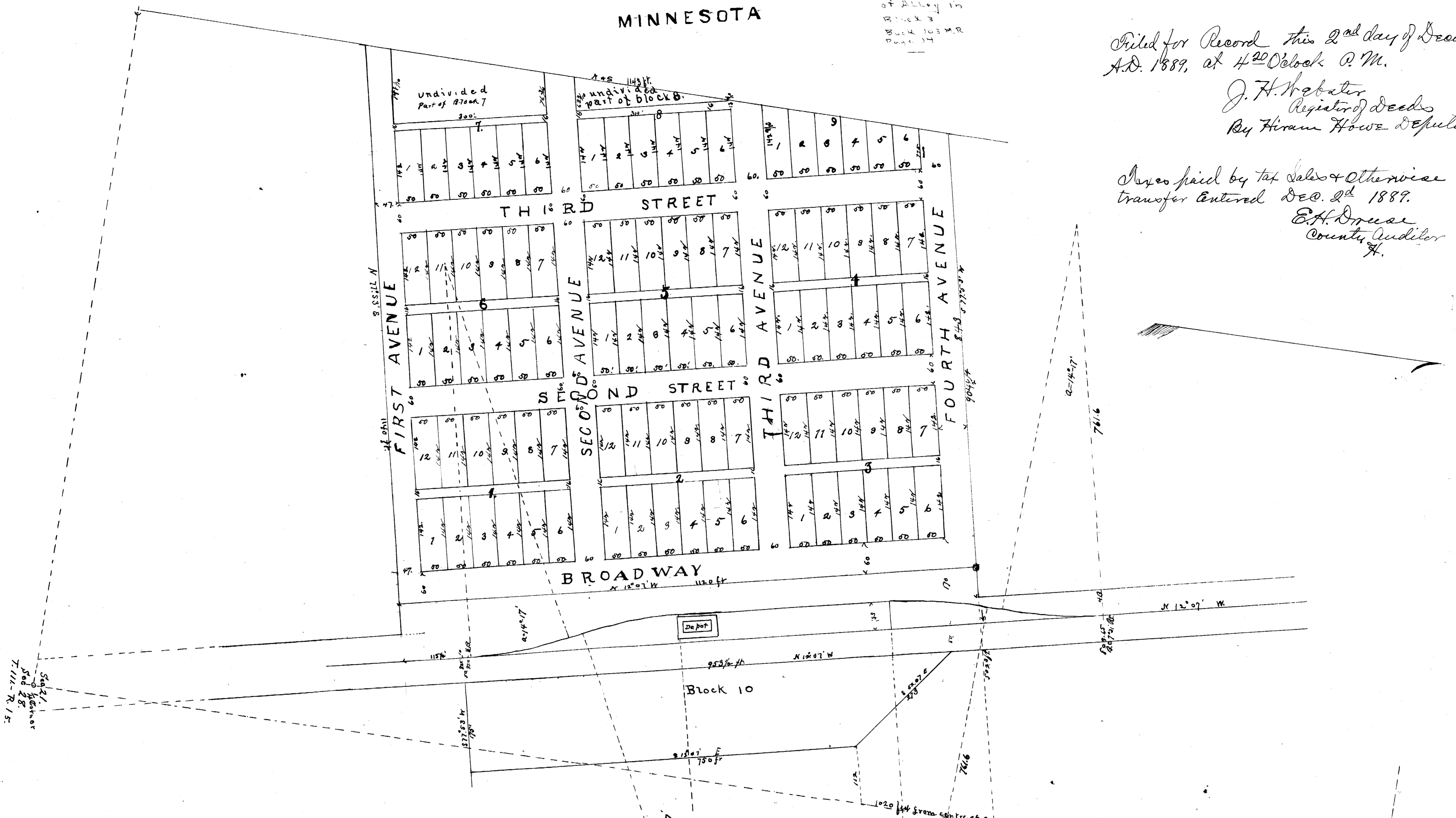

Goodhue County } Know all men by these presents: That I Theodore B. Sheldon
corner in fee of all the part of the east one-half of the South West Quarter and the west one-half of the South East
Quarter of Section twenty one (21) of Township one hundred & eleven (111) North of Range fifteen (15) West described as
follows to wit: - Beginning at a point after running South Seventy seven degrees and fifty three (77.53) minutes west five hundred and two (502) feet
Section thence South Seventy seven degrees and fifty three (77.53) minutes west five hundred and two (502) feet
for place of beginning then continue South Seventy seven degrees and fifty three (77.53) minutes west eight hundred and
forty three (843) feet to the center line of said South West Quarter of Section twenty one (21) thence South
Eleven hundred and forty three (1143) feet thence North Seventy seven degrees and fifty three (77.53) minutes east eleven
hundred and forty three (1143) feet thence North twelve degrees and seven minutes west eleven hundred and twenty (1120) feet
to place of beginning;
also another piece of land in the said East half of the South West Quarter and West half of the South
East Quarter of Section twenty one (21) of Town one hundred and eleven (111) Range fifteen (15) Beginning after
