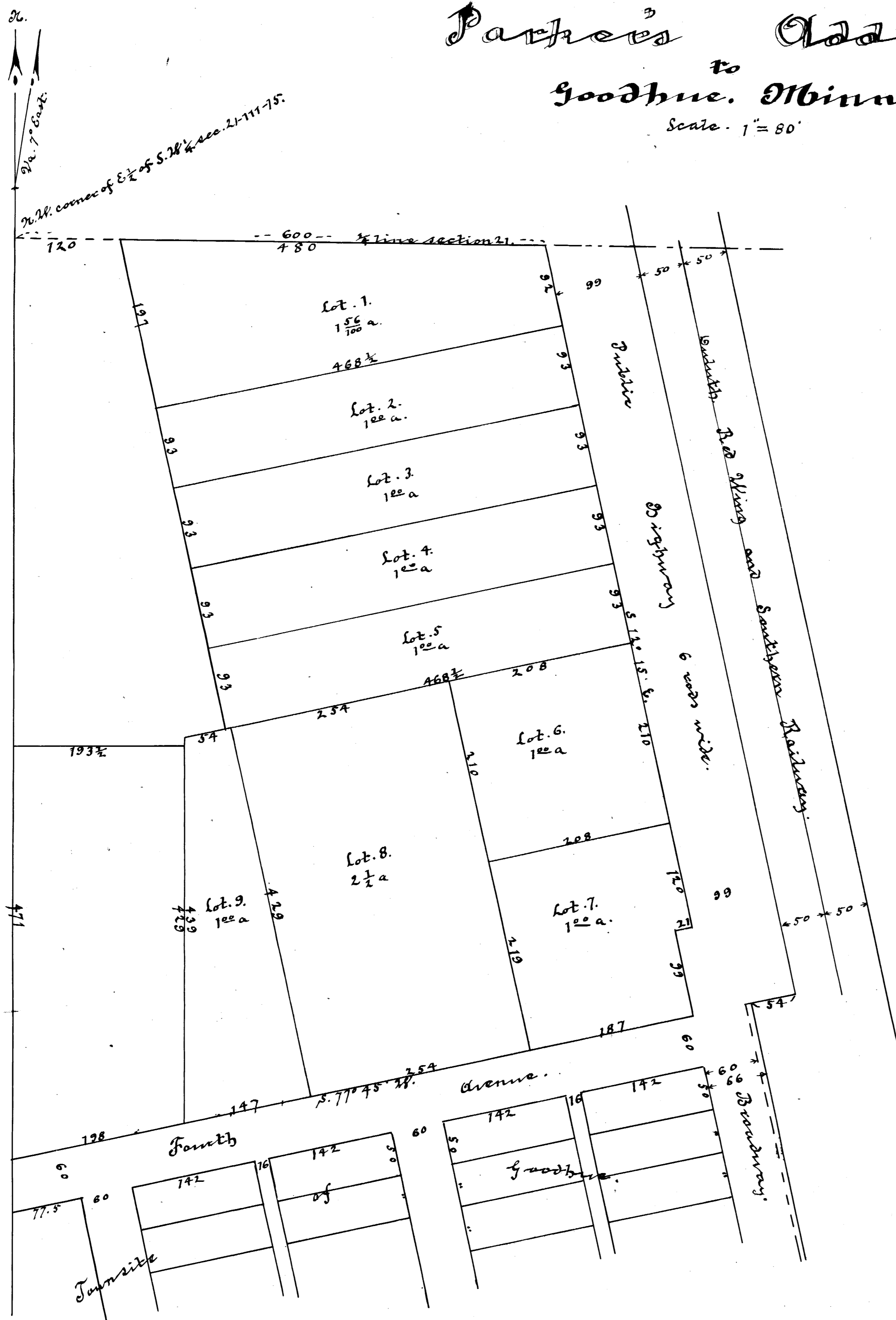


Parker's Addition to Goodhue, Minn.
