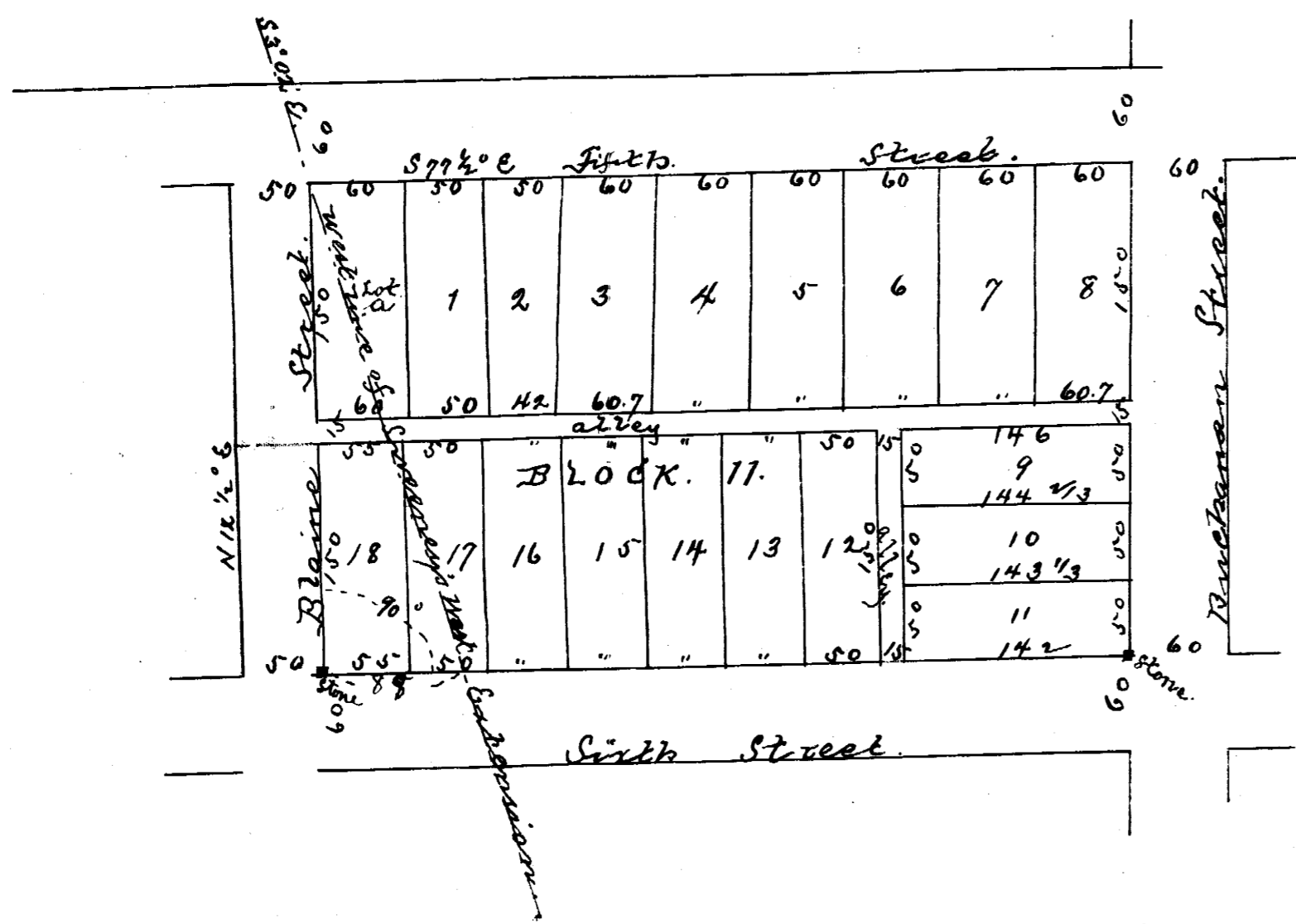


Enlargement and Rearrangement

Know all men by these presents that we, the undersigned, do hereby certify in face of the following described premises situate in the County of Goodhue and State of Minnesota to wit: Block 11 of Sweeney's West Extension to Sweeney's Addition to Red Wing and also a piece of land described as follows: Beginning at the southeast corner of said Bk. 11 running thence N 77 1/2° W 8 feet, thence N 12 1/2° E 9 1/8 feet to the northwest corner of said Bk. 11 and thence S 3° 02' E on the west line of said block 11 to the point of beginning, have caused the same to be surveyed and platted into lots as in the manner shown by this plat by J. P. Hoff County Surveyor, and we do hereby name and designate the premises herein described as "The Enlargement and Rearrangement of Block 11 of the West Extension of Sweeney's Addition to Red Wing Minn." and we do hereby give and dedicate to the public use forever the alley shown and appearing as such on this plat.
