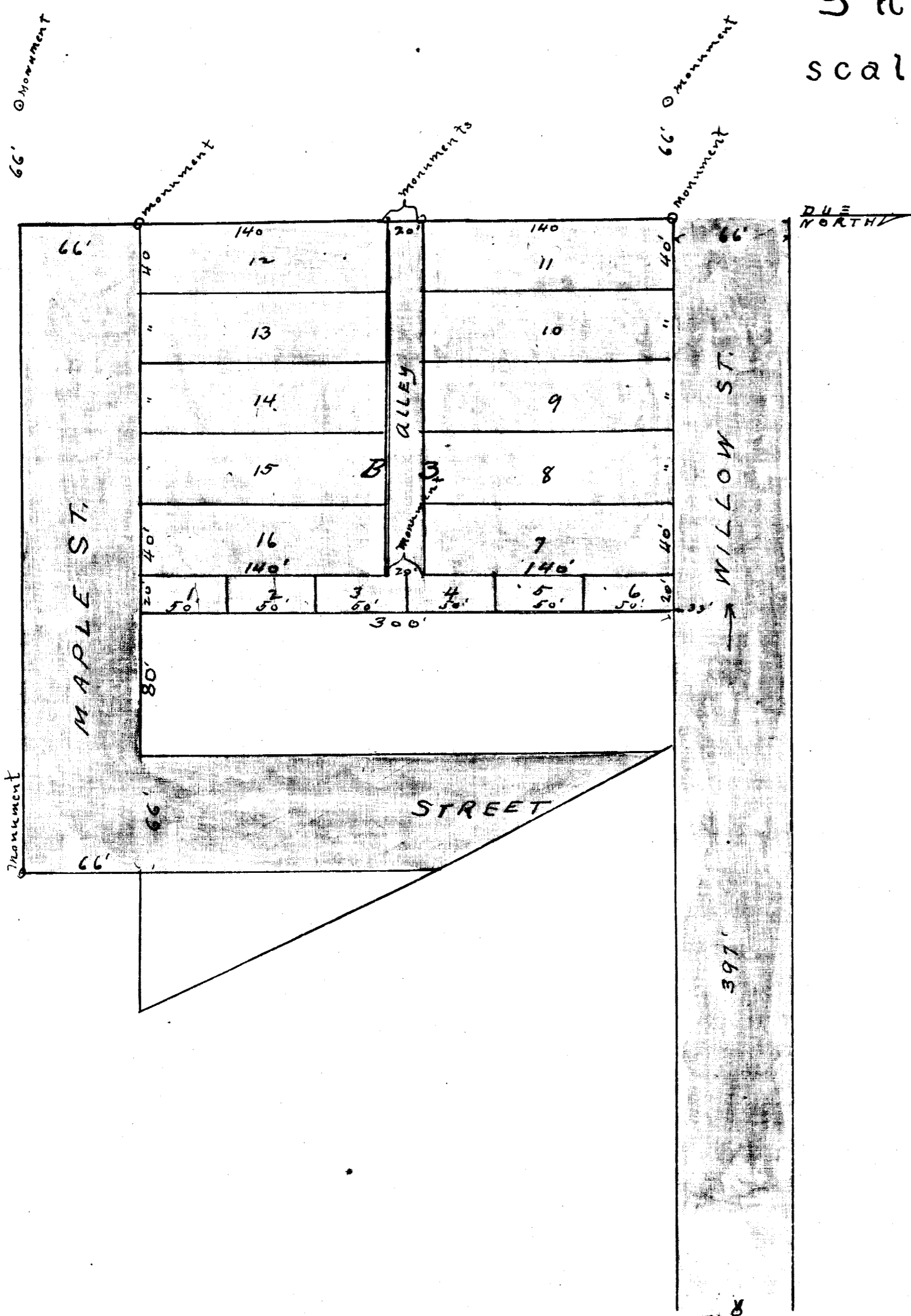


ELLS FIRST ADDITION

And that we hereby donate and dedicate to the public use forever the street and alley therein shown.

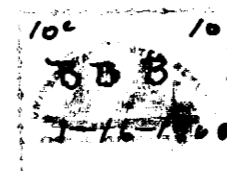
