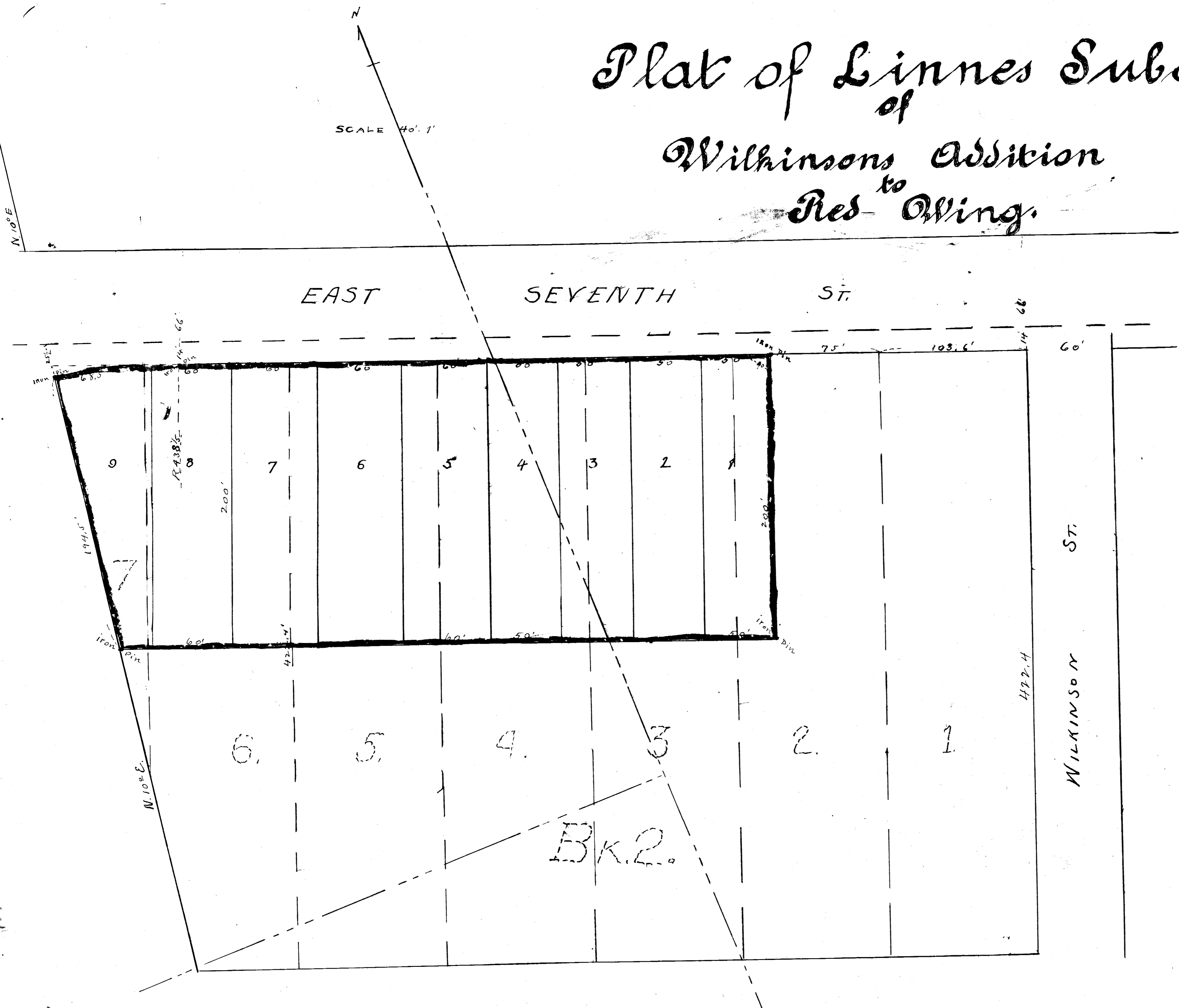


Plat of Linnes Subdivision of Wilkinsons Addition Red Wing.
