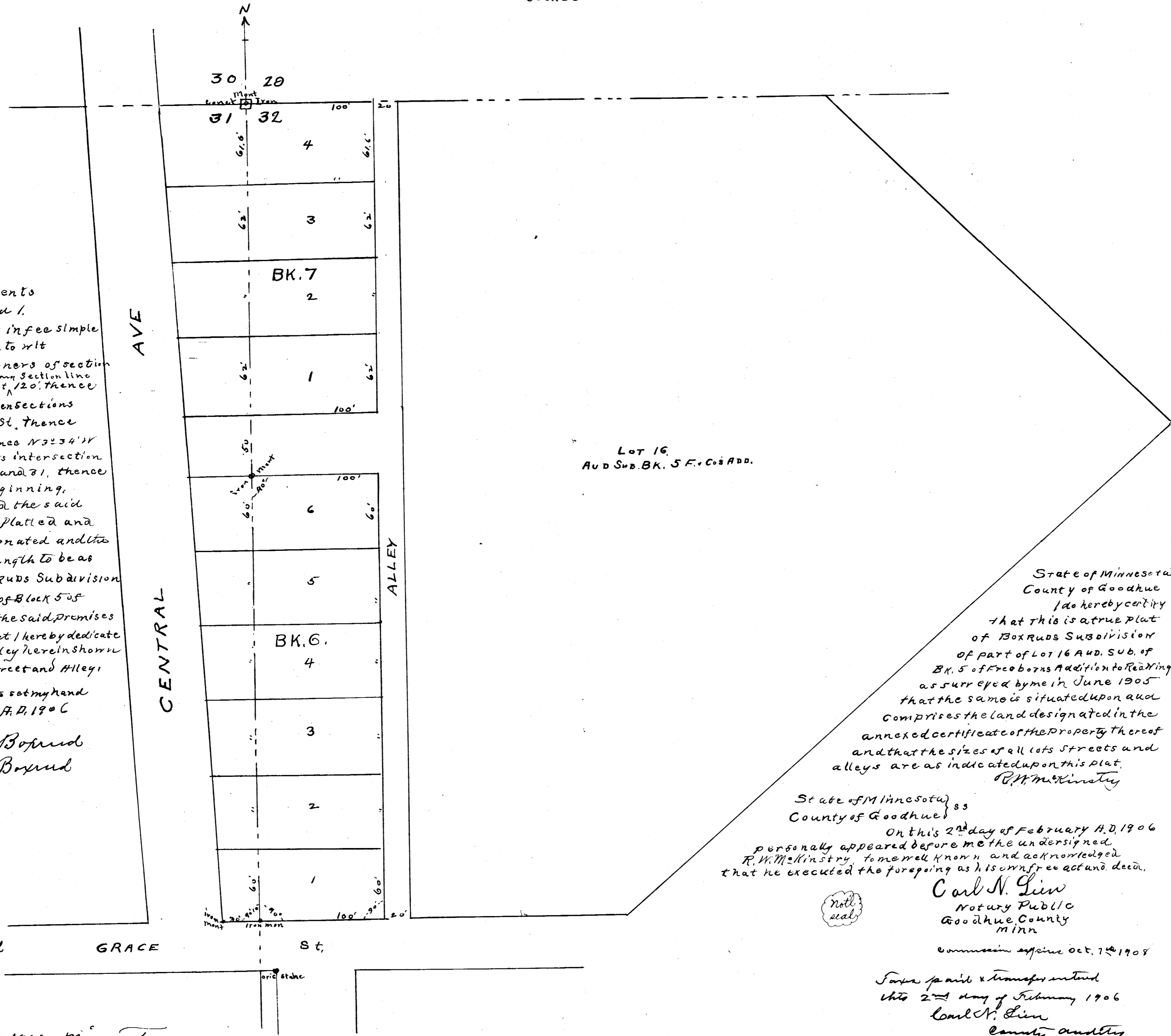


BOXRUDS SUBDIVISION
