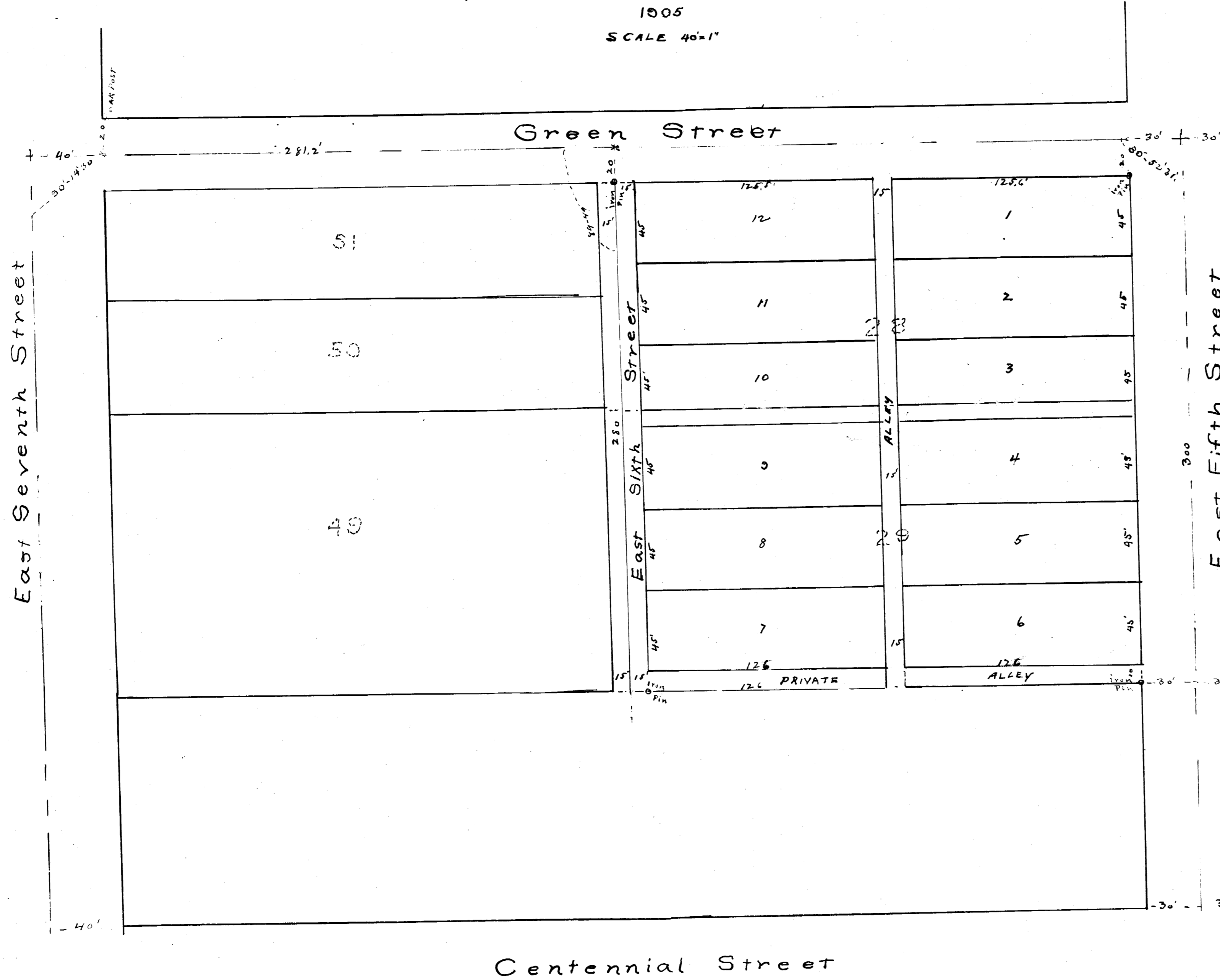


PLAT OF BECKMAN'S ARRANGEMENT
