

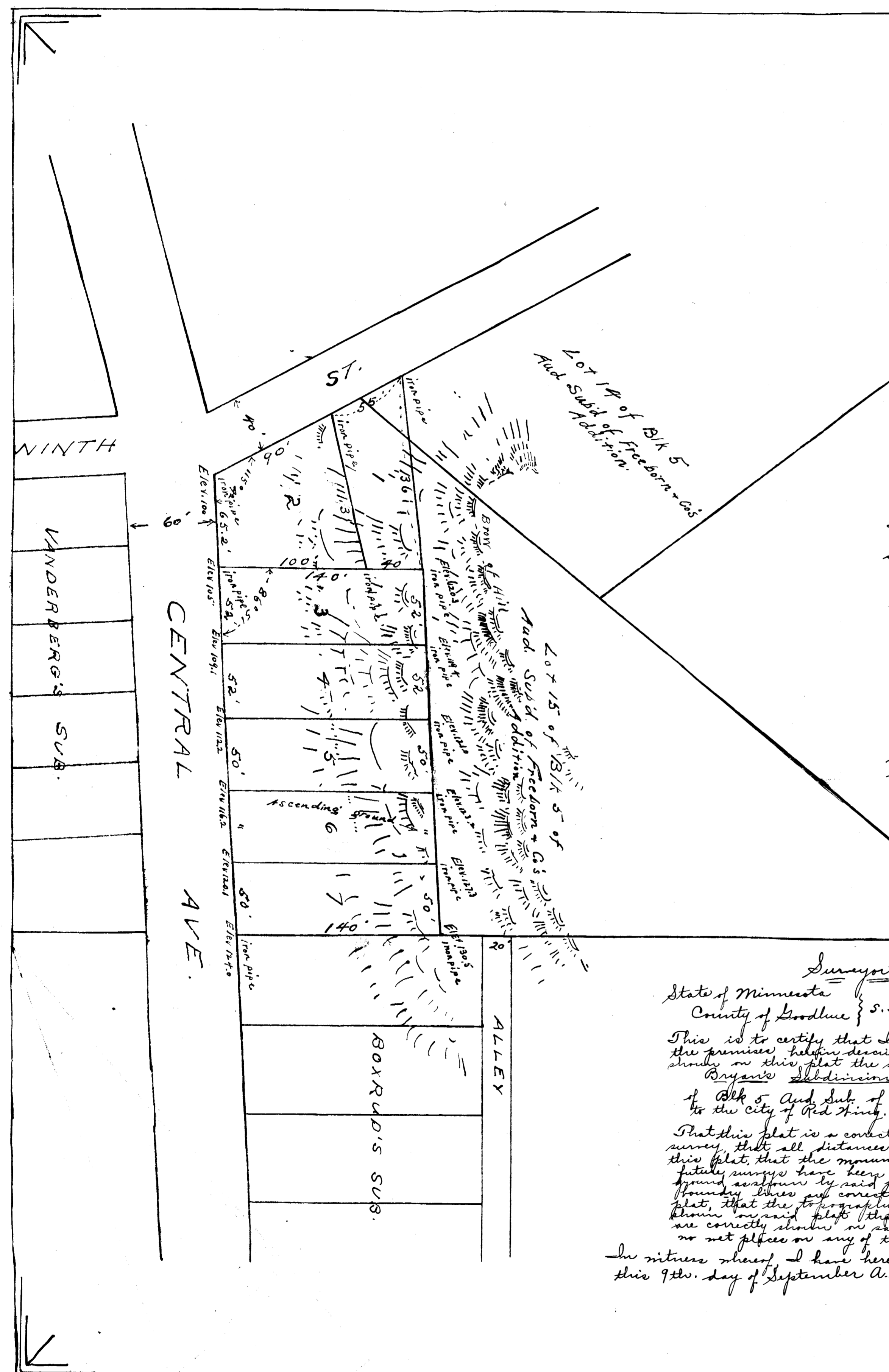

Know all men by these presents That I John W. Thurn of the City of Red Wing, a single person, County of Goodhue and State of Minnesota; do hereby own and fee simple of the following described real estate situated in the County of Goodhue and State of Minnesota to wit:

Beginning at a point on Section line between 29 and 32 T 13 R 14 W which point is one hundred and forty feet (140') east of the east line of Central Avenue, thence southerly and parallel with the east line of Central Avenue two hundred and fifty four feet (254') thence northwesterly one hundred and thirty six feet (136') to a point on the north line of North Street which point is one hundred and forty feet (140') north easterly from the intersection of the north line of North Street and the east line of Central Avenue thence northwesterly one hundred and forty feet (140') along the north line of North Street to the intersection of North Street, thence southerly along the east line of Central Avenue three hundred and nineteen feet (319') to the section line between sections 30 and 31, T 13 R 14 W, thence east along said section line one hundred and forty feet (140') to place of beginning.
