

Instrument of Dedication

State of New Jersey - the owner in fee simple of the following described real estate, situated in the County of Goodhue and State of Minnesota, to wit:

Beginning at the intersection of the southerly line of Lot Twenty Three (23) of Smith's Addition to the City of Red Wing with the westerly line of East Avenue; thence run South Forty Eight degrees and Thirty minutes East ($5.48^{\circ}30' E$) along said westerly line of East Avenue Sixty Hundred Twenty Nine and nine hundredths (629.09) feet. Thence run South Forty One degrees Thirty Minutes West ($5.41^{\circ}30' W$) at right angles to East Avenue One hundred Thirty Two and thirty six hundredths (332.36) feet. Thence South Fifty-one degrees and Ten Minutes East ($5.31^{\circ}30' E$) One hundred and twenty Two hundredths (100.22) feet to a point one foot North of Stone Wall of Oakwood Cemetery. Thence South Forty-one degrees and Thirty minutes West ($5.41^{\circ}30' W$) One Hundred Forty Three and seven tenths (143.7) feet, to westerly line of Lot Seventeen (17) of Smith's Addition. Thence run North Fifty Three degrees and Fifty Minutes West ($4.53^{\circ}50' W$) along westerly line of Lots 17, 18, 19, 20, 21, and 22 of said Smith's Addition Six Hundred Thirty Two and Twenty-Six hundredths (732.26) feet to the southerly line of Lot Twenty Three (23) of said Smith's Addition. Thence run North Forty-one degrees and Thirty Minutes West ($5.41^{\circ}30' E$) East, along southerly line of said Lot Twenty-Three (23) of said Smith's Addition Three Hundred Thirty Nine and forty six hundredths (339.46) feet, to place of beginning.

Do hereby declare that I have caused said premises to be surveyed and platted and monuments fixed as designated on plat by Albert E. Phane, County Surveyor, in the manner shown on the within plat, and I do hereby designate and name the same as "Hewitt's Subdivision" to the City of Red Wing, and do further declare that I am the owner in fee simple of said real estate and that the said premises are free from all incumbrances, and I hereby dedicate to the public forever, the said premises and alleys hereon designated to be used, occupied and enjoyed as such streets and alleys. 
