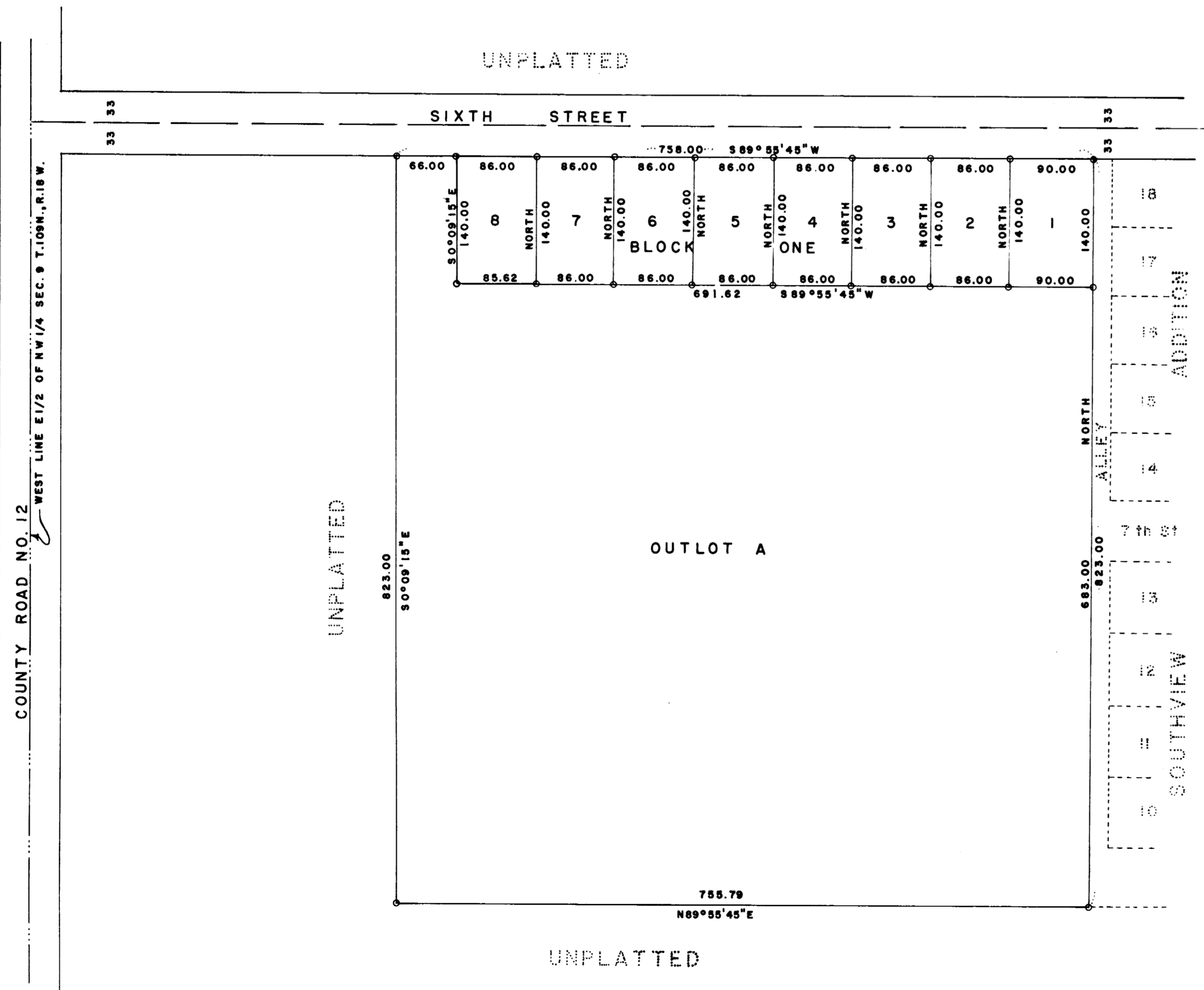


Viking Addition
