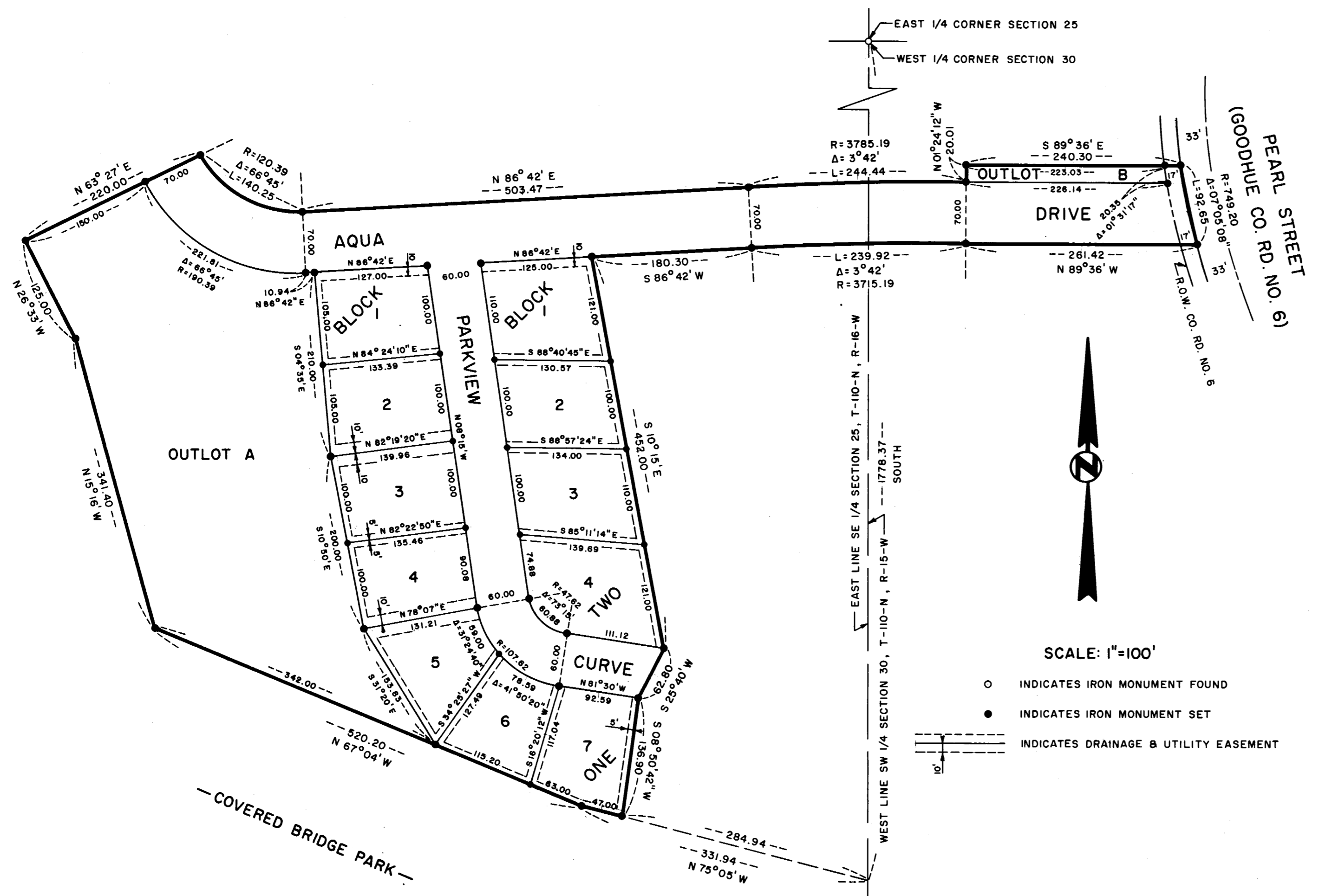


GOLDEN-VIEW ADDITION

KNOW ALL MEN BY THESE PRESENTS: that Elmer S. Stiller and Violet Stiller, husband and wife, and Elizabeth C. Zielsdorf, a single person, owners and proprietors, and Goodhue State Bank, a Minnesota corporation, mortgagee of the following described property, situated in the County of Goodhue and State of Minnesota, to-wit:

All that part of the SE 1/4 of Section 25, Township 110, Range 16, and of the SW 1/4 of Section 30, Township 110, Range 15, described as follows; Commencing at the NE corner of said SE 1/4; thence SOUTH (assumed basis for bearings) along the east line of said SE 1/4 a distance of 1778.37 feet; thence N 75° 05' W, 284.94 feet to the point of beginning of the tract herein described; thence N 75° 05' W, 47.00 feet; thence N 67° 04' W, 520.20 feet; thence N 15° 16' W, 381.40 feet; thence N 26° 33' W, 125.00 feet; thence N 63° 27' E, 220.00 feet; thence Ely on a curve to the left, the last described line being a radial line of said curve, (central angle 66° 45' and radius 120.39 feet) 140.25 feet; thence N 86° 42' E, tangent to the last described curve, 503.47 feet; thence Ely, on a tangential curve to the right (central angle 3° 42' and radius 3785.19 feet) 244.44 feet; thence N 1° 24' 12" W, 20.01 feet; thence S 89° 36' E, 240.30 feet; thence Sly on a curve to the left (central angle 7° 05' 08" and radius 749.20 feet and having a chord bearing of S 13° 11' 10" E) 92.65 feet; thence N 89° 36' W, 261.42 feet; thence Wly on a tangential curve to the left (central angle 3° 42' and radius 3715.19 feet) 239.92 feet; thence S 86° 42' W, tangent to the last described curve, 180.30 feet; thence S 10° 15' E, 452.00 feet; thence S 25° 40' W, 62.80 feet; thence S 8° 50' 42" W, 136.90 feet to the point of beginning. Containing 9.29 acres.
