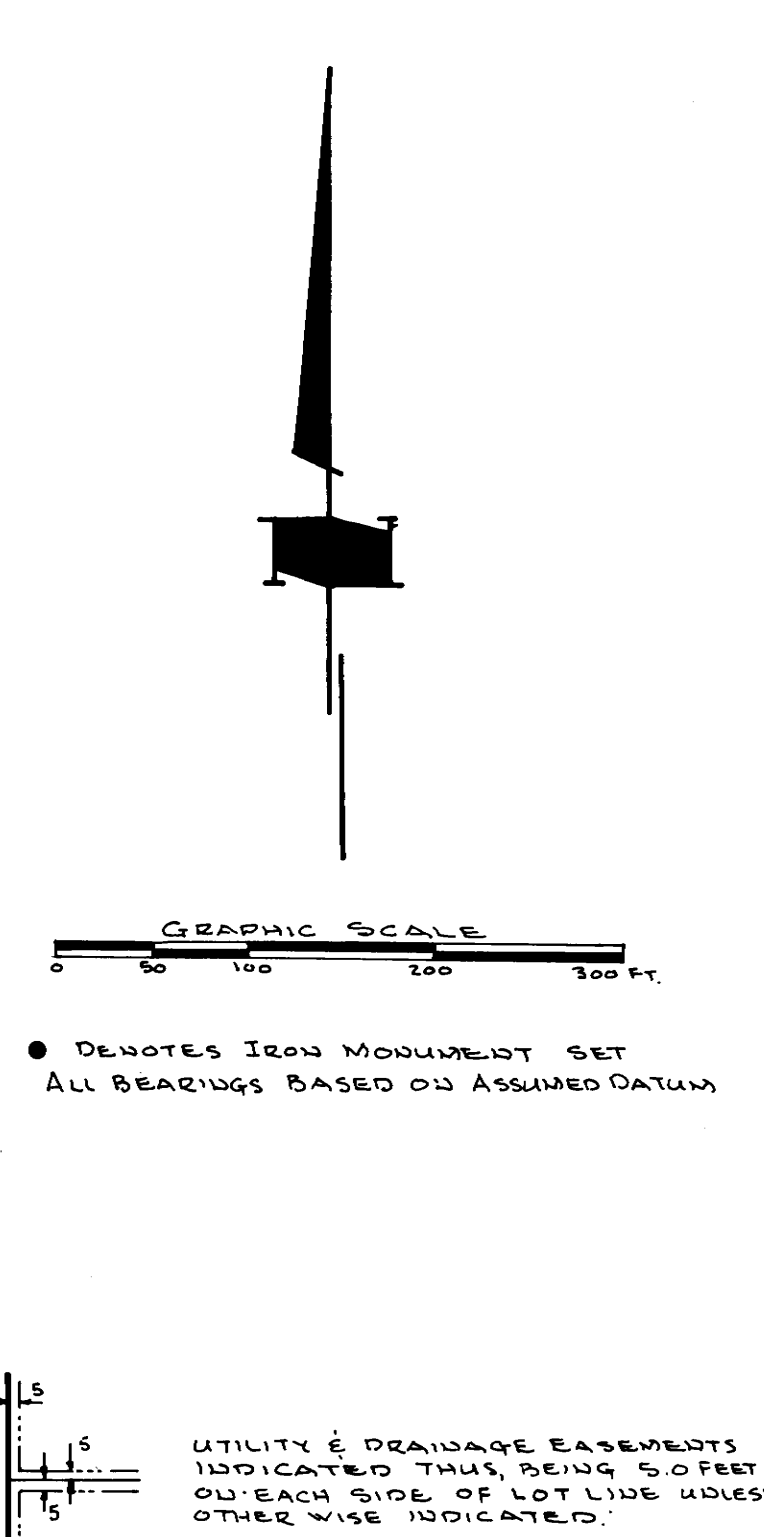
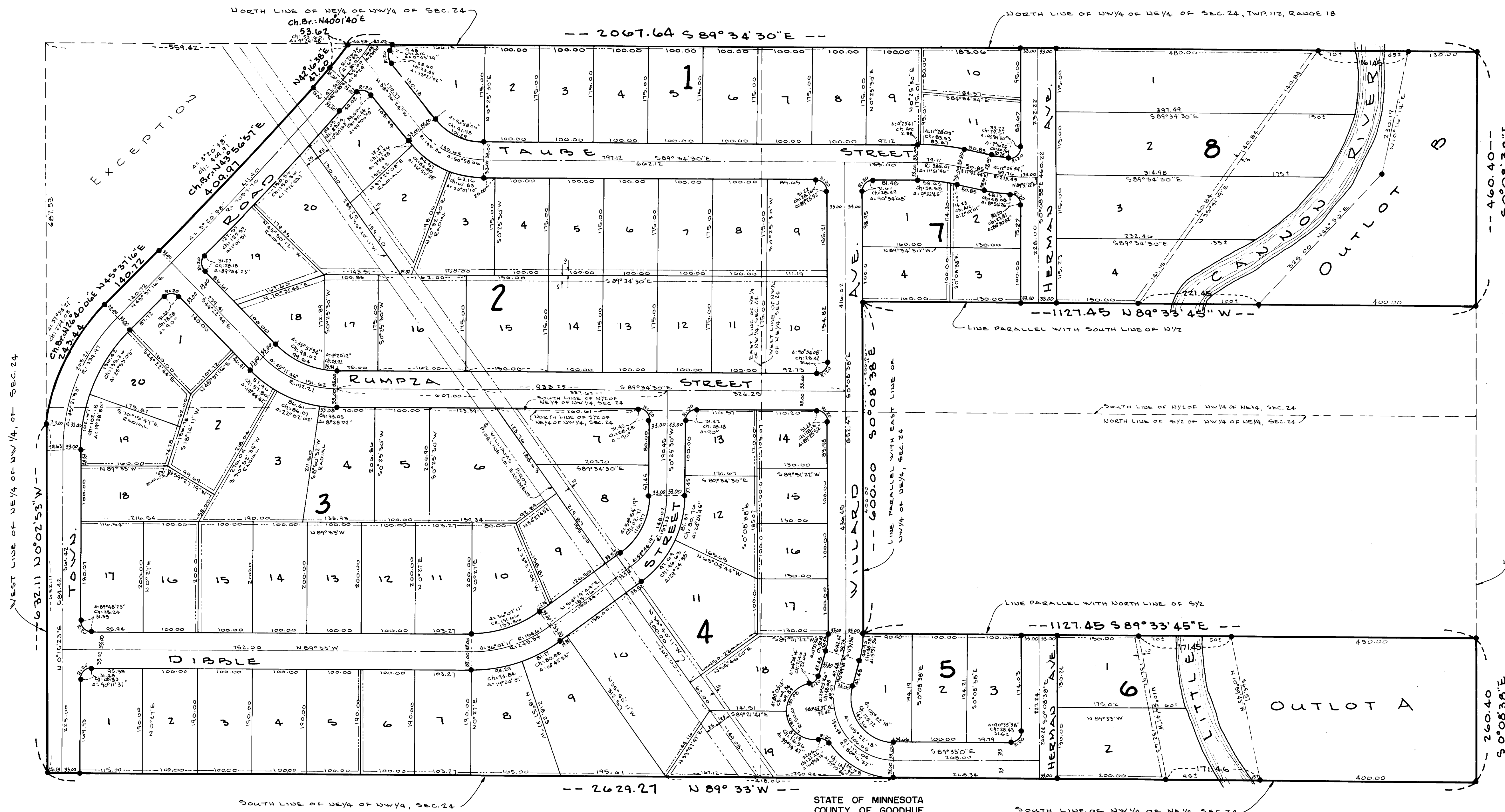


WOODLAND HEIGHTS ADDITION
