

KNOW ALL MEN BY THESE PRESENTS: That the Village of Wanamingo, a Minnesota Municipal corporation, owner and proprietor of the Following described property situate in the County of Goodhue, State of Minnesota, to

All that part of the Northeast Quarter of the Southwest Quarter of Section 30, Township 110, Range 16, Goodhue County, Minnesota described as follows:

Beginning at a point on the Easterly extension of the Northerly line of Second Street of the Original Plat of Wanamingo as on file in Register of Deeds Office, Goodhue County, distant 435.0 feet Easterly of the West line of said Northeast Quarter of the Southwest Quarter of Section 30; thence North 89 degrees 02 minutes West along the Easterly extension of the Northerly line of said Second Street a distance of 260.0 feet; thence South 00 degrees 00 minutes 42 seconds West a distance of 66.00 feet to a one inch by 30 inch steel pipe at the Northeast corner of the property described in that certain Deed in Book 19 Page 567, Register of Deeds Office, Goodhue County; thence South 89 degrees 02 minutes East 485.00 feet; thence South 00 degrees 00 minutes 42 seconds West a distance of 333.00 feet; thence South 89 degrees 02 minutes West 663.97 feet to the East line of said Northeast Quarter of the Southwest Quarter of Section 30; thence North 00 degrees 11 minutes 45 seconds East along said East line a distance of 208.67 feet to the Southerly right of way line of the Chicago, Milwaukee, St. Paul, and Pacific Railroad; thence North 72 degrees 14 minutes 58 seconds West along said right of way line a distance of 933.92 feet; thence South 00 degrees 00 minutes 42 seconds West a distance of 79.40 feet to the point of beginning.

Has caused the same to be surveyed and platted as Wanamingo East Addition, and does hereby donate and dedicate to the public for public use forever the AVENUE , STREETS , and drainage and utility easements as shown on this plat.
